A 6-year-old girl I'll call Elizabeth knocked over a display case that contained a much-cherished vase once owned by her great-grandmother. Her mom loved that vase and frequently referred to it as the family treasure. The vase hit the floor with a

loud crash and shattered into pieces. Elizabeth, shocked and frightened at what she'd done, screamed and began sobbing.

Her mom came running into the room fearing the worst. Seeing the shattered vase, her heart sank. Then she saw Elizabeth sitting on the floor wailing. "I'm sorry, Mommy. I'm sorry, Mommy. I broke the family treasure!"

Seeing despair on her daughter's face, the mother's heart plunged further.

Faced with two powerful and conflicting instincts – one toward anger and blame, the



other toward compassion and forgiveness, she sat next to Elizabeth, pulled her on her lap, and kissed her tears. "Sweetheart, when I ran in here, I was terrified that something bad had happened to our family's most precious treasure. But thank God, you're okay. Elizabeth, you are the family treasure."

Elizabeth's mom turned what could have been a painful incident and a lifelong source of guilt into an enduring source of affirmation and worthiness.

I wonder if I would have had the presence of mind to realize in the instant after an upsetting event that I could choose my reaction and that my choice would have a permanent impact on someone I love.

The reaction of Elizabeth's mom was nothing short of heroic and stands as a reminder that, even in the face of powerful emotions, we do have choices – and they really matter.

This month be aware of the choices you face each day and remember that they really matter. We teach our family and friends values with everything we say and do. The trouble is we're not always aware of what value we're teaching. Stop, think and remember you can always choose to act with kindness and compassion rather than to **react** with anger and emotion.

MORAL GUIDES FOR CATHOLICS – PRECEPTS OF THE CATHOLIC CHURCH

My dear Sisters and Brothers in Christ,

At the ending of our Fortieth Quadrennial Convention in Baltimore, Maryland last autumn, Mary Therese Tylus, a member of the Anna Hurban District of Chicago, came up to introduce herself to me. In the course of our conversation, Mary Therese asked if I would consider coming to their District and be the celebrant of their annual Saint Anne Day Mass in July 2012. It is easy for me to say "yes" when an event is over eight months away but those months fly by quickly. But I was honored that she asked me to keep the date open. And when the annual district presidents met at our home office in Beachwood, Ohio, this past May, the president of the Chicago District, Mary Therese, reminded me of my October commitment. Then there were a slew of e-mails that were sent to me that were full of details from Mary Therese, whom I soon nicknamed "Nervous Nellie of Chicago"! 

Message from our National President

We are in the midst of celebrating the 120th anniversary of our beloved Zenska Jednota. In August, 1892, called together by our Foundress, Mrs. Anna Hurban, a Slovak immigrant wife and mother, 15 delegates from different parts of our country met for our first convention in a church parish hall in Cleveland, OH. After consulting with Rev. Father Stephen Furdek, a leader in

the Slovak-American community at the time, Mrs. Hurban

already had convinced eight other Slovak women in Cleveland to form a national fraternal organization to provide death benefits, to improve the moral and social conditions of its members and to aid and assist members in times of need.

Those fifteen delegates and the first national officers were representatives from various parts of the United States where Slovaks lived: Cleveland, Minneapolis, Pitts-

burgh, Johnstown, Terre Haute

and Yonkers. The delegates chose our name,

our Patron Saint, St. Ann, and our purpose, which remain to this day. What a forward thinking woman Mrs. Hurban must have been!

How many organizations, whether businesses or fraternal benefit societies, have survived, let alone grown and thrived, after 120 years?

During this landmark anniversary year, it is important to note that the First Catholic Slovak Ladies Association is positioned well for a period of sustained managed growth. Our board of directors and managing officers are committed to take the steps necessary to manage that growth through product changes, continued monitoring of trends in key financial and other indicators, and study and implementation of appropriate infrastructure modification.

A.M. Best agreed with us when we articulated this philosophy and business strategy to them and we attained an A- (Excellent) rating in May of this year.

We must continue to find new and innovative ways to build financial and fraternal strength for our members, while striving to increase our membership. We have reconstituted

Our Slovak Spiritual Heritage

Our Mother of Sorrows — Patroness of Slovakia

In Slovakia the feast of Our Mother of Sorrows is a Catholic non-working national holiday celebrated on 15 September in the small town of Šaštín-Stráže in Western Slovakia at the National Basilica of Our Mother of Sorrows.

The pilgrimage to Šaštín traces its roots back to 1564 when the wife of a Hungarian nobleman commissioned a statue of the Sorrowful Mother to be erected as an answer to a prayer. Since that time this statue, the Šaštín Pieta, had become the focus of devotion for pilgrims. The Empress Maria Theresa noticed that a large number of pilgrims had continued to visit the shrine, so she requested that a larger church be built to house the Pieta. In 1764, with Maria Theresa in attendance, a cathedral was consecrated to the Mother of Sorrows in Šaštín.

In 1667 the Vatican approved the feast of Our Sorrowful Mother to be recognized and celebrated. In 1814 Pope Pius VII added the feast of Our Sorrowful Mother to the Roman Catholic calendar of Saints on the third Sunday in September. In 1913 Pope Pius X moved the feast to 15 September.

In 1927 Pope Pius XI first proclaimed Our Mother of Sorrows as patron of all Slovakia. In 1964 Pope Paul VI strengthened this proclamation by designating the Šaštín cathedral to be a Minor Basilica, the first basilica in Slovakia. In 1995 Pope John Paul II added a golden crown to the statue.

Within the Basilica of the National Shrine of the Immaculate Conception in Washington, DC a chapel was built to honor Our Mother of Sorrows, the Patroness of Slo-



vakia. This monument was a gift from the First Catholic Slovak Union of the United States (Jednota). On September 5, 1965 this Slovak shrine was dedicated to Our Mother of Sorrows as a true and lasting tribute to the deep faith and faithful devotion of the Slovak people in Slovakia and America. *Sr. Catherine Laboure Bresnock, SS.C.M.*

Ann Fedorchak, Financial Secretary and member of Jr. Branch 184 of Gary, IN, turned 90 on June 27, 2012.


She celebrated with her family and received, among other gifts, a number 90 Chicago Bears jersey to commemorate this milestone. Now she is ready for football season. Go Bears!



Slovak Catholic Federation Plans Pilgrimage of Faith for 2013

Rev. Philip Altavilla, V.G., National President, Slovak Catholic Federation, announced that a special Pilgrimage of Faith is being organized for April 14-26, 2013, to celebrate a number of milestones in the history of the Catholic Church: the Year of Faith declared by Pope Benedict XVI in commemoration of the 50th anniversary of the convening of the Second Vatican Council by Blessed Pope John XXIII and the 20th anniversary of the publication of The Catechism of the Catholic Church; the 50th anniversary of the founding of the Pontifical College of Saints Cyril and Methodius, Rome, Italy, due to the vision and efforts of Cardinal Joseph Tomko, assisted by the late Bishop Andrew Grutka and many committed Slovak Catholics from America and Canada; and the Jubilee Year in Slovakia, recalling the 1,150th anniversary of the arrival of Saints Cyril and Methodius to preach the Gospel to the Slavic peoples.

Those wishing to participate are reminded that this event is a Pilgrimage and not an ordinary tour. Given the places that are to be visited and dignitaries that are to be met, elements of the itinerary may change, even at the last minute. This pilgrimage is organized through Danube International Travel Agency, Nyack, NY, and is presented as an opportunity to celebrate both Catholic faith and Slovak heritage.

Pilgrims will depart from Philadelphia on Sunday, April 14, 2013, with arrival the following day in Rome. Five full days will be spent in Rome which will include visits to major religious and historic churches and sites. While in Rome, pilgrims will attend the weekly Wednesday papal audience with His Holiness, Pope Benedict XVI, and will visit the Pontifical Slovak College of Saints Cyril and Methodius. Pilgrims will reside at the same hotel the entire time in Rome.

Following a visit to Rome, pilgrims will fly to Vienna, Austria, and then transfer to motor coach to spend the remainder of the pilgrimage in Slovakia. While in Slovakia, pilgrims will stay at a hotel in Bratislava for five days and will visit places such as: Trnava, Šaštin and Nitra, the site of the oldest Christian Church in Slovkia. Nitra was the center of the evangelization mission of Saints Cyril and Methodius, with Saint Methodius having served as Archbishop of Nitra. The pilgrimage will also include a visit to Velehrad, Czech Republic, where Saint Methodius is believed to have died in 885 a.d.

Pilgrims will depart from Vienna, Austria, to Philadelphia on Friday, April 26, 2013. The cost of the air and land package is \$3,900.00 per person based on double occupancy. The single supplement is an extra \$780.00. Space on the pilgrimage is limited so initial registration with a \$100.00 down payment must be submitted by **Saturday**, **September 15, 2012**.

Slovak Catholic Federation Mid-Year Annual Appeal Report

Since 1978, the Slovak Catholic Federation has been conducting the SS. Cyril and Methodius Appeal which begins each year in the month of February during the closest weekend to the Feast of SS. Cyril and Methodius. To date, I wish to report that **\$17,514.89** has been collected; this is roughly \$5,000.00 short from last year's Mid-Year Report. Now in its 34th year, this Appeal has primarily been taken up in parishes of Slovak heritage in the United States.

As we are all very much aware, the days of "ethnic parishes" are becoming a thing of the past. More and more Slovaks reside in different parts of the country and no longer claim to belong to a parish of Slovak heritage. For this reason, many Slovaks may not have the opportunity to hear about, let alone participate in, this Annual Appeal. If it were not for the Slovak Catholic fraternal societies and their publications, communication to American and Canadian Slovaks would not be possible. In recent years, we have seen an increase in individual donations apart from the parish collections. Also, most of the Slovak fraternal societies have also been making contributions to this collection from their National Boards of Directors, along with a number of local branches, wreaths, assemblies, and lodges. The Appeal continues during the entire calendar year 2012.

This Appeal assists the Church in Slovakia by supporting the training mission of the Pontifical Slovak College of SS. Cyril and Methodius in Rome, Italy (formally known as the Slovak Institute or *Ustav*). In addition, funds are distributed to those Religious Communities of both men and women which share a counterpart which belongs to the Slovak Conference of Religious. These communities are: the Vincentian Sisters of Charity (*Ruzomberok*); Dominican Sisters (*Dunajska Luzna*); School Sisters of St. Francis (*Zilina*); Daughters of St. Francis (*Bratislava-Prievoz*); Byzantine Catholic Sisters of St. Basil the Great (*Secove* and *Presov*); Franciscan Friars Minor (*Bratislava*); and House of St. Benedict (*Bacurov*).

As various groups will be holding summer picnics, along with several fraternal national conventions this year, I would ask that consideration be given to kindly taking up a collection in support of the Slovak Catholic Federation Appeal. All donations are tax deductible. In 2010, this Annual Appeal totaled **\$40,049.25**.

SAUSAGE-STUFFED SQUASH

- 4 medium summer squash (zucchini, yellow or a combination), halved lengthwise
- 12 ounce(s) Italian pork sausages, casing removed
- 1 can(s) (14.5 oz.) diced tomatoes in juice with roasted pepper, not drained

Scoop flesh from squash leaving a ¼-inch-thick shell. Dice flesh.

Cook sausage and diced squash in a large nonstick skillet, breaking up sausage with a spoon, approximately 5 minutes or until browned and cooked. Remove to a bowl and stir in tomatoes.

Put squash halves cut side down in skillet. Add 2 tablespoons water, cover and cook 2 minutes. Turn squash over, cover and cook 2 minutes until crispy-tender. Fill with sausage mixture. Cover; cook over low heat 2 minutes to reheat.

CRISPY EGGPLANT WITH SPICY TOMATO SAUCE

1 eggplant, peeled and cut into 1/4 inch slices

salt to taste

2 eggs

- 2 tablespoons milk
- 1/2 cup grated Parmesan cheese
- 1/2 cup wheat germ
- 2 cups tomato sauce
- 1 teaspoon cayenne pepper
- 1 cup shredded mozzarella cheese Preheat an oven to 400 degrees. Sprinkle the eggplant slices with a little

salt on each side. Place onto a baking SEPTEMBER 2012

sheet, and set aside for 10 minutes. After 10 minutes, blot with paper towels to remove the moisture that has accumulated. Meanwhile, beat the eggs and milk together in a mixing bowl; set aside. Mix the Parmesan cheese and wheat germ until evenly combined; set aside.

Dip the dried eggplant slices into the egg, allow excess egg to drip off, then press into the Parmesan cheese mixture until coated on both sides. Gently shake off any excess Parmesan cheese, and place the eggplant slices onto a baking sheet. Repeat with remaining eggplant slices.

Bake in the preheated oven until tender and golden brown, 15 to 20 minutes. While the eggplant slices are baking, cook and stir the tomato sauce and cayenne pepper in a saucepan over medium heat until hot. When the eggplant is done, pour the sauce over top, and sprinkle with mozzarella cheese to serve.

GARDEN VEGETABLE CASSEROLE

1/4 cup olive oil

- 3 small zucchini, cut in half lengthwise then into ¼-inch slices
- 3 small yellow squash, cut in half lengthwise then into ¼-inch slices
- 2 green bell peppers, cut into bite-size strips
- 2 red bell peppers, cut into bite-size strips
- 3 banana (or hot) peppers, seeded and chopped
- 2 sweet onions, sliced
- 5 eggs
- 1 cup heavy cream
- 2 tablespoons all-purpose flour
- 8 ounces processed cheese food (eg. Velveeta), cubed
- 2 cups seasoned bread crumbs
- 1 cup grated Parmesan cheese
- garlic powder to taste
- onion powder to taste
- seasoned salt to taste
- black pepper to taste
- Pre-heat oven to 350 degrees. Heat olive oil in a large skillet over medium high heat. Add zucchini, yellow squash, green and red bell pepper, and onions; cook, stirring occasionally until slightly softened. Meanwhile, in a bowl, whisk together eggs, cream, and flour.

When vegetables are tender, drain skillet of excess liquid and arrange in the bottom of a large glass baking dish. Season as desired with seasonings of choice, and stir to blend flavors. Distribute cheese cubes evenly over the vegetables. Pour in the egg mixture, and spread bread crumbs and Parmesan cheese over the top. Bake in the preheated oven for 45 minutes to 1 hour, or until bubbling hot. Remove cover during the last 15 minutes to brown top lightly. Serve immediately.

PEACH KUCHEN

1/2 cup margarine

- 1/4 cup white sugar
- 1 egg
- 1 teaspoon vanilla extract
- 1 cup all-purpose flour
- 1/2 teaspoon baking powder
- 1/4 teaspoon salt
- 1 (29 ounce) can sliced peaches, drained
- 3 tablespoons white sugar
- 1 teaspoon ground cinnamon

Preheat oven to 350 degrees. Grease and flour a 9 inch springform pan. Sift together the flour, baking powder and salt. Set aside.

In a large bowl, cream together the butter and sugar until light and fluffy. Beat in the egg, then stir in the vanilla. Beat in the flour mixture. Spread dough with hands over the bottom and 1 inch up the sides of prepared springform pan. Arrange peach slices in a spoke pattern over the dough. Sprinkle with sugar and cinnamon.

Bake in the preheated oven for 35 to 40 minutes, or until golden brown.

STRAWBERRY ANGEL FOOD DESSERT


- 1 (10 inch) angel food cake
- 2 (8 ounce) packages cream cheese, softened
- 1 cup white sugar
- 1 (8 ounce) container frozen whipped topping, thawed
- 1 quart fresh strawberries, sliced
- 1 (18 ounce) jar strawberry glaze

Crumble the cake into a 9x13 inch dish.

Beat the cream cheese and sugar in a medium bowl until light and fluffy. Fold in whipped topping. Mash the cake down with your hands and spread the cream cheese mixture over the cake.

In a bowl, combine strawberries and glaze until strawberries are evenly coated. Spread over cream cheese layer. Chill until ready to serve.
