<u>ANNUAL ACTIVITY REPORTS / BRANCH CARDS / 990-N</u> - They were mailed to you in December, 2015 and all 3 will need to be completed and returned to the Home Office by <u>January 31, 2016</u>. You must have <u>at least 2</u> branch officers listed on your branch cards. Also, in order for you to receive your annual branch compensation check you must complete and submit your Branch Cards <u>AND</u> 990-N form <u>AND</u> Fraternal Activity Report. They are to be mailed back all 3 together in the envelope that was enclosed.

A few tips:

- 1. Please read the letter and guidelines for the *Fraternal Activity Report*.
- 2. When completing the *Branch Card*...If you have an E-mail address please indicate it in the space provided. Also, if you would like one of the branch officer's information displayed on the FCSLA website, indicate the selection at the bottom of the card. **If you DO NOT check anyone, the contact will DEFAULT to the Fraternal & Youth Director**.
- 3. Read the letter explaining the 990-N forms.
- 4. Mail all 3 forms together in the envelope that is provided.



BRANCH BANK ACCOUNTS - A reminder—you are REQUIRED to have a branch bank account set up and have at least two (2) signatures on your Branch Bank Account. You MUST have your Branch EIN # on the Branch Bank Account. You should NOT have your personal SS# on the Branch Bank Account. The funds for the branch are not for personal use. They are for the branch member activities and charitable donations. If you do not know your EIN #, please contact Kelly Shedlock, Fraternal & Youth Director, and she will be more than happy to look it up and give it to you.



<u>MEMBERS / NAME / ADDRESS CHANGE</u> — Only the Insured, Annuitant or Owner can authorize a Name / Address Change. The Insured, Annuitant or Owner is required to sign the Address / Name Change form. Branch officers are not allowed to request a name / address change for a member.
