Please make sure you shred annually any documents that have members names, addresses, certificate numbers, etc. Do not just throw them in the trash cans.



<u>BRANCH ACTIVITIES</u> - Branches should have at least one branch activity a year, try doing a Matching Funds project, have branch meetings, plan a Join Hands Day, make donations, etc. Make sure you keep track throughout the year! You will be amazed of what your branch does on a yearly basis.
