

What Are Disclaimers And Why Would I Want To Use One?

Hello. My name is Attorney Jeffrey J. Malak and I am General Counsel of the Polish Union and a partner in the law firm of Chariton & Schwager, Wilkes-Barre, PA. will be providing you with information which you may find useful with regard to various legal topics. Please look for the Lawfully Yours column in future Fraternal Journal issues.

Disclaimers are an important part of postmortem tax planning. Sections 2518 and 2045, which were added to the Internal Revenue Code in 1976, set forth the requirements for making an effective disclaimer for federal tax purposes. The regulations provide that, in order to be effective for federal tax purposes, a disclaimer must comply with local or state law.

To be valid under Pennsylvania law, a disclaimer must be in writing, describe the interest disclaimed, declare the disclaimer and be signed by the disclaimant.

Virtually all interests devolving by whatever means may be disclaimed regardless of any spendthrift or other restriction. A disclaimer may be made on behalf of a decedent, minor or incapacitated person by such person's personal representative, guardian or power of attorney holder with court

In a situation where an interest passes by ill or intestacy a disclaimer must be filed with the clerk of the Orphans' Court and a copy of the disclaimer delivered to any fiduciary in possession of the disclaimed property. Unless a decedent has provided for an Lawfully Yours





alternative disposition in the case of a disclaimer, the disclaimant will be treated as having predeceased the decedent.

For purposes of Pennsylvania Inheritance Tax, if a qualifying disclaimer, or renunciation, is not barred and is made prior to the time the inheritance tax return is due, the property will pass as if the disclaimant had predeceased the decedent and inheritance tax will be assessed accordingly. This could have the effect of shifting the inheritance tax rate from 4.5% to 15% if the effect of the disclaimer is to bypass a spouse in favor of a lineal decedent, collateral relative or non-rel-

Visitors included Mother Ryszarda Wittbrodt, a native of Poland and Provincial Superior of Sacred Heart Province, Cresson, Pennsylvania; Sister Rafala Golonka, religious superior and administrator of the John Paul II Nursing Home (Dom Opieki im. The Sisters in Kamesznica strive to provide this home in the spirit of the Servant of God, John Paul II, who so upheld the dignity to be accorded every human per-This is why the Sisters describe this project as "Building a Living Monument to John Paul II."


A Wonderful Wafer Supper

Merger Agreement of the Polish Union and the Grand Council of Pennsylvania Catholic Beneficial League

The Agreement of Merger dated January 4, 2010 by and between the Polish Union of the United States of North America ("Polish Union") and the Grand Council of Pennsylvania Catholic Beneficial League ("Grand Council") is being furnished to all Polish Union members by publication in the Fraternal Journal, the official publication of the Polish Union. This Agreement of Merger will be affirmed at a Special Polish Union Convention to be held on March 21, 2010 at the Ramada, located at 20 Public Square, Wilkes-Barre, Pennsylvania. The full Agreement of Merger is published below.

AGREEMENT OF MERGER THIS AGREEMENT OF MERGER

(hereinafter referred to as the "Agreement"), made this 4th day of January, 2010, is by and between the Polish Union of the United States of North America ("PUNA"), a Pennsylvania domiciled Fraternal Benefit Society located at 53-59 North Main Street, Wilkes-Barre Pennsylvania 18703 and the Grand Council of Pennsylvania Catholic Beneficial League (hereinafter referred to as the "GRAND COUNCIL"), a Pennsylvania domiciled Fraternal Benefit Society located at 24 Race Avenue, Lancaster, PA 17603.

WHEREAS, with the best interests of the GRAND COUNCIL members in mind, the Officers and Directors of the GRAND COUNCIL have reached an agreement with the Officers and Directors of PUNA to merge the GRAND COUNCIL into PUNA. GRAND COUNCIL and PUNA are fraternal benefit societies with the same religious (Roman Catholic) and geographical origins (Pennsylvania) and with similar fraternal goals of service to its members; and

WHEREAS, all the GRAND COUNCIL memberships and contracts will be transferred to PUNA, and PUNA will assume all liability for each in-force GRAND COUNCIL contract and/or life insurance certificate as though it had been originally issued by PUNA;

NOW, THEREFORE, in consideration of the mutual agreements included herein, and intending to be legally bound thereby, the parties agree as follows:

1. The GRAND COUNCIL agrees to

merge with PUNA.

2. The GRAN

- The GRAND COUNCIL agrees to transfer to PUNA all of its assets and will cooperate with PUNA to accomplish such transfer. Assets will be valued at market value as of the date of transfer for use in determining the solvency distribution set forth below in this Agreement.
- 3. The GRAND COUNCIL agrees to reduce its liabilities to zero by payment in cash and/or transfer of assets to PUNA. Liabilities will be those reported in the financial statements according to NAIC accounting
- 4. PUNA agrees to accept all current certificate holding GRAND COUNCIL members
- 5. PUNA agrees that the solvency distribution between the GRAND COUNCIL and PUNA will be equitable and some portion of the difference between the GRAND COUN-CIL solvency and PUNA's solvency will be distributed in the form of paid up additional insurance for GRAND COUNCIL members.
- 6. PUNA agrees to assign GRAND COUNCIL groups an administrative number for billing and other administrative purposes.
- PUNA agrees to permit each GRAND COUNCIL group to remain self-governing without interference from PUNA.
- 8. PUNA agrees to permit each GRAND COUNCIL group to keep and maintain its own treasury (excluding premium income) which shall remain under that GRAND COUNCIL group's control. PUNA will not seek to gain control of any local group's funds unless that local group should request PUNA's assistance in administering their
- 9. PUNA agrees to retain the President, Secretary, Grand Treasurer and Grand Financier of the GRAND COUNCIL with their current salaries until December 31, 2011 or earlier, if agreed to in writing by both the GRAND COUNCIL and PUNA.
- 10. PUNA agrees to offer the President and Secretary of the GRAND COUNCIL advisory seats on the PUNA Board of Directors with a stipend until December 31, 2011, contingent upon their participation and/or attendance at Board of Director meet-
- 11. PUNA agrees to offer the GRAND COUNCIL delegate positions beginning with PUNA's 2010 convention in accordance with PUNA's Constitution and By-laws.

- 12. PUNA agrees to pay for the legal drafting of all merger documents and legal advertising required under this Agreement and under the laws of Pennsylvania.
- 13. PUNA agrees to provide financial support to those activities and charities currently sponsored by the GRAND COUNCIL
- 14. PUNA agrees to offer GRAND COUNCIL members the same benefits as PUNA members.
- 15. PUNA agrees to allow participation in PUNA's scholarship program, which offers qualified student members scholarship aid from \$200.00 up to \$800.00 in accordance with PUNA scholarship rules.
- 16. PUNA agrees to provide one copy per family of the PUNA official publication, the Fraternal Journal, with a special GRAND COUNCIL section in the Fraternal Journal.
- 17. PUNA agrees to create new letterhead with the combined PUNA and GRAND COUNCIL logo identifying GRAND COUN-CIL as a division of PUNA.
- 18. PUNA agrees to allow participation in all of PUNA's religious, cultural and social
- 19. PUNA agrees to provide GRAND COUNCIL members access to office space and meeting rooms located at 53-59 North Main Street, Wilkes-Barre, Pennsylvania.
- 20. PUNA agrees to provide each GRAND COUNCIL member with an assumption certificate, which will describe his or her current insurance and contract values. An assumption certificate will be mailed to the last known address of each GRAND COUN-CIL member within ninety (90) days after this Agreement is approved by the Pennsylvania Department of Insurance and/or as required by law. In the event of the death of a GRAND COUNCIL member after the date of this Agreement, but prior to such deceased member's receipt of the assumption certificate, benefits will be paid by the PUNA as if the merger had been completed.
- 21. PUNA and GRAND COUNCIL agree to bear their own expenses (except as provided otherwise in this Agreement) until the date of merger and final approval is obtained from Insurance Department Commonwealth of Pennsylvania. After the date of merger approval, all expenses will be the responsibility of PUNA.

22. PUNA and the GRAND COUNCIL agree that no brokerage fees or commissions will be paid to any person or party in connection with the merger of PUNA and the GRAND COUNCIL.

23. PUNA and the GRAND COUNCIL agree the invalidity of any part of this Agreement shall not affect the remainder. Changes in form, which may be required by a Department of Insurance, shall not require resubmission of this Agreement. Any changes to the Agreement that are required by the Department of Insurance of Commonwealth of Pennsylvania, which are not substantive in nature, are automatically incorporated herein.

24. The GRAND COUNCIL confirms that it is not party involved in any pending lawsuit and/or litigation.

25. PUNA and the GRAND COUNCIL agree this Agreement will be subject to the rules and regulations of the Commonwealth of Pennsylvania.

26. This Agreement may be executed in any number of Counterparts, any and all of which shall be deemed to be the original. A facsimile and/or e-mail signature shall be deemed the same as an original.

Kapusta And Much More

Sauerkraut Salad

Drain and rinse 2 c. sauerkraut, press out moisture and chop. Place in salad bowl and tear apart so it doesn't stick together. Add 1 chopped onion, 1 finely grated carrot and 1 peeled diced apple. Season with pepper and sugar, drizzle with salad oil and toss. Optional: Salad may also be seasoned with caraway.

Pork Ribs and Sauerkraut

Preheat oven to 350 degrees. Drain 1 qt. sauerkraut and rinse in a large pan of cold water, swishing it around with your hand. Drain well, chop coarsely, place in pot, scald with boiling water to cover, bring to boil and reduce heat. Add 1 mushroom bouillon cube (if necessary use beef bouillon) and cook uncovered 20 min. then cover and continue simmering. Divide 2 1/2 Ibs. spare ribs or pork loin-back ribs into 2-rib portions. Rinse, pat dry and place bone-side-down on a rack in an uncovered baking pan. Bake about 1 hr. Transfer sauerkraut to a roaster and into it mix 1 peeled diced apple. Add ribs, covering them with sauerkraut and sprinkle with 2 - 3 T. rib pan drippings. In bowl mix 1 heaping T. Polish plum butter with 2 T. tomato paste (or ketchup) and 1/4 t. Kitchen Bouquet and stir into sauerkraut. Cover and bake another 60 min. at 325 degrees. Season with a little pepper, marjoram and garlic powder, stir lightly and let stand in oven another 20 min. for flavors to blend. Serve with boiled or mashed potatoes and a grated salad.

Grated Carrot Salad

With hand-held grater or in processor, grate 3 carrots and 1/2 celeriac (celery root). Add 2 peeled cored, coarsely grated apples and 1 - 2 heaping T. prepared non-creamed horseradish. Mix well and season with juice of 1/2 a lemon and just enough sugar for a nice balance. Lace with 1 - 2 T. sour cream or low-fat yogurt.

Polish Pork Stew

Rinse and pat dry 11/2 Ibs. cubed stewing pork. Shake meat in a flour-filled plastic bag to coat evenly. In a heavy skillet, brown meat on all sides in 3 T. hot oil or shortening. Remove meat from skillet with slotted spoon and lightly brown 3 sliced onions in the same drippings. Return meat to skillet, add 2 - 3 sliced carrots, 1 small diced turnip (optional), 1 bay leaf and 1/2 c. beer. Reduce heat and simmer covered on low heat 45 - 60 mins. or until meat is tender, stirring occasionally. Add a little water if stew begins to sizzle. Season with salt & pepper, 1/4 t. paprika, 1/4 t. marjoram, 1/4 t. crushed caraway seeds and (optional) 1 bud crushed garlic. Stir ingredients and simmer briefly. Garnish with chopped parsley if desired. Serve with batter dumplings (see below).

Batter Dumplings

First, bring a large pot of slightly salted water to boil. Sift 1 1/2 c. flour into a bowl. Add 1/2 t~salt, 2 beaten eggs and about 1/2 c. water. Mix with wooden spoon to blend ingredients and then beat vigorously until batter is smooth. The more air bubbles beaten into the batter, the fluffier the dumplings will be. Dip a teaspoon into the boiling water, scoop up a spoonful of batter and drop it into the boiling water. Continue until batter is used up, dipping spoon in boiling water before each addition. When boiling resumes, reduce heat and cook covered 3 -4 min. Remove dumplings to colander and rinse. Drain well and serve with gar-

The Irena Sendler Story

While researching the holocaust for a school project, four Protestant kids from Kansas discovered a story of a Polish Catholic woman who defied the Nazis to save over 2,500 Jewish children.

The play they wrote telling this story isLife in a Jar. It is the story of Irena (Krzyzanowska) Sendler, a Polish Catholic social worker who saved the lives of children by going into the infamous Warsaw Ghetto. There she visited Jewish families to 'talk them out of' their precious children in order to save their lives. She, along with her network of twenty-five rescuers, secretly removed these children and placed them in convents and safe houses where they were cared for by compassionate and courageous Polish people until the war's end. Irena felt, "it was simply the decent thing to do." She would record the true identities of these children and for safe keeping place these records in jars which she buried under an apple tree.

Hence the title - Life in a Jar. Irena's courageous and heroic actions were almost lost to history. This play, written about her, eventually brought world recognition. Life in a Jar was recently preformed at the Mellow Theater, Scranton, to a grateful audience of both the Polish and Jewish her-

Irena was nominated for the Nobel Peace Prize in 2007, the year it was given to Al

Irena died on May 12th, 2008 at the age of ninety-eight.

Then budget for the monthly payments, credit cards and any outstanding bills. . Contact your creditors if you can't make immediate payments. Most creditors will agree since some payment is better than

Consider taking a debt-consolidation loan. With this the interest rates are usually lower. Some card firms don't make new charges until the old ones are paid. A nonprofit organization called Consumer Credit Counseling Services can be reached at an office near you.
