Your Privacy Is Important And Protected at Polish Union

The Board of Directors of the Polish Union of U.S.A. has adopted the following policy regarding the fraternal and its members right to privacy of individual information, we possess for insurance purposes. That policy is printed below for your information. If you have any questions regarding this policy, please call the Polish Union Home Office.

1. The Purpose Of This Policy Shall Be To:

- a. insure the security and confidentiality of customer records and information
- b. protect against any anticipated threats or hazards to the security or integrity of such records, and
- c. protect against unauthorized access to or use of such records or information which could result in substantial harm or inconvenience to any customer.

2. Persons Bound.

This policy shall be applicable to and adhered to by the Officers, members of the Board of Directors, employees of and all of the Officers of the groups comprising the Polish Union and all of our group secretaries and licensed agents. Further, all of the members of the Polish Union are requested to adhere to the letter in spirit of this policy.

3. Information Subject To This Policy.

All of the information we have collected or will collect in the future regarding our officers, members of the Board of Directors, District Directors, employees, officers of our groups, group secretaries and our members and their beneficiaries concerning demographic data such as names, addresses, social security numbers, etc., along with information regarding employment, finances, health, avocations and other personal characteristics.

4. Declaration Of Confidentiality

All of the information collected by Polish Union is hereby declared to be confidential and shall not be disclosed to any individual or other entity without the express written consent of the affected person.

5. Exceptions To This Privacy Policy

In the course of our business, we must disclose certain information to other individuals or firms in order to enable them to provide business services to us including our re-issuers, actuarial and data processing services subcontractor. However, our contracts with any of our subcontractors require them to keep confidential any information which may be disclosed to them. In addition, information may be disclosed to our auditors or for research purposes, regulatory agencies such as state insurance departments. In addition, Polish Union will comply with all lawful subpoenas issued by order of any court or regulatory body.

6. Disclosure To Third Parties.

Polish Union at present does not disclose any personal information to other companies or organizations not affiliated with it that would use the information we have provided them to contact your about their own products or services.

7. Duration Of Confidentiality.

Should you cease to be a member of Polish Union, we will continue to protect and safeguard your personal information in the same manner as we do with our members.

8. Source Of Information

The great bulk of the personal information which Polish Union obtains from its members comes directly from the members particularly in the form of policy applications. This information provides Polish Union with those facts which it needs in order to conduct its business. In many cases, it may need to verify this information or it may need additional information which it may obtain from third parties such as employers, consumer reporting agencies and health care providers.

9. Use Of This Information

Polish Union uses the information gathered from its members and from other third parties in the normal course of our insurance business and our fraternal relationships with its members. The business purpose for collecting this information includes the evaluation of a request for our insurance or other services, and analysis of benefit claims and administration of our products or services in addition to processing transactions and other requests by members. In addition, we will use this information to contact you about services and products which we currently provide or may provide in the he future.

10. Safeguarding Of This Information.

Polish Union shall take all steps reasonably necessary to safeguard the integrity of the information in its custody including the continued use of our office vault, the use of all reasonable methods of safeguarding information contained in our computerized data system and the control of the office area.

11. Adherence To This Policy.

All of the Officers and each member of the Board of Directors, District Directors, employees, officers of groups, group secretaries and licensed agents shall be given a copy of this policy and asked in writing to acknowledge its receipt on an annual basis.

12. Sanctions For Violation Of This Policy.

The Board of Directors will investigate all alleged breaches of this policy and will impose sanctions and penalties, on a case by case basis, should a violation of this policy be shown. In addition, the Board of Directors will, in appropriate cases or when required by law or regulation, report all violations to state and federal authorities. Penalties for violation may include dismissal from employment by Polish Union in addition to those sanctions and penalties provided by law.

13. Procedure

If anyone to whom this policy applies is requested by a third party to divulge any confidential information, the General Secretary must be notified of such requests. The General Secretary shall have the responsibility, in consultation with the Executive Committee, of deciding whether or not to comply with such requests.

2. Applicants must be a High School Graduate or higher, entering the Fall Term in the year that they are applying for the Scholarship Grant, and must be a Full Time student (12 Term/Semester Hours).

Applicants must Obtain and Submit to the Polish Union; Verification from the University, College, Junior College, Graduate, Business, Nursing or Trade School that they will be attending in the New Fall Term for the year that they are applying for the scholarship. 



Babka For Your Easter Basket

Easter Food Blessing, an ancient Polish custom As the spring approaches we can feel a difference in the air, especially I the morning. The birds begin to sing rather than chirp and some plants begin to show some color. Pussy willow and forsythia are the first two to bloom and can often is forced inside if they are not in bloom for the holiday outdoors. This year Easter is early, falling at the end of March so these and other spring blooms will adorn tables since Polish customs dictate that fresh flowers be on the table along with all the delicious foods at Easter time. Holy week customs that go back at least 1000 years are still being observed by Polish American families. Those of us who had Babci or other elderly family members keep the old customs alive might have to stop up to the plate as they say and see that our beloved traditions are carried on. Many people of Polish or other Eastern European descent make a basket of Easter foods to be blessed on Holy Saturday and take it to their parish priest. This custom is a very important part of a Holy Week rich in traditions passed on from one generation to the next. This basket was called Swieconka and usually has food symbolic of the Easter holiday. The big beautiful Babka or sweet bread made into a large round cake is usually the centerpiece of our basket. This soft, delicious dough is often embellished with a cheese or jelly filling. A Paschal Lamb, representing the Lamb of God can be made from cake, bread or butter and is often centerpiece of the food brought to the church. Eggs, both decorated and plain are a symbol of new life or rebirth. Meat, usually ham or sausage (kielbasa), Horseradish, bitter herbs that signify the bitterness of the suffering of Christ, and salt a Polish sign of hospitality are all found in this basket. Greenery, usually in the form of boxwood or branches of pussy willow represents the awakening of the earth. Bread is always in the basket, both a symbol of communion, the bread of the last supper and the traditional sweet breads or Babka. This basket is usually taken to the local church on Holy Saturday around noon, but in old times the Parish priest often visited each home and thus blessed the food and the house. Today many local parishes still observe this custom, on Holy Saturday. Many time people will drive long distances to revisit the church of their grand parents and parents and keep the tradition. In some parishes the tradition begins a new when Polish families ask the priest to have a food blessing Holy Saturday. More information of this and other customs may be found in The Polish Traditions or country cookbooks by Sophie Hordorowicz Knab. BABKA (takes three risings, last time can refrigerate till next day, allow almost 2 hours for cold dough o rise. Bake for 40-45 minutes or until done at 350.3/4 c. soft butter 1/2 tsp. cinnamon1/2c. sugar 4 c. flour4 egg yolks; 2 whole eggs optional fillings: 1 c. white raisins 1 tsp. salt 1 cup raisins, jelly or *cheese 1 package of yeast 1 c. warm milk



1/4 c. warm waterFrost with butter icing of 1 box 4 X sugar, 1 stick melted butter and a few drops of milk to make it soft. Top warm not hot cake with this and it will melt down sides of cake! Top with a pansy blooms when ready to serve. Mix butter and sugar in a large bowl, add salt to eggs and beat until thick; then add this to butter mixture and beat well. Soften yeast in warm water. Add to mixture. Alternatively add flour, cinnamon and milk, beating until a smooth batter is achieved. (I use kitchen aid mixer for this) Add raisins if desired. Knead until batter with any additional flour needed so that it leaves fingers easily. Let rise until double in bulk. Punch down and allow rising again. Generously grease or butter a fluted tube pan and sprinkle with breadcrumbs or flour. Fill with dough. Brush dough with a mixture made by beating 1 egg yolk and 2 tablespoons water if you like, not necessary. Sometimes I roll the dough out before placing in pan and spread with a berry jam. Then roll up jelly roll style and place the coil in tube or bundt pan. A cheese filling of a pack of cream cheese or a cup of ricotta or farmer s cheese, 1/2 cups sugar, 1 tsp. vanilla or lemon juice, and a beaten egg can also be use. Sprinkle with almonds. Let rise a third time. Bake at 350 degrees for 30 minutes. There are probably as many Babka recipes as there are Babci, but this one is easy and tasty. My Babci used more than dozen eggs in her Babka. I often stood at her elbow as she made a dozen or more for holidays. She uses to get up very early to make this. I however make the dough in the late afternoon or early evening, allow it to rise two times and place in pan which goes in refrig all night. Get up early and place the pan near a warm oven. It takes about an hour and a half to rise if in a warm spot. Then bake for 40 minutes at 350.
