
## **Polish Union aka Ameripol**

We have launched a Marketing Project to help the general public become more aware that the family oriented programs we offer are open to all. 

As someone who does stained glass, I have been especially impressed by Jozef Mazur and his works. Below is a brief listing of his accomplishments.

Jozef Mazur is not necessarily a household name, but in the world of fine arts, the name Mazur is directly connected to mediums of statuary, ecclesiastic murals, and especially magnificent stained glass windows. Just when you think the Germans have cornered the market on stained glass production, a man of Polish decent outshined them all in terms of technique and artistic beauty. Jozef Mazur, born to a Galician family in 1897, studied at the prestigious Albright Art School in Buffalo, New

York, and became a prolific creator of ecclesiastic stained glass windows. His reputation for exceptional workmanship, and the exquisite beauty of his work, spread to larger cities such as New York, Philadelphia and Chicago, where many examples of his work can be found. Jozef Mazur used his gifts and talents to inspire generations of faithful in churches throughout America and Europe. The Polish Room at the University of Buffalo houses a magnificent four-panel stained glass window depicting Frederic Chopin, Adam Mickiewicz, Juliusz S?owacki, and Ignacy Paderewski. This window is a beautiful example of Mr. Mazur's love of Polish heritage.

The next time you enter a house of worship, pay special attention to the stained glass windows. Look for a signature, and you might just find a window signed by Jozef Mazur. The Polish Union in Wilkes-Barre just happens to have its very own signed Mazur window, located in the main staircase area. It is quite a treasure to behold, and incredibly, it's in our very own home office.

## Civil War Hero General Wlodzimierz Krzyzanowski

With the nation observing the 150th anniversary of the beginning of the Civil War, it is good to remember Wlodzimierz Bonaventure Krzyzanowski who was born on July 9, 1824 in Roznów, Poland. A cousin to the famous pianist, Frederick Chopin, he came to America in 1846 and became a civil engineer. In 1861 he joined the Union Army and rose rapidly in rank from private to Colonel of the 58th Infantry of New York.

After the battle of Cross Keys, he was given the rank of Brigadier and for his gallant part in the battle of Bull Run, President Lincoln appointed him to the rank of General. After distinguishing himself at the Battle of Gettysburg, he was stationed in Tennessee, where he was quite effective in instilling law and order to the new frontier. On October 1, 1865, he was dismissed from active service with honors.

Proving himself more than just a fighting man, Krzyzanowski was appointed the first Governor of the newly acquired Territory of Alaska. He also held various positions in the Treasury Department.

In 1883 he published a book, Wspomnienia Z Pobytu w Ameryce (Memories of My Odyssey in America). In 1886 he founded the Aid Society for Polish Immigrants in New York.

General Krzyzanowski died on January 31, 1887, and was buried in Greenwood Cemetery in Brooklyn until 1937 when his



remains were transferred to a resting place of honor in Arlington National Cemetery in Washington, D.C.

Krzyzanowski was a proud Polish-American who not only proved his patriotism, but his interest in humanity as well.

If they don't want to participate in the talk, they can at least listen to jokes and anecdotes and learn more about the family and its members.



## Have You Reviewed Your **Designated Beneficiary?**

· Life Insurance has more than on purpose, providing a saving fund for use in the event of an emergency, a retirement fund for supplementing other income, but without a doubt the primary purpose is the protection it affords to the beneficiary named on your policy.

• It Is True that in some instances we hope to personally enjoy the benefits accumulating under the insurance contracts, but those responsible for the support of others carry insurance for less selfish reasons in that they hope to guarantee a future for the loved ones that may be left behind.

• While It Is True that insurance is usually taken out to protect someone else, it is also true that not enough thought is given to this after the issuance of the certificate or policy. Failure to keep the Beneficiary Designation up-to-date could mean that the proceeds will be paid to the wrong person or that someone who should share in the proceeds will be left out. Unlike the estate of a deceased person which is distributed to the heirs in accordance with state statutes, life insurance proceeds must be paid to the person or persons

named on the policy as beneficiary.

· Occasionally while going through the files, we find that certificates issued, ten, twenty or more years ago have had no change in beneficiary designation since their issuance. It would seem that in some of the instances, some changes have occurred in the family relationship during this time to require changes in the beneficiary designation. Marriages have occurred or children may have been born so that a husband or new children should be added as beneficiaries.

• Also, it may be that the original beneficiary is no longer living so that a new beneficiary should be named. We believe it is very important that the beneficiary designation be kept up-to-date at all times. It would be our recommendation that you look over your certificates from time to time to make certain that your beneficiary is correctly stated.

Twisting in the selling of life insurance is the misrepresentation made to encourage a policy holder to drop the old polices and buy new ones in another company or society. It is a statutory offense in both the United States and Canada. But the offenders are elusive. They may avoid statutes by urging loans on old policies instead of surrenders, with results equally damaging. A victim may never discover that he has been cheated.

The twister usually starts by trying to undermine your confidence in the company or society in which you own life insurance, and in the agents or recommenders who sold you your policies.

He represents himself as a "specialist" who offers "investments" as well as life insurance and is therefore "unbiased." He implies that you must have bought your present policies from agents who were ignorant of "new and modern" methods. Or they represented companies or societies which do not offer his "unique plan." He will claim that you have been sold 'expensive insurance," containing guaranteed cash values, which he will "liberate" for useful investment. You may be sure he will liberate you from enough cash to pay him a nice feeif he can swap you out of your old policies.

The twister discredits, in advance, all criticism of his proposal. He will predict that the agents who have sold you your insurance will say you are making a mistake to swap it for

new coverage. All he is predicting is truth. But the twister calls it "protecting their own selfish interests.

Should a twisting attempt be made on you, be sure you have all the facts. Give your Group Secretary or the Home Office the opportunity to review the replacement proposal with you so you will have both sides of the story.

## **Healthier Cuisine**

Polish cuisine is not usually thought of as low calorie or even especially healthy, but there are variations to many traditional dishes that can meet today's health-conscious dietary needs.

#### Healthier Golabki

Core and plunge a head of cabbage into a pot of salted, boiling water and simmer until leaves are wilted. Instead of the traditional meat-rice-egg filling, fill the leaves with one of the following:

• Combine 3 c. cooked barley, 16 oz. chopped, fresh mushrooms sauteed with 2 minced onions in a non-stick saucepan in 1T. oil until lightly browned; 1 med. peeled, raw potato, grated (like for potato pancakes), seasoned with salt, pepper, 2 pinches of marjoram and 1 T. fresh chopped dill.

• Combine 1 1/2 c. cooked barley, 1 1/2 c. cooked buckwheat groats, 1 c. cooked or canned, drained lentils, 1 med. peeled raw potato, grated, 2 minced onions, sauteed in nonstick saucepan in 1 T. oil until lightly browned. Season with salt, pepper and 2 pinches of savory

Combine 1 1/2 c. cooked barley 1 1/2 c. cooked brown rice (or buckwheat groats) 1/4 lb. raw ground turkey or chicken meat, 1 med. peeled and grated potato, 2 minced onions sauteed in 1 T. oil until lightly browned, 1 bud mashed garlic, and 1 t. liquid Maggi seasoning. Salt and pepper to taste. Place cabbage rolls snugly in roaster in no more than 2 layers. Drench with 1 c. vegetable bouillon (1 bouillon cube dissolved in 1 c. boiling water) and 2 c. tomato juice. Cover and bake in 350 degree oven 2 hrs. Switch off heat and leave in oven until golabki have cooled to room temp. Refrigerate overnight. Reheat and serve the next day.

**Healthy Fish Smothered In Vegetables** Rinse and dry 1 1/2 lbs. fish fillets. In 2 T. In 2 T. oil, saute 2 chopped onions and 1 stalk chopped celery until tender. Place fillets on top of onions and celery and sprinkle lightly with salt, pepper and sage. Scald 2 tomatoes with boiling water, plunge into cold water and remove skins. Chop tomatoes and place on top of fish. Add 1 c. vegetable bouillon and simmer covered about 15 mins. or until fish flakes nicely. Top with 2 c. cooked (fresh or frozen) canned French beans or peas & carrots and cook covered until heated through. Just before serving, sprinkle with a little lemon juice and garnish with chopped fresh dill.

#### Almost Meatless Bigos

Drain and rinse 1 qt. sauerkraut in cold water. Drain again, chop coarsely, place in pot, scald with boiling water to cover, add 1 bayleaf and cook on low heat 1 hr. Shred a small head of cabbage, place in another pot, scald with boiling water to cover, bring to boil and simmer 20 mins. Drain. IN large saucepan saute in 3 T. oil 1 lb. chopped fresh mushrooms and 2 chopped onions until tender. In roaster or Dutch oven combine and toss sauerkraut, cabbage and mushrooms. Add 1 c. diced, cooked turkey and 1/4 lb. skinned smoked kielbasa, sliced or diced; 2 peeled coarsely grated apples; 1 t. liquid Maggi seasoning; 2 T. ketchup and a sprinkling of salt, pepper, marjoram and ground caraway. Simmer on stovetop 1 hr. or longer, stirring frequently, or bake in 350 degree oven.

High Fibre Kasza & Beans The old peasant dish is perfect for the health-minded. Dice 2 onions and saute in nonstick skillet in 1-2 T. oil until lightly browned. Combine 4 c. hot cooked buckwheat groats with 2-3 c. cooked or canned drained beans (Navy, soy, pea, or lima). Top with sauteed onions. Season with salt, pepper and savory and garnish with chopped chives. Serve with sauerkraut salad, (below)

#### Sauerkraut Salad is Vitamin Rich

Drain and rinse 1 qt.. sauerkraut, squeeze out moisture and chop rather fine. Combine in salad bowl with 1 minced onion (or several chopped green onions), 1 small grated carrot, 10 grated radishes and 2 peeled, grated apples. Toss well, season with pepper and 1/2 t. sugar and lace with several T. Extra Virgin olive oil. Garnish with finely chopped fresh parsley and/or chives.


