Each year our Home Office reports a number of members deaths, yet, beneficiaries have not filed a death claim with us. Until the claim is made and processed we cannot issue the death benefit due. If you know of anyone who might not have filed a death claim that they are beneficiary to, encourage them to contact us. We will help you make arrangements to file a legal death claim. Call us during business hours.

If someone has lost the original policy as the beneficiary, or the policy was misplaced while the deceased was still alive, you may request a duplicate policy providing you have a legal Death Certificate for the deceased member.

### CHANGES HAVE BEEN MADE - PLEASE READ THIS THOROUGHLY

- 1. If All Eligibility Requirements listed below are met then the Approved Applicant will receive a grant as follows:
- Insured for between \$5,000 and \$7,499 of insurance will receive a grant of \$200 dol-
- Insured for between \$7,500 and \$9,999 of insurance will receive a grant of \$300 dol-
- Insured for between \$10,000 and \$14,999 of insurance will receive a grant of \$400 dollars.
- Insured for between \$15,000 and \$19,999 of insurance will receive a grant of \$600 dollars.
- · Insured for \$20,000 or more of insurance will receive a grant of \$800 dollars.
- 2. Applicant must be an Insured Member of the Polish Union of U.S.A. in good standing (paid to date) for a Minimum of Five (5) years and carry a Minimum of \$5,000 of Polish Union of U.S.A. Permanent Life Insurance (excludes term).
- 3. Applicant must be a High School Graduate or Higher, entering the 2013 Fall Term/Semester, and must be a Full Time Student (minimum of 12 Term/Semester
- 4. Applicant must Submit; School Verification from the University, College, Graduate, Business, Nursing or Trade School that they will be attending in the 2013 Fall Term/Semester. Box 660, Wilkes-Barre, PA 18703-0660, E-mailing or polunion@epix.net. Polish Union reserves the right to use the essays and photographs for publicity purposes and information.

7. The Scholarship Application and Essay **Deadline is May 31, 2013**. They must be Postmarked no later than May 31, 2013. Any received with a postmark after this date will not be eligible or considered.

The School Verification will be accepted under separate cover to allow for additional time to acquire, But it must be received no later than July 31, 2013.

8. Scholarship Grants are given to each

approved Applicant once per school year with a lifetime limit of four times. Scholarship Grant checks are issued and sent to the applicant, with the understanding that it will be applied toward applicant's tuition, or supplies.

9. Polish Union accepts no responsibility for decreases of other grants or loan amounts due to the awarding of the Polish Union Scholarship Grant to the student. Students are solely responsible for all aspects of their financial aid status and, thus, should be aware of the consequences of applying for a Polish Union Scholarship


Northeast Polish American Congress, along with a memorial tribute to General Pulaski, followed by the Parade with reserved seats for area attendees.

### Grandma's Chrusciki Recipe

Beat 5 egg yolks with 2 T. confectioner's sugar until white. Continue beating and gradually add 6 T. sour cream, 2 T. melted room-temp. butter and 2 T grain alcohol. (You can also use vodka, whisky, rum, cognac or even 6% distilled vinegar.) Sift 3 c. flour onto board, add yolk mixture and work ingredients into a uniform dough. Knead it vigorously 5 - 7 mins., then beat it with rolling-pin about 10 min., until silky. Keep turning the dough over so all sides get well-beaten. Roll out on floured board, sifting a little flour over the top, and cut into 1 by 4 in. strips. Make a 1-in. vertical slit at middle of each strip and pull one end through slit to form a bow. Cook in hot, deep lard, shortening or oil until golden on both sides, remove to paper towel and, when cool, dust chrusciki with confectioner's sugar.

Bliny Polskie Polish Pancakes
Ingredients: 2 c. lukewarm water; 1½ cakes or 1½ envelopes yeast; 4 c. all-purpose flour; 2 c. whole-wheat flour; 5 separated eggs; ½ c. melted butter; ½ t. salt butter for frying.

Dissolve yeast in milk, add flour and mix thoroughly. Add lightly beaten egg yolks, melted butter and salt and finally, fold in stiffly-beaten egg whites. Let stand at cool room temperature for 3 to 4 hrs. until batter has consistency of waffle batter.

Fry in very hot butter but do not burn. Fry till brown. Serve with sour cream. Note: Recipe serves 12. For half the quantity, use 2 or 3 eggs, depending on size.

Cucumber Apple Salad Mizeria z Ogórków i Jabłek

Place 2 sliced thin cucumbers, 2 cored and sliced thin apples, 4 sliced thin radishes and 3 T lemon juice in a salad bowl, and toss, being sure to cover the apple slices completely with lemon juice. Season ½ c. sour cream with 2 t. chopped dill and spoon over the salad just

**Pork Ribs and Cabbage** Żeberka Wieprozowe z Kapustą

Brown 3 to 4 lbs. of ribs: pork spareribs or short ribs in ¼ c. bacon drippings. Season and combine with 6 peppercorns, salt, 1 ½ c. beef broth, ¼ c. cider vinegar, 1 diced carrot, 2 chopped onions, ¼ t. caraway seeds and 1 bayleaf. Simmer for 1 ½ hrs., adding more broth if necessary (keep meat covered). Add 1 small quartered head of savoy cabbage in quarters and continue cooking for another 30 mins. or until cabbage is tender. Cut into serving pieces and arrange on heated platter with the cabbage.

**Chocolate Mazurek** Mazurek Czekoladowy

Cream 1 c sugar and ½ c. butter, then beat in ½ c. melted baking chocolate slowly. Add 4 lightly beaten eggs, 1 t. vanilla extract, salt to taste and 1 T. light cream or milk and mix well. Gradually sift in 2 c. flour. Spread evenly on a greased cookie sheet and bake at 350 degrees for 15 - 20 mins. When cool, drizzle with the white icing. Top with grated nuts of your choice. **White Icing:** Combine 1 c. confectioner's sugar and 2 T. rum or lemon juice and drizzle over cake.

### Your Privacy Is Important And Protected at Polish Union

The Board of Directors of the Polish Union of U.S.A. has adopted the following policy regarding the fraternal and its members right to privacy of individual information, we possess for insurance purposes. That policy is printed below for your information. If you have questions regarding this policy, please call the Polish Union Home Office.

### 1. The Purpose Of This Policy Shall Be To:

a. insure the security and confidentiality of customer records and information.

b. protect against any anticipated threats or hazards to the security or integrity of such records,

- c. protect against unauthorized access to or use of such records or information which could result in substantial harm or inconvenience to any customer.
- **2. Persons Bound.** This policy shall be applicable to and adhered to by the Officers, members of the Board of Directors, employees of and all of the Officers of the groups comprising the Polish Union and all of our group secretaries and licensed agents. Further, all of the members of the Polish Union are requested to adhere to the letter in spirit of this pol-
- 3. Information Subject To This Policy. All of the information we have collected or will collect in the future regarding our officers, members of the officers of our groups, group secretaries and our members and their beneficiaries concerning demographic data such as names, addresses, social security numbers, etc., along with information regarding employment, finances, health, avocations and other personal characteristics.
- 4. Declaration Of Confidentiality All of the information collected by Polish Union is hereby declared to be confidential and shall not be disclosed to any individual or other entity without the express written consent of the affected person.

### 5. Exceptions To This Privacy Policy

In the course of our business, we must disclose certain information to other individuals or firms in order to enable them to provide business services to us including our re-issuers, actuarial and data processing services subcontractor. However, our contracts with any of our subcontractors require them to keep confidential any information which may be disclosed to them. In addition, information may be disclosed to our auditors or for research purposes, regulatory agencies such as state insurance departments. In addition, Polish Union will comply with all lawful subpoenas issued by order of any court or regulatory body.

6. Disclosure To Third Parties. Polish Union at present does not disclose any personal informa-tion to other companies or organizations not affiliated with it that would use the information we have provided them to contact your about their own products or services.

- 7. Duration Of Confidentiality. Should you cease to be a member of Polish Union, we will continue to protect and safeguard your personal infor-mation in the same manner as we do with our mem-
- 8. Source Of Information The great bulk of the personal information which Polish Union obtains from its members comes directly from the members particularly in the form of policy applications. This information provides Polish Union with those facts which it needs in order to conduct its business. In many cases, it may need to verify this information or it may need additional information which it may obtain from third parties such as employers, consumer reporting agencies and health
- 9. Use Of This Information Polish Union uses the information gathered from its members and from other third parties in the normal course of our insurance business and our fraternal relationships with its members. The business purpose for collecting this information includes the evaluation of a request for our insurance or other services, and analysis of benefit claims and administration of our products or services in addition to processing transactions and other requests by members. In addition, we will use this information to contact you about services and products which we currently provide or may provide in the he future.
- 10. Safeguarding Of This Information. Polish Union shall take all steps reasonably necessary to safeguard the integrity of the information in its custody including the continued use of our office vault, the use of all reasonable methods of safeguarding information contained in our computerized data system and the control of the office area.

### 11. Adherence To This Policy.

All of the Officers and each member of the Board of Directors, District Directors, employees, officers of groups, group secretaries and licensed agents shall be given a copy of this policy and asked in writing to acknowledge its receipt on an annual basis.

### 12. Sanctions For Violation Of This Policy.

The Board of Directors will investigate all alleged breaches of this policy and will impose sanctions and penalties, on a case by case basis, should a violation of this policy be shown. In addition, the Board of Directors will, in appropriate cases or when required by law or regulation, report all violations to state and federal authorities. Penalties for violation may include dismissal from employment by Polish Union in addition to those sanctions and penalties provided by law

13. Procedure If anyone to whom this policy applies is requested by a third party to divulge any confidential information, the General Secretary must be notified of such requests. The General Secretary shall have the responsibility, in consultation with the Executive Committee, of deciding whether or not to comply with such requests.
