# GLORY TO GOD IN THE HIGHEST AND ON EARTH PEACE TO PEOPLE OF GOOD WILL

My dear Sisters and Brothers in Christ,

For many people, this month is sometimes viewed as burdensome in a variety of ways. For some, it is an attempt to maintain a schedule that is out of the ordinary and, at times, impossible to complete daily tasks. For others, it is a depressing time of the year because of the amount of night time versus daylight. For some, it is more depressing because of the loss of a loved one during 2012 and their presence being missed for the first time in the upcoming holiday season. Still for others, it is a time of distraught because the holiday season will not be realized by commercialism's expectations on people for having the "best" Christmas ever or people's ideal of what Christmas was in the past and how they could make it even better this year only to have the ideal not come to fruition.

But there is the flip side of December that has a real upbeat tone. I enjoy the Season of Advent and this year it envelopes only December rather than invading the month of November – Advent is only 24 days this year! That is a shorter time, however, to get the churches decorated from Advent to the Christmas Season. But the parishioners are great in decorating and they truly make it a parish family event. I am very impressed of how parishioners make an extra effort to support the Advent Giving Trees in my three churches, assisting those who are in need both spiritually and physically. I believe that their support lends to their heartfelt understanding about the event that they are about to celebrate. And after the cards have been sent, the gifts bought and wrapped, the decorating tweaked, the cookies and the once a year foodstuffs have been baked, we come to Christmas Eve! Unlike the rest of the month, Christmas Eve is a reserved day of peace for me. And I gear myself into that mode not only

because of my spiritual preparation for the Masses I am about to celebrate but also placing my mind into focus for the people I am about to encounter.

Primarily, I prepare myself for bringing the peace of Christ to the people who will be participating in Mass – at the Vigil; during the Night; at Dawn; and, during the Day. I am voicing this peace to a variety of individuals – Catholics who participate in Mass, i.e., daily, weekly, occasionally, or only on Christmas and Easter; to Catholics who have no relationship with the Church; to Christians of a variety of denominations; and, to people who do not believe in Jesus.

This same peace that I proclaim is to my friends that I encounter during the Christmas Season. Some I will have the opportunity to visit with after Mass or throughout the week. Seeing them is a sign of our continued relationship that has developed throughout the years and might only be renewed again next Christmas. Peace on Christmas Eve strengthens my friendship with them.

Although my immediate family is far scattered – Wales, Florida, Texas, Ohio, Maryland, Illinois, and Pennsylvania – peace comes to the core of my heart when I hear their voices on the telephone or in their cards on Christmas Day. Several of them I have not seen in over five years but their cards and pictures keep me abreast of their families. Maybe one of these days, I will become more computer savvy and have Skype incorporated into my computer program! But to know that all of them and their families are doing well gives me a sense of peace.

But what is "peace"? The Fathers of the Second Vatican Council guide us in the ways of peace in the *Pastoral Constitution on the Church in the Modern World (Gaudium et spes)*. They teach: "Peace is not merely the absence of war. Nor can it be reduced

solely to the maintenance of a balance of power between enemies. Nor is it brought about by dictatorship. Instead, it is rightly and appropriately called 'an enterprise of justice' (*Isaiah 32:7*). Peace results from that harmony built into human society by its divine Founder, and actualized by people as they thirst after ever greater justice. . . . That earthly peace which arises from love of neighbor symbolizes and results from the peace of Christ who comes forth from God the Father. For by His cross the incarnate Son, the Prince of Peace, reconciled all men with God. By thus restoring the unity of all men in one people and one body, He slew hatred in His own flesh. After being lifted on high by His resurrection, He poured the Spirit of love into the hearts of men. For this reason, all Christians are urgently summoned 'to practice the truth in love' (Ephesians 4:15) and to join with all true peacemakers in pleading for peace and bringing it about" (paragraph 79).

Peace comes about through harmony, justice and love through the truth. My ultimate encounter with this kind of peace on Christmas Eve is in the Prince of Peace, Jesus Christ. Christ became our harmony, justice, and love when He took on our human nature in the Incarnation and fulfilled them in the events of Easter. What a wonderful God we have! And as I sit down to the Vilija meal, I am reminded of the events of salvation history and our heritage, thanking God for the gift of the Prince of Peace.

My prayer for the members of the First Catholic Slovak Ladies Association is that you and your families may have a peace-filled Advent Season only to be culminated by a Christmas Season encapsulated by the Prince of Peace within your hearts and homes!



In 1950 the church building was moved into Munden and placed over a basement which housed a dining/meeting room, kitchen and restrooms.

President Bernie Demechko announced the District Anna S. Granchay Scholarship was won by Jaclyn Hamrock, Branch 169. Since Jaclyn was already at the University of Kentucky for classes, her father accepted the award.

She introduced Agnes Lisko, family representative for the Katherine L. Sedlacko Family Trust Scholarship, which was also won by Jaclyn Hamrock, Branch 169.

Bernie commented on the pride we all have of our students who are pursuing such prestigious careers. She said she was going to forgo the usual "Be proud of your Slovak heritage, your Faith, and the First Catholic Slovak Ladies Association (FCSLA)" and would speak instead on the 120th anniversary of the organization.

In 1892 when Slovak immigrant women were aware that, as widows or unmarried women, they could not purchase insurance with then-established Slovak Men's Fraternal Insurance companies, they decided to be entrepreneurs, be independent, and establish their own society. Anna Hurban and eight other women met at her home and "Around the kitchen table" established the rules for a women's insurance company. The premium would be ten cents a month for coverage of a \$200 policy for death of adult women. The first year they had a total of 95 members and assets of \$212. In 1905, they established a Junior Order with members up to sixteen – premiums were 10 cents a month for a \$100 policy.

By 1925, the FCSLA had 30,000 members and \$27,000,000 in assets. It weathered the influenza outbreak of 1918-19, the Great Depression, and World War II. By 1921 boys were being admitted into the Junior Order and policies were sold to men. Today our membership is 85,000 and we are licensed to sell insurance in 48 states (two pending). Our assets are \$704,000,000 and our surplus \$82,000,000. She pointed out that if you have high expectations and goals and feel you cannot accomplish them, remember the 9 women with no college education, speaking little or no English who took an idea and developed it into the largest Slovak fraternal benefit society in our country. She added that anyone with a college education can reach for the stars – and possibly become a star – in their field of endeavor.




# Chicago Junior Branches Summerfest "Bowling for All Ages"




Artists rendering of the new St. Thomas Á Becket Church.

## GINGERBREAD COOKIES

- 2 cups all-purpose flour (spooned and leveled), plus more for rolling
- 2 teaspoons ground ginger
- 1 teaspoon ground cinnamon
- ½ teaspoon ground nutmeg
- ¼ teaspoon ground cloves
- ¼ teaspoon baking soda
- ¼ teaspoon salt
- ½ cup unsalted butter, room temperature
- ⅓ cup packed dark-brown sugar
- ⅓ cup unsulfured molasses
- 1 large egg

Decorating sugar or sprinkles (optional)

In a medium bowl, whisk together flour, spices, baking soda, and salt; set aside. With an electric mixer, beat butter and brown sugar until smooth. Beat in molasses and egg. With mixer on low, add dry ingredients; mix just until a dough forms. Place dough on floured plastic wrap; pat into an 8-inch square. Wrap well; chill until firm, 1 to 2 hours.

Preheat oven to 350 degrees. Divide dough in half. Working with one half at a time (rewrap and refrigerate other half), place dough on floured parchment or waxed paper; roll out ⅛ inch thick, turning, lifting, and flouring dough (and rolling pin) as needed. Freeze dough (on paper) until firm, about 20 minutes.

Loosen dough from paper. Cut out shapes, and transfer to baking sheets. Decorate with sugar or sprinkles, as desired.

Bake until firm and edges just begin to darken, 10 to 18 minutes, depending on size. Cool completely on baking sheets. Makes 18 cookies.

## ALMOND & APRICOT THUMBPRINT COOKIES

- 1½ cups all-purpose flour
- ½ teaspoon baking soda
- ½ teaspoon baking powder
- ½ teaspoon coarse salt

- ¾ cup smooth almond butter
- ½ cup unsalted butter, room temperature
- ½ cup packed light-brown sugar
- 1 large egg
- 1 teaspoon pure vanilla extract
- ⅓ cup granulated sugar, for rolling
- ½ cup apricot jam

Preheat oven to 350 degrees, with racks in upper and lower thirds. In a medium bowl, whisk together flour, baking soda, baking powder, and salt. In a large bowl, using an electric mixer, beat almond butter and butter on medium until smooth. Add brown sugar and beat until fluffy, about 3 minutes. Add egg and vanilla and beat until combined. With mixer on low, gradually add flour mixture and beat just until combined (dough will be slightly crumbly).

Place granulated sugar in a small bowl. Roll level tablespoonfuls of dough into balls and gently roll in sugar to coat. Place on two parchment-lined rimmed baking sheets, 1½ inches apart. Bake until cookies are puffed, 8 minutes. Remove sheets from oven and, with the bottom of a round ½ teaspoon measuring spoon, make an indentation in center of each cookie. Bake until set, 5 to 7 minutes. Let cookies cool on wire racks, 20 minutes. Stir jam and spoon ½ teaspoon into each indentation. Makes 30 cookies.

## EGGNOG CHEESECAKE BARS

- Vegetable oil cooking spray, for pan
- 12 graham crackers, finely ground (1½ cups)
- ¾ cup plus 3 tablespoons sugar
- 2 ounces (4 tablespoons) unsalted butter, melted
- 1 lb. cream cheese, room temperature
- 2 large eggs
- 1 large egg yolk
- ¾ cup eggnog
- 1 tablespoon plus 1½ teaspoons flour
- 1 tablespoon plus 1 teaspoon brandy
- 1 teaspoon pure vanilla extract
- ½ teaspoon freshly grated nutmeg, plus more for dusting
- ¼ teaspoon salt

Preheat oven to 350 degrees. Coat a 9-inch square baking pan with cooking spray. Stir together graham crackers, 3 tablespoons sugar, and the melted butter. Press into bottom of pan. Bake until crust is just brown around the edges, 12 to 15 minutes. Let cool.

Meanwhile, beat cream cheese with a mixer on medium speed until fluffy, about 2 minutes. Add the remaining ¾ cup sugar, the eggs, yolk, eggnog, flour, brandy, vanilla, nutmeg, and salt; beat until smooth. Pour filling over crust. Set pan in a roasting pan, and add enough hot water to come halfway up sides of baking pan.

Bake until just set, 40 to 45 minutes. Remove baking pan from water bath, and transfer to a wire rack. Let cool slightly, about 30 minutes. Refrigerate for at least 3 hours or overnight.

Cut into 1½-by-3-inch bars. Lightly dust tops of bars with freshly grated nutmeg just before serving. Makes 18 bars.

## OUTRAGEOUS CHOCOLATE COOKIES

- 8 ounces semisweet chocolate, roughly chopped
- 4 tablespoons unsalted butter
- ⅔ cup all-purpose flour
- ½ teaspoon baking powder
- ½ teaspoon salt
- 2 large eggs
- ¾ cup packed light-brown sugar
- 1 teaspoon pure vanilla extract
- 1 package (12 ounces) semisweet chocolate chunks

Preheat the oven to 350 degrees. Heat chopped chocolate and butter in a microwave-safe bowl in 20-second increments, stirring between each, until almost melted; do not overheat. In another bowl, whisk together flour, baking powder, and salt.

In a mixing bowl, beat eggs, brown sugar, and vanilla on high speed until light and fluffy. Reduce speed to low; beat in melted chocolate. Mix in flour mixture until just combined. Stir in chocolate chunks.

Drop heaping tablespoons of dough 2 to 3 inches apart onto baking sheets. Bake, rotating sheets halfway through, until cookies are shiny and crackly yet soft in centers, 12 to 15 minutes. Cool on baking sheets 10 minutes; transfer to a wire rack to cool completely. Makes 2 dozen.

## HAZELNUT MERINGUES

- 1¼ cups blanched hazelnuts, toasted
- 2 large egg whites, room temperature
- 1 cup confectioners' sugar
- Coarse salt

Preheat oven to 350 degrees, with racks in upper and lower thirds. In a food processor, pulse hazelnuts until finely ground. In a medium heatproof bowl, combine egg whites, sugar, and pinch of salt. Set bowl over (not in) a pot with 2 inches simmering water and cook, whisking constantly, until warm to the touch, about 3 minutes. Remove bowl from heat and, using an electric mixer, beat mixture on high until thick and glossy, 3 minutes. With a rubber spatula, fold in hazelnuts.

Drop batter by heaping tablespoonfuls, 2 inches apart, onto two parchment-lined baking sheets. Bake until cracked on top, about 18 minutes, rotating sheets halfway through. Let meringues cool to room temperature. Makes 24.
