A FIFTY YEAR HISTORY: VATICAN COUNCIL II DECLARATION ON RELIGIOUS FREEDOM (*Dignitatis Humanae*)

My dear Sisters and Brothers in Christ,

In the summer of 1973, my family embarked on our first trip to the Slovak Republic then known as Czechoslovakia. The purpose of our trip was to visit the relatives of my maternal great aunt and uncle. They had not seen their family since they left the country in the early 1930's and it was their desire to meet with them as they kept in touch with one another religiously throughout the years. For me, I would be introduced to relatives that I did not know existed, on both sides of my maternal grandmother and grandfather. (To this day, I have not investigated the grandparents on my father's side of the family that were located in the region that was known as Šariš. Maybe that will be an excuse for a future trip!) It was a month's endeavor and truly a learning experience for me since it was a different way of life (farming) and a foreign form of government of a country (communism). Farming in Slovakia compared to that of the United States was primitive – not many mechanical farming vehicles and much still done by manual labor. The people worked many, long hours in the fields and often the men labored in factories in the cities, while women and children worked the farms.

My encounter with communism was a little frightening. My great aunt and uncle who were Canadian citizens entered the country with no trouble. This takes into account that they were bringing in all kinds of gifts for the relatives plus Bibles, Lectionaries and Mass Missals (given to them by Slovak Jesuit priests in Galt, Ontario) to be presented to their counterparts in Slovakia. But when it came to my parents and me, we were bodily searched and all of our suitcases were emptied to investigate the contents. All of us were ordered to notify the officials of the city or village that we were visiting to report the length of our stay and the reason for our visit. We were neither to talk about the politics of either country nor speak of anything concerning religion.

I became familiar with a priest during my visit, Father Vojtech Jenčík, who like many other priests and religious suffered

persecutions by the communists. Father Jenčík had a doctorate in theology and as we became friends, he took me to various churches, among them Sväta Alžbeta Katedrál in Košice. Like many of the closed churches and religious buildings it had a plaque on it that read “Kultúrna národná pamiatka”, i.e., “Cultural heritage monument”. Fortunately, he knew someone who let us in and needless to say I was impressed. But during my excursion, I experienced how being a person of Faith under that form of government was trying, to the point of persecution and even death.

Before ascending to the right hand of God the Father, Jesus gave His final command to the Apostles. This command is particularly noted at the end of the *Gospel of Matthew* and the *Gospel of Mark*: “Then Jesus approached and said to them, ‘All power in heaven and on earth has been given to me. Go, therefore, and make disciples of all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Spirit, teaching them to observe all that I have commanded you. And behold, I am with you always, until the end of the age’” (*Matthew* 28:18-20); and, “He said to them, ‘Go into the whole world and proclaim the gospel to every creature. Whoever believes and is baptized will be saved; whoever does not believe will be condemned’” (*Mark* 16:15-16). Christ entrusted to the Church through the Apostles to go throughout the world preaching the Good News of Jesus Christ. And we know that the Apostles and the members of the early Church did this, even to the point of martyrdom.

One of the four documents of the Second Vatican Council that was promulgated on 7 December 1965, the day prior to the solemn closing of the Council, was the Declaration on Religious Freedom known in Latin as *Dignitatis Humanae*. The document teaches us about religious freedom in three distinct areas.

*Each person has the freedom to practice their Faith. “It is in accordance with their dignity as persons – that is, beings endowed with reason and free will

and therefore privileged to bear personal responsibility – that all men should be at once impelled by nature and also bound by a moral obligation to seek the truth, especially religious truth. They are also bound to adhere to the truth, once it is known, and to order their whole lives in accord with the demands of truth” [Paragraph 2]. Not only is it an individual freedom but also a communal freedom as well. “However, the social nature of man itself requires that he should give external expression of his internal acts of religion; that he should participate with others in matters religious; that he should profess his religion in community” [Paragraph 3].

*People should practice their Faith without interference of government and be protected by the laws of government. “Government is also to help create conditions favorable to the fostering of religious life, in order that the people may be truly enabled to exercise their religious rights and to fulfill their religious duties, and also in order that society itself may profit by the moral qualities of justice and peace which have their origin in men's faithfulness to God and His holy will” [Paragraph 6].

*The Church has the freedom to proclaim the Good News. “Among the things which concern the good of the Church and indeed the welfare of society here on earth – things therefore which are always and everywhere to be kept secure and defended against all injury – this certainly is pre-eminent, namely, that the Church should enjoy that full measure of freedom which her care for the salvation of men requires...The freedom of the Church is the fundamental principle in what concerns the relations between the Church and governments and the whole civil order” [Paragraph 13].

The need for religious freedom espoused by the Fathers of the Council was not only written with Catholicism in mind but for all religions. Yet we know that religious persecution is still alive in our world. Let us pray that people will not use religion for matters of injustice and war but for justice and peace!

Clark Case Brings New Rules for Inherited IRAs

In recent years, IRA accounts have grown larger and larger. The practice of rolling 401K funds into IRA accounts has contributed to this growth. Passing IRA funds to future generations has become a popular strategy of estate planners. IRAs have generally been protected from creditors by the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005. (BAPCA)

However, a recent U.S. Supreme Court Case (Clark v. Rameker) has changed some of the protection offered by IRAs against creditors and has raised other questions for estate planners. Following are the facts of the Clark case, how the case proceeded to the Supreme Court, the decision, and how it will affect inherited IRAs in the future.

Ruth Heffron established an IRA in the year 2,000. Ruth died in 2001. Her daughter, Heidi, was named as sole beneficiary. In 2010, Heidi and her husband filed for bankruptcy and as part of the bankruptcy, they sought to exempt the IRA assets, worth approximately \$300,000, from creditors. Heidi's argument was that the IRA should be exempt. The Bankruptcy Court disagreed and said that an inherited IRA is not exempt. However, the District Court reversed that decision, holding that the exemption covers any account in which the funds were originally accumulated for retirement purposes. The case then went to the Appeals Court.

The 7th Circuit Court of Appeals reversed the District Court decision and held that an inherited IRA is not "retirement funds" under the bankruptcy code. The case proceeded

to the U.S. Supreme Court to resolve a conflict between the 7th Circuit Court and the 5th Circuit Court's decision in "In re Chilton, 674 F.3d 486 (5th Cir. 2012).

The U.S. Supreme Court in a unanimous decision found that funds in an inherited IRA are not considered "retirement funds" and thus, are not exempt from the debtor's bankruptcy estate. The result is that a debtor's bankruptcy trustee may consider the inherited IRA to be an asset of the bankruptcy estate, and thus, is available to satisfy creditor's claims.

The case has opened up the question as to whether a spouse is better off "rolling" the proceeds of his/her spouse's IRA at his/her death into his/her own IRA or simply inheriting the proceeds by the beneficiary designation. According to the Wilson Law Group, one of the leading estate planning firms in Wisconsin, "rollovers seem to provide better protection for a spouse because the spousal inherited IRA may not be protected." In addition, the firm's opinion is that Heidi would have been protected had a "stand alone retirement trust" been named as beneficiary for Heidi's benefit.

With IRA accounts reaching much larger amounts today, especially with 401K rollovers, planning is certainly appropriate. It is always advisable to contact an estate planning attorney, familiar with the laws in your state on legal matters which accompany estate planning! This article is meant to inform our members with IRAs of the Clark decision and how it might affect an inherited IRA.

St. Louis Branches Honors U.S. Army Captain Fr. Emil Kapaun

The FCSLA "MOTTO – 'For God & Nation'" precisely describes Medal of Honor Awardee, U.S. Army Capt. Fr. Emil Kapaun - A Catholic Priest serving his God and his country as a Military Chaplain; he is a member of the heritage and culture of our SLAVIC nation!

Fr. Emil Joseph Kapaun (April 20, 1916-May 23, 1951) was a Roman Catholic priest and United States Army Chaplain who died as a prisoner of war in the Korean Conflict. Because of his wartime activities, the Roman Catholic Church has declared him a Servant of God, the first stage on the path to sainthood, and on April 11, 2013, President Barack Obama awarded the Medal of Honor posthumously to Captain Kapaun. Fr. Kapaun was ordained in 1940 at the Kenrick-Glennon Seminary in St. Louis.

It is with thanks that we acknowledge the gracious cooperation afforded the St. Louis Branches (S101 and J11) of the FCSLA by Fr. John Horn, S.J., the President-Rector; Fr. David Skillman, Vice-Rector; Reverend Kristian C. Teater, STL Dean of Students and with Ms. Kate Guyol



the Development Director of Kenrick-Glennon Seminary. Ms. Guyol provided their authorization to the FCSLA to 'secure' the Medal of Honor, from the U.S. Army, so as to be honorably displayed in the Seminary's Campus Student Union named in Fr. Kapaun's honor.

The Branches contracted with a professional carpenter who crafted, and secured, a locked showcase that holds the Medal of Honor in accordance with the strict mandatory specifications directed by the U.S. Army.

Captain Fr. Emil Kapaun, the seventh chaplain to earn the military's premier award for valor.

After the Game Recipes

CHICKEN LETTUCE WRAPS

- 1 tablespoon olive oil
- 1 pound ground chicken
- 2 cloves garlic, minced
- 1 onion, diced
- ¼ cup hoisin sauce
- 2 tablespoons soy sauce
- 1 tablespoon rice wine vinegar
- 1 tablespoons freshly grated ginger
- 1 teaspoon Sriracha, or more, to taste
- 1 (8-ounce) can whole water chestnuts, drained and diced
- 2 green onions, thinly sliced
- Salt and freshly ground black pepper, to taste
- 1 head butter lettuce

Heat olive oil in a saucepan over medium high heat. Add ground chicken and cook until browned, about 3-5 minutes, making sure to crumble the chicken as it cooks; drain excess fat.

Stir in garlic, onion, hoisin sauce, soy sauce, rice wine vinegar, ginger and Sriracha until onions have become translucent, about 1-2 minutes. Stir in chestnuts and green onions until tender, about 1-2 minutes; season with salt and pepper, to taste.

To serve, spoon several tablespoons of the chicken mixture into the center of a lettuce leaf, taco-style.

CHEESY APPETIZER LOAF

- 1 pkg. (8 oz.) Shredded Italian Five Cheese
- 3 tablespoons Mayonnaise
- 2 tablespoons chopped stuffed green olives
- ½ teaspoon garlic powder
- 1 French bread baguette (24 inch), cut lengthwise in half
- Paprika

Heat broiler. Combine first 4 ingredients; spread onto cut sides of bread.

Sprinkle lightly with paprika.

Broil, 6 inches from heat, 1 minute or until cheese is melted. Serve warm.

HAM AND BROCCOLI CHEESE POT PIE

- 1 bag (12 oz) frozen broccoli cuts, thawed, drained
- 2 cups cut-up cooked ham
- 2 cans (10¾ oz. each) condensed Cheddar cheese soup
- ¼ cup milk
- 2 cups Original Bisquick® mix
- 1 cup milk
- 2 tablespoons yellow mustard
- 2 eggs

Heat oven to 400°F. In ungreased 13x9-inch (3-quart) glass baking dish, mix broccoli, ham, soup and ¼ cup milk.

In medium bowl, stir remaining ingredients until blended. Pour over ham mixture.

Bake uncovered about 35 minutes or until crust is golden brown.

SLOW-COOKER SMOKED SAUSAGE AND BEAN SOUP

- 1 lb. small red potatoes, each cut into 8 pieces (about 3 cups)
- 4 medium carrots, sliced (2 cups)
- 1 medium onion, chopped (½ cup)
- 1 medium stalk celery, sliced (½ cup)
- 2 cans (15 oz. each) cannellini beans, drained, rinsed
- 4 cups (32 oz.) chicken broth
- 1 teaspoon dried thyme leaves
- ½ teaspoon seasoned salt
- 1 lb. fully cooked kielbasa sausage, cut in half lengthwise, then into ¼-inch slices
- 2 tablespoons chopped fresh parsley

Spray 3- to 4-quart slow cooker with cooking spray. In cooker, mix all ingredients except sausage and parsley.

Cover; cook on Low heat setting 8 to 9 hours.

Stir in sausage and parsley. Cover; cook on Low heat setting 30 minutes longer or until sausage is hot.

APPLE CHIPS WITH SALTED CARAMEL YOGURT DIP

- 1 large Granny Smith apple
- 1 tablespoon fat-free caramel topping
- ¼ teaspoon coarse sea salt
- 1 container (6 oz.) Apple Crisp yogurt
- 2 tablespoons chopped walnuts

Heat oven to 275°F. Line cookie sheet with cooking parchment paper.

Using sharp knife, cut apple into very thin slices (about ⅛ inch). Place on cookie sheet.

Bake 30 minutes; quickly turn slices. Bake 30 to 40 minutes longer or until golden brown and crispy. Cool on cookie sheet (apples will continue to crisp up).

Meanwhile, in small microwavable bowl, microwave caramel topping uncovered on High 30 seconds. Stir in salt. Place yogurt in small bowl, and drizzle with salted caramel. Top with chopped walnuts. Serve dip with apple chips.

PRALINE PUMPKIN DESSERT

- 1 can (15 oz.) pumpkin (not pumpkin pie mix)
- 1 can (12 oz.) evaporated milk
- 3 eggs
- 1 cup sugar
- 4 teaspoons pumpkin pie spice
- 1 box Spice cake mix
- 1½ cups chopped pecans
- ¾ cup butter or margarine, melted
- Whipped cream, if desired
- Additional pumpkin pie spice, if desired

Heat oven to 350°F (325°F for dark or nonstick pan). Grease or spray bottom and sides of 13x9-inch pan. In medium bowl, beat pumpkin, milk, eggs, sugar and 4 teaspoons pumpkin pie spice with wire whisk until smooth. Pour into pan.

Sprinkle dry cake mix over pumpkin mixture. Sprinkle with pecans. Pour melted butter evenly over top.

Bake 50 to 60 minutes or until knife inserted in center comes out clean. Cool 30 minutes.

To serve, cut dessert into 4 rows by 3 rows. Serve warm or chilled with dollop of whipped cream sprinkled with pumpkin pie spice. Store covered in refrigerator.

APPLE PIE OATMEAL DESSERT

- 1 cup quick-cooking oats
- ½ cup all-purpose flour
- ⅓ cup packed brown sugar
- 2 teaspoons baking powder
- 1½ teaspoons apple pie spice
- ¼ teaspoon salt
- 3 eggs
- 1⅔ cups 2% milk, divided
- 1½ teaspoons vanilla extract
- 3 medium apples, peeled and finely chopped
- Vanilla ice cream, optional

In a large bowl, whisk oats, flour, brown sugar, baking powder, pie spice and salt. In a small bowl, whisk eggs, 1 cup milk and vanilla until blended. Add to oat mixture, stirring just until moistened. Fold in apples.

Transfer to a greased 3-qt. slow cooker. Cook, covered, on low 4-5 hours or until apples are tender and top is set.

Stir in remaining milk. Serve warm or cold with ice cream if desired. Yield: 6 servings.
