



#### **BOARD OF DIRECTORS VERIFICATION PROCESS**

According to our Constitution and Bylaws presented and approved at the Special Convention held October 6-8, 2014; individuals must submit resumes containing a listing of qualifications for the office being sought, along with a completed FCSLA Intent Form obtained from our National Secretary and returned by August 2, 2015 to our National President.

The verification process was approved by the Board of Directors at its quarterly meeting held at the Home Office on March 19-20, 2015 as follows:

An outside contracted company whose home office is based in Cleveland, Ohio, will verify education, employment data and work experience.

The Credential Committee, made up of appointed delegates, will review the resumes, fraternal qualifications and verification reports for the individuals who have submitted letters of intent, to determine if the individuals meet the qualifications as set forth in the Bylaws.

The Credential Committee will be made up of delegates who are not seeking National Office.

#### **BISHOP ALFRED NOVAK, W018**



Bishop Alfred (Alfredo) Ernest Novak, C.Ss.R, of the Diocese of Paranaguá died December 3, 2014. He was 84 years old. Originally from Assumption Parish in Dwight, Bishop Novak was the youngest child born to local banker Frank Y. Novak and his wife, Mary. Of the six Novak children, four went into religious life. Alfred was ordained a priest in 1956. Each of the priest-brothers was called to a different mission. Alfred was sent to Brazil, where he

ministered to native people along the Amazon River, traveling by boat to reach the remote communities. In 1979, Pope Saint John Paul II named Father Alfredo titular bishop of Vardimissa and auxiliary bishop of São Paulo. Ten years later, he was made the second bishop of Paranaguá. Fittingly, Bishop Novak took the motto, "Evangelizare misit Me," which means, "He has sent me to proclaim the Good News." Understanding the importance of raising children in the faith, Bishop Novak – locally known as Dom Alfredo - established a Catholic school in his diocese. He also worked to have the chapel of Our Lady of Rocio established as a shrine, as there is a great devotion to Our Lady of Rocio in Brazil. Dom Alfredo remained devoted to the poorest of the poor, finding creative and practical ways to help each person or family. Until Bishop Novak was made bishop of Paranaguá, the entire region was served by missionary priests. He began raising up diocesan priests out of the local population. These priests and many seminarians were part of the Masses celebrated for Dom Alfredo's soul in the seven days following his death. Bishop Novak served his diocese for 17 years before Pope Benedict XVI accepted his retirement in 2006. He returned to the states several more times for home visits, and once for a specialized cardiac operation, but he never stopped serving the Brazilian people. As is customary, Bishop Novak was buried at the Cathedral of Our Lady of the Rosary in Paranaguá.

Hermine Polesnak Muellerleile, 90, died peacefully on December 13, 2014. She was born in Browndale, PA, on January 4th, 1924, daughter of the late Vincent and Anna Kalny Polesnak. ## Remembering My Grandmother

(Helen Javurek, former S292 President for over 50 years, passed away December 16, 2014. What follows is a very touching article written by her granddaughter Shelley Cormack. As I read Shelley's article I could not help but remember my maternal and paternal grandparents who also entered the USA through Ellis Island for a better life. I imagine you too will find your own memories as you read Shelley's touching remembrance.) Her obituary appears on page 9.

Opening the junk drawer in my kitchen is like opening a tool box. I spy a tape measure, masking tape, a pocket knife, and a Ziploc baggie of salvaged rubber bands. My eyes linger on the baggie. Suddenly opening the junk drawer becomes like traveling in a time machine to the past, bringing memories of growing up close to my grandmother.

Grandma is now 100 and lives in an assisted living home, but for forty-eight years of my life she lived on Hillgrove Avenue in Cleveland. Seeing my bag of rubber bands takes me back to her kitchen where she kept a bag of rubber bands in a drawer with fresh dish towels. I can smell the clean scent of Amway soap that escaped whenever the drawer was opened. My bag of rubber bands brings memories of painted blue metal cupboards, the mouth-watering aroma of simmering chicken paprikas, the warmth of her kitchen, and a floor so clean I would tease her that I could eat from it.

My junk drawer rubber bands remind me of lessons she taught about not being wasteful. Bubba, as we called her, grew up in extreme poverty in Czechoslovakia. She'll tell how at 18 years old she immigrated through Ellis Island, arriving in November of 1933 without a coat and unable to speak English. You feel her emotion when she recalls how she shared a bed with her grown brother, his head at her feet and her head at his, while her husband worked nights — too poor to afford their own place. Bubba lived through the Great Depression and World War II when sacrifice and doing without was just the way you lived. She lived frugally her whole life, saving everything that could be reused: wrapping paper, plastic bags, shoe-laces, twisty-ties, and rubberbands. Why spend money on such things when salvaged ones worked fine? Save your money.

From my grandmother I learned the lesson of frugality: waste not, want not. So now I keep my own stash of used rubber bands in a baggie in a kitchen drawer. On a shrinking planet with limited resources, I have an extension to add to her lesson for my children — that of preserving the earth by reducing the amount of trash contributed to the landfill. In modem terms — reducing my carbon footprint. Reduce. Re-use. Recycle. Live simply. Because of my grandmother I reuse glass jars with the labels carefully cleaned off and replaced with one's hand written on masking tape. Clothing too worn to pass on gets cut up for rags and the buttons saved in one of those jars. Have you bought buttons recently? Save your money. Like the rubber bands, I have buttons for any conceivable need.

My junk drawer toolbox is a metaphor for the toolbox of things I've learned from my grandmother about living simply. Bubba's life of poverty gradually disappeared. In later years she lived frugally and simply out of habit, not necessity. I try to live so out of conscious choice. Meditating on a baggie of salvaged rubber bands, I realize how many frugal luxuries I enjoy. It has led me to a deeper understanding of the idea that all I have is all I need. I read somewhere that living simply out of necessity is poverty but living simply out of choice is wealth. I am very wealthy indeed.

- · Special National Convention. #### Strategic Plan

We strive to reach the major goals and objectives set forth in our Strategic Plan and consistent with our Mission, Vision, and strategic direction, building on the foundation of our Catholic faith and Slavic traditions, maintaining profitability, striving to grow and conserve membership, and identifying and maintaining the infrastructure to support our mission.

During 2014, despite ongoing challenges in the national marketplace, we have been able to increase the overall amount of insurance in force to over \$1,043,000, our overall asset base to over \$781,500,000, and to realize a net income of over \$4,100,000, after declaring a bonus dividend for the 2015 quadrennial convention year. Our surplus has grown to over \$92,800,000 due to longstanding efforts of former and current officers and leaders over many years. I encourage you to read the annual report of the National Treasurer Steve Hudak for a detailed report. We are proud that our sales are a diverse mix of both insurance and annuity products, totaling over \$33,000,000 in premiums for the year. We continue to build our producer distribution network across the United States, where we are licensed to do business in 48 states and the District of Columbia. FCSLA is well positioned for sustained growth, and we have maintained our excellent rating (A-) rating with A.M. Best.

We continue to provide generous branch stipends for our branches to remain active for our members and for many communities where our members live. Our National Fraternal and Youth Director Kelly Shedlock organized 3 new branches in 2014. We heightened our presence in several key communities by conducting a number of outreach efforts at ethnic, church and community events in various parts of the United States. Our Matching Funds Program continues to be a great success where our branches held 120 events with local charitable organizations, raising over \$322,590.76 to support these causes in 2014. Our branches report several hundred thousand volunteer hours to the home office each year.

#### A GIANT LEAP FORWARD

On October 5-8th, 2014, I convened a Special Convention of delegates elected from our branches and national officers to hear the recommendations of the Bylaws Revision Committee for a total revision of our bylaws. They concisely lay our positive standards for qualifications for leadership within our ranks.

We also achieved another first for our society when delegates at the special convention were able to cast their vote via electronic voting.

#### **Quadrennial Convention Bonuses**

In anticipation of our 2015 Quadrennial Convention to be held in Louisville, Kentucky, from October 5-8th, 2015, our board of directors approved two special initiatives! First, we are promoting our current FCSLA Guaranteed Issue Life Insurance Program, from November 1, 2014 through April 30, 2015, where we offer current members in eligible states this reasonable cost, quality life insurance product where a member cannot be turned down for any medical reason. Second, our board of directors has declared a bonus dividend on every eligible insurance product in 2015 for a total amount of over \$2,600,000. I am honored to serve as presiding officer for our board, a dedicated group of individuals with diverse backgrounds committed to furthering the lofty mission of our association.

#### 2014 National President's Appeal

In 2014, we were pleased to present our second national drive for a unified cause: "To Protect the Children", dedicated to our newly canonized Popes Saint John XXIII and Saint John Paul II. Again, our branches, districts and individuals donated \$48,970.00 to local agencies dedicated to serve at risk children, especially those which serve those in fractured families or those grieving a loss of a loved one, adoption agencies or groups supporting the pro-life cause.

Our Association is licensed to do business in 48 states and the District of Columbia. In 2014 we were approved to do business in California. When approval is given there are many more internal operations that need to be put in place before we can start writing and recruiting. Our staff is working on these items. Every state has different licensing requirements. Our Association requires all of our contracted agents and licensed recommenders to follow the licensing requirements of their state. It is very important to make sure an individual knows the fraternal exemption for their state. Many states have changed their Fraternal Exemption and/or licensing requirements. FCSLA is very proud of our compliance record. We offer our branch officers the opportunity to obtain their producer's license. If a member is interested in selling in their state or any of the states where we are licensed to do business, we encourage them to contact the Home Office for information in obtaining their producer's license.

#### Website

We are continuously updating our website www.fcsla.org. Our Association's website appears on many search engines. A monthly report is from our website administrator, Dynamics Online, Inc. This report lists the areas on our website and which departments are being hit on the most. (Every time an individual clicks on a specific icon on our website it is recorded.) The report also lists how many visitors or members used our website in 2014. By using our website, members or potential members gain information about



our Association and updates on the many products we sell. We also list the benefits our members are offered. Branch officers and members can print forms they need that are listed on our website. Several districts share information on our website and their activities planned. We've searched and have had many interviews to find an individual to fill our Promotions and Communications Coordinator position but just haven't found that individual by the end of 2014. I have made it a priority for 2015. This individual oversees our website, therefore, until this position is filled, our Fraternal and Youth Director, Kelly Shedlock, and our Programs Manager, Paula Dalpiaz are assisting with updating our website with new information and branch activities. Our website shares the many activities our branches are sponsoring and also some reports on projects completed. FCSLA is proud of keeping our members informed and opening lines of communication.

#### Loans

When members consider surrendering their legal reserve certificates, the Conservation Department reminds the member that they may be eligible for a loan. We calculate the rate of interest charged against a loan in accordance with the insured's contract. Different contract plans have different loan rates of interest, the range being 4% to 8%.

#### **Executive Committee Meetings**

National President Cynthia M. Maleski called four quarterly scheduled Executive Committee meetings in 2014. The executive committee members met in the months prior to the months when the Board of Directors scheduled a meeting. The committee members research, examine, and discuss varied topics to prepare recommendations to the Board of Directors at their quarterly meetings.

#### 2014 Computer Enhancements

In 2014, we worked on completing the updating all of our computers to Windows 7 and Office 10. Our Programs Manager, Paula Dalpiaz and Programmer Jim Deak continue to efficiently keep us on track in all of our software updates.

In 2014, we relied on using "Constant Contact", (a mass emailing service) to communicate in a timely manner to all contracted agents and licensed recommenders when new information needed to be shared. We rely on this line of communication using email addresses to reach a significant number of individuals all at one time. We also used this system to email our magazine to those who signed up for this benefit. We thank Marie Golias, our National President's Administrative Assistant for completing this task.

During 2014, monthly meetings were scheduled with the managing officers and all individuals involved with IT to keep FCSLA on schedule for many of the projects involving our software or hardware. Technology is constantly changing and requires us to make decisions for all departments using IT functions on a daily basis.

#### **Branches**

Our Home Office has a Branch Management Department which assists our Branch Officers in branch operations. Our staff is available to explain the duties that are necessary for a branch to run smoothly and efficiently. Our staff at the home office recommends direct billing for branches. <u>Direct Billing is a Branch decision</u> and there is no cost to the Branch for this service. Please

notify the Home Office if you wish to take advantage of this service. Having direct billing gives the Branch Officers more time and opportunities to fulfill their fraternal obligations. Of our 407 active Junior/Senior Branches 286 branches are on direct billing as of December 31, 2014.

It is recommended that Branch Officers review and share the **Branch Officers Management Guide** and the monthly **Branch Newsletter** with their officers and members. Both the guidebook and newsletter have a wealth of information to enhance the efficient operation of a branch while updating operations and procedures on a regular basis.

The Branch Leadership Committee (newly renamed) continued visiting several districts for leadership training in 2014. These sessions prove to be an awesome way to share current information. I had the wonderful opportunity of being involved in three leadership seminars in the following districts: #3 Pittsburgh, PA with our Fraternal and Youth Director, Kelly Shedlock; #9 Milwaukee, WI with our National President Cynthia M. Maleski and #13 Yankton, SD with our National Auditor Barbara Sekerak also Chair of the Branch Leadership Committee. All three districts under the leadership of their District Presidents were instrumental in planning these sessions. We made sure they knew how their cooperation and communication made our job much easier.

In 2014 we made every effort to canvas branch members when branch officers were retiring. A revised letter was sent to members who live in the branch's home city. We did not close any branches in 2014. A few branches were put on direct billing and labeled FCSLA until they elected new officers. We did not merge any branches and also branch members holding until their new branch was opened were then transferred.

In 2014, the following new branches were established:

S-631 in Fremont, NE

S-638 and J-535 in Springville, NY

We are very excited to see FCSLA grow in areas where we did not have an existing branch. I would like to congratulate the new branch officers, agents who assisted in these areas, and our Fraternal & Youth Director, Kelly Shedlock for all of her time and effort. Let us continue to spread our fraternal message along with our new Mission and Vision.

#### **Branch Bonus - Dividends - Benefits**

I am proud to share with you that in 2014, the FCSLA Senior and Junior Branch Bonuses amounted to \$820,954.00. The bonus is calculated on three criteria: 1) a base amount of \$25.00, 2) \$8.50 per certificate in your branch 3) \$30.00 per each new member acquired during the year of 2013. We continuously remind the branches how and for what reasons this branch compensation should be used. It is not meant to be kept in their bank accounts to gain interest. The funds should be used to sponsor charitable and benevolent causes, assist branch members in time of need, make donations to church, school and community activities, pay operating expenses and branch officer's salaries. When branch activities are planned you uphold our Mission and Vision.

#### **Dividends**

A dividend of 50% of the base was allocated for 2014. Through December, dividends totaled \$1,340,378.00 and were issued in the following manner:

\$ 63,631.00 — Junior and Senior Checks

\$ 158,131.00 — Accumulated Interest



\$ 147,062.00 — Accumulated Current Dividends

11,956.00 — Dividends used to reduce Premium

3,070.00 — Dividends used to reduce loan balance

\$1,079,401.00 — Jr. and Sr. Dividends were used to purchase almost \$3.94 million of additional paid-up insurance.

We encourage branches to take advantage of our Home Office with assistance in mailing the members' annual dividend. If the branch officers request this assistance, \$2.00 per certificate will be deducted from the branch's annual bonus to cover the expenses of this service.

#### A.M. Best Review

Your managing officers prepare a business report every year for our FCSLA interview with the A.M. Best analysts.

We are pleased and proud that the FCSLA has maintained an A- (excellent) rating for 2014 from A.M. Best.

#### **Districts**

FCSLA has 15 out of 16 active districts. Districts have an important role in our fraternal benefit branch system. They offer support and service to branches in their area. The combined sales of our Districts through December 2014 totaled \$9,443,994.00.

Districts receive a stipend for promoting sales in their areas. They receive \$1.00 for each \$1,000 of insurance sold and an additional bonus of \$1,000 if its quota is reached. Districts not reaching their quota receive a pro-rated amount.

#### Recommenders / Agents

FCSLA relies on its recommenders and agents to enroll new members, assist members with their life insurance and/or annuity needs, and actively participate in branch sponsored events. The agents have provided 57% of our life business, licensed recommenders 22% and recommenders 21%. We appreciate their promoting the sale of our products. Commissions paid to recommenders/agents on Life Certificates as of 12/31/14 totaled \$270,887.00. Annuities represent a very productive part of business for FCSLA. Commissions paid to recommenders/agents on annuity accounts as of 12/31/14 totaled \$644,969.00. These two amounts of commission paid total \$915,856.00 as seen in our Financial Report.

#### Sales Manager

Mr. Patrick Braun, our National Sales Manager, along with our two Regional Sales Managers, Al Heiles and Bill Hollander continue to contract new independent agents. They have been concentrating in states where we do not have a strong presence of contracted agents. These three managers also train, teach and communicate with the agents, licensed recommenders, district officers and branch officers. They scheduled many seminars and training sessions in 2014 which include current compliance mandates. As of 12/31/14 we have 792 contracted independent agents and 46 licensed recommenders.

#### Fraternal Outreach

Our Association continues to be well respected among the top fraternal benefit societies. We pride ourselves in spreading the good news about the Fraternal Benefit System. Our branch members on all levels are encouraged to reach out to our churches,

community and individual members. Many of us are very proud of our Catholic faith and Slavic background. Many of our branch activities are evidence of supporting these ideals.

Join Hands Day - JHD is a national day of service on the first Saturday in May each year. This day is devoted to bringing adults and young people together to make a difference in their community. Many FCSLA Branches and Districts participated in 2014 Join Hands Day Projects of volunteerism sponsored by the American Fraternal Alliance. It is very important to report these JHD events to our Fraternal and Youth Director.

Pro-life March — Life is a gift from God. We witness this awesome gift every time a new baby is born. This year we unfortunately had to cancel the bus trip due to weather. We had many disappointed individuals including myself but the risk we would have been taking with everyone's life wasn't worth it. Instead we planned a prayer service at the Home Office which was led by Rev. Gerard Gonda, President of Benedictine High School. Several of the Benedictine High School Students along with your managing officers, our former National President Mary Ann Johanek and National President of the First Catholic Slovak Union, Mr. Andrew Rajec attended the prayer service. Our Fraternal & Youth Director coordinated this prayer service which was very meaningful.

Scholarships — FCSLA is proud of helping tomorrow's leaders. Supporting education is one of FCSLA's proudest fraternal activities. Scholarship applications can be obtained through our Home Office or on our website twww.fcsla.org. The FCSLA Program awarded scholarships totaling \$231,545.00. The scholarship program is reviewed annually by the Board of Directors. The Philanthropic/Scholarship Committee met during 2014 to discuss our Scholarship Program and changed the dates and how the applicants are judged for the 2015-2016 school year.

Matching Funds Program — The Matching Funds Program is an opportunity for our Branches and members to volunteer and raise funds for a benevolent cause of their choice. Through December 2014, there were 120 charitable projects completed that raised \$322,591.00. Our Association matched \$170,608.00 of the raised amount.

Annual District Presidents' Meeting — The managing officers planned and hosted the 13th Annual District Presidents' meeting on May 9, 2014 at the Home Office. Through the years these meetings have changed in format but not in content. This annual meeting gives your managing officers and our Home Office staff an opportunity to share new procedures, information, and goals with the District Presidents/Representatives. District Presidents/ Representatives also have time on the agenda to communicate to the managing officers the needs and/or concerns of their branches and members in their district. In 2012, under the guidance of our National President Cynthia M. Maleski, a popular round table discussion was introduced. Our President in 2014, appointed Margaret Abildua of District #6, as the leader of this discussion. It is very important for those attending this meeting to return home with information to share.

#### 2014 Senior and Junior Fraternalist of the Year Award

 The FCSLA proudly awarded the Senior 2014 Fraternalist of the Year Award to Bonnita Vavruska from Branch W-093 in Tabor. SD and the Junior Award to Rachael Funtal from Branch J-157 in Pittsburgh, PA. We congratulate both Bonnie and Rachael for



representing their branch, church and community with fraternal spirit and excellence. A descriptive article about each of them was in our September issue of *Fraternally Yours*.

**Cookbook** — Our Slovak American Cookbook continues to be a very popular cookbook that fosters Slovak culinary traditions. In 2014 there were 1,108 cookbooks sold.

**50 Year Members** — FCSLA recognizes members who reach 50 consecutive years of membership; the FCSLA awards a one-time check in the amount of \$75.00. There were 853 members honored in 2014, totaling \$63,975.00.

**Fraternal Survey** — Over the course of a year, FCSLA members volunteered countless hours of service and financial support to those in need. These acts of kindness and generosity should not go unnoticed. They are recorded, compiled and forwarded to the American Fraternal Alliance as evidence of our fraternalism. Our branches make us very proud!

**Branch Activities** — The FCSLA continues its tradition of subsidizing and encouraging an annual Branch activity held for its Junior/Senior members. Approximately \$161,114.00 was paid to branches that hosted a senior and/or junior activity. All activities submitted are brought to my attention for reimbursement approval. Many of these activities are very creative and branch members are very appreciative to attend the events.

New Forms and Gifts — We initiated a new approach in the way branch officers requested giveaways and the gifts we ordered. With the assistance of several staff members we chose gifts that were unisex and useful for all ages. We kept this in mind for junior members by asking several junior members what they would like. Our Fraternal and Youth Director Kelly Shedlock, Office Support Staff Jackie Gates and I, created a Request for Giveaways Form which we have modified several times to make user friendly. The form tells us what event is being held and who is sponsoring the event. This is a tremendous help in sending out the appropriate giveaway. Jackie also created excel spreadsheets which assist us tremendously in keeping track of our inventory and also what we send a branch in case we have another request.

**Employees** — We are very fortunate at FCSLA to have a very dedicated staff. I cannot say enough about them to do them justice. The managing officers rely on them daily. They know how our members rely on them for the many questions they present and the answers they provide. Our employees are loyal, dedicated and talented. In 2014, we did have some employees resign and it has been very difficult to find replacements. In May, our National President and I hired an Executive Secretary, Jayne Neelon. Jayne has been a welcomed addition to our staff. We also had a new hire to assist in Branch Operations. We are looking forward to 2015 in anticipation of hiring additional dedicated individuals.

To our staff, I sincerely thank all of you for all the assistance you gave me on a daily basis. The FCSLA is truly blessed with a great Home Office Staff that is team-oriented and works towards an efficient operation.

#### **Special Convention**

Through 2014 we followed the guidelines of our bylaws and motions made at the 2011 Quadrennial Convention to prepare for our 2014 Special Convention. A huge thank you to our National President's Administrative Assistant, Marie Golias (who also assisted with the Bylaws Revision Committee) and our Executive

Secretary Jayne Neelon for all of their assistance in organizing before, through and after the convention. There is a tremendous amount of work involved and after this convention they are prepared for our 41st Quadrennial Convention in 2015. Louisville, KY here we come. At our Special Convention we also had assistance from our Programmer Jim Deak and our National Treasurer's Assistant Gianna Picciano. I also assisted in arranging meetings when the Bylaws Revision Committee met at the Home Office.

A first for FCSLA besides all of the changes the delegates made in our new bylaws was our electronic voting. I presented this new mechanism at our Board of Directors Meeting in June and the board agreed to give it a try. Our IT tech Chris Tollon and Jim Deak assisted in preparing all the necessary equipment we needed to use this new technique in voting. It worked so well and saved an enormous amount of time that the board members voted to use it at our convention in 2015.

#### My Fraternal Activities

I attended the American Fraternal Alliance Midyear and Annual Meetings, the Slovak Catholic Federation spring and fall meetings, and Ohio Fraternal Alliance's Board and Annual Meetings. I remain serving the OFA as their treasurer. In May I attended an informative seminar sponsored by Bruce and DePersis in Pittsburgh, PA. In July I attended the combined districts St. Ann's Day celebration hosted by District #6 in Indiana. Their hospitality under the direction of District President Margaret Abildua was outstanding. In December, I attended the annual Christmas Party for District #7 under the direction of District President Mary Therese Tylus. This event and all the events I attend are one of the perks I enjoy as your National Secretary. It gives me great pleasure to be able to celebrate with as many members as possible. It allows me the opportunity to be part of your/our fraternal family. I look forward to sharing with many more of you in 2015.

## National Treasurer

Reverend Monsignor, National Officers, National Directors and Members of the First Catholic Slovak Ladies Association (FCSLA):

Pochvaleny Bud Pan Jezis Kristus!

I present to you the 2014 financial report of the FCSLA. This report includes comparative balance sheets and income statements for 2014 and 2013. These statements are based on the Association's general ledger balances. A list of acquired and disposed investments follows the financial statements. Please refer to them during the following comments.

#### **Operating Performance**

FCSLA experienced another strong financial year. 2014 was profitable and our assets and surplus increased from 2013. Our overall strategy of managed growth and profitability is working.

A look at the balance sheet shows that our total assets grew by almost \$25 million to a total of \$781.5 million at December 31, 2014. This represents an annualized growth of 3.3%. Consistent with our investment guidelines, the vast majority of these assets are held in high quality investment grade corporate bonds.

Our life reserves grew by \$.8 million or .3% and our annuity reserves grew by \$20.4 million or 5.1%. Life reserves represent 37.6% and annuity reserves represent 62.4% of our total year end product reserves. In aggregate, the balance of the remaining liabilities increased by 20.8% mainly due to the increases in the provision for dividends payable due to the convention dividend bonus and the death claims payable. The change in surplus will be discussed later.

Turning to the income statement, insurance premiums declined 5.5% from last year. This reduction was primarily the result of lower premiums from the sales of our Single Premium Whole Life product. The guarantee issue Single Premium Whole Life product campaign started in November 2014 and is expected to end at the end of April. I encourage those members who received this offer to strongly considerate it as it does not require medical underwriting and helps keep up with the rising costs of final expenses.

Our annuity sales for 2014 totaled \$28.3 million representing 27.3% growth over prior year. During 2014 the Association introduced our Elite line of annuity products which include the following: Silver Elite, Gold Elite and Platinum Elite. These products offer competitive credit rates, guarantee rates and surrender periods. For additional information on these products including guarantee and credit rates please refer to our website or a current copy of *Fraternally Yours*.

Our investment income increased to \$40.6 million, an increase of 5.2% over last year. This increase is the result of the increase in investment assets as discussed earlier and several early calls on certain bonds. The annualized return on investment for 2014 excluding the early call premiums was 5.28%. This percentage continues to get lower each year as higher-yielding bonds mature or get called and are replaced by lower-yielding bonds. These lower-yielding bonds are reflective of the current low interest rate environment which is directly impacted by federal monetary policies and the overall economy. While US treasury yields were better in the majority of the first half of 2014, they were generally less during the second half of 2014, compared to similar periods in 2013. Over-

all these rates are significantly lower than their historical averages.

Changes in life and annuity reserves are directly impacted by new premiums received and benefits and surrenders paid. The significant increase in life insurance surrenders coupled with life premiums and death benefits paid resulted in a slight reduction in the overall life reserves. Please continue to stress to your children and grandchildren the long term benefits of life insurance as many individuals overlook them when they are faced with difficult economic times. During 2014, Post Mortem Benefits (PMB) of over \$1.2 million were paid to the beneficiaries of our deceased members. FCSLA continues to be one of the few fraternals that still provides this outstanding benefit.

After direct insurance and annuity related expenses and benefits the remaining other operating expenses, in aggregate, remained consistent with 2013. A significant portion of these costs relate to fraternal expenses which will be discussed later.

Income from operations for 2014 was \$6.7 million a 21.5% increase from last year's \$5.5 million. We continue to meet our overall goal of sustained managed growth and profitability.

Keeping with our long history of paying dividends and the income from operations, the Board of Directors approved approximately \$2.6 million of dividends to be paid in 2015. This includes a special convention year dividend bonus. This represents a \$1.3 million increase from last year. Net income from operations after dividends was \$4.1 million compared to \$4.2 million last year.

After accounting for capital gains, overall income for 2014 was \$4.1 million compared to the \$5.8 million last year. In summary 2014 was another solid financial year for FCSLA.

#### **Fraternal Expenses**

Fraternal costs represent a major expense for FCSLA. This year we spent about \$2.5 million on fraternal related activities. These costs include branch and districts bonuses, fraternal activities, official publications, conventions, donations, matching funds and scholarship awards, to name a few. In addition to these fraternal costs FCSLA paid Post Mortem Benefits (\$1.2 million) and dividends (\$2.6 million) for the direct benefit of our members and/ or their beneficiaries as discussed earlier. This brings the grand total of fraternal benefits to our members, beneficiaries, and the communities they live, work and worship in to \$6.3 million. This amount far exceeds amounts spent by similar and larger sized fraternals. Keep this number in mind as you discuss our fraternal with your family and friends.

#### Investments

A complete list of all bonds and stocks purchased, matured or called during 2014 is included at the end of this report for your review. As mentioned earlier finding suitable investments with the acceptable yield and duration relationship continues to remain challenging.

#### **Financial Strength**

There are several ways to look at FCSLA's financial strength including surplus, solvency ratios, Risked Based Capital and independent outside rating agencies.

At year end our surplus, total assets less liabilities, was over \$92.8 million dollars. This amount represents the accumulative effective of many years of profits and even a few years when we incurred losses. Overall, we continue to be blessed with this large surplus and we need to give thanks and credit to the great stewardship of my predecessors and current and former National



Officers, Board members and employees. Everyone contributed to give FCSLA the ability to continue to fulfill our financial promises to our members.

Another way to compare our Association's surplus and financial strength with others is our solvency ratio. Our solvency ratio is 113.4% at the end of 2014. This means that we have approximately \$113 in assets to cover every \$100 in liabilities we currently owe. Our solvency ratio is one of the highest amongst all the fraternals.

Recently, Risked Based Capital (RBC) has become another indicator of financial strength. Our RBC was 960% at year end. Regulators have put the RBC benchmark at 250% to 300% which our Association easily surpasses.

In May 2014, A.M. Best renewed our A- (Excellent) rating as an independent outside indication of our financial strength. This articulates how solid they view our finances as very few fraternals achieve the "A-" or above designation.

#### **Closing Remarks**

After discussing another solid financial year, I would be remiss by not commenting on the financial challenges that face FCSLA now and in the future. The sustained low interest rate environment that we are currently operating in will remain one of FCSLA biggest financial challenges. While the Federal Reserve has given hints of raising interest rates in 2015 the actual amount of the increases and timing is unclear. Our challenge will be to maintain our growth of our asset base in a profitable manner taking into account the interest rates we credit our liabilities.

Finally, I would like to thank the outstanding home office staff that keeps the FCSLA operating on a daily basis. I would also like to thank my fellow managing officers, National President Cynthia M. Maleski and National Secretary Sue Ann M. Seich and the Board of Directors for their commitment and the professionalism exhibited throughout the year. Last but not least, I want like to thank our members and everything they do to make the FCSLA the great fraternal it is.

#### YEAR OVERVIEW

As we begin 2015, this report is a review of the previous year. With turbulent changes both here and globally in the economic climate the Association grew assets and maintained the A- rating from A. M. Best.

#### STRATEGIC PLAN and COMMITTEES OF THE BOARD

We continued to implement principal aspects of our strategic plan through board committees. In addition to sub-groups of the Board, we served on the following committees: Executive, Product Development, Philanthropic Dollars and Scholarship, Branch Leadership Training and Bylaws Revision. As mandated by the 40th Convention, a Bylaws Revision Committee had been established. The Committee was charged with reorganizing the structure of the then existing bylaws and recommending a form of governance to the Special Convention. The Committee commenced the first phase of the process in October, 2012 and completed their commission two years later at the October, 2014 Special Convention in Beachwood, Ohio. The recommendations of the Committee were adopted by the Special Convention and later approved by the Ohio Department of Insurance.

#### **EXECUTIVE COMMITTEE OF THE BOARD**

As National Trustees, we serve on the Executive Committee where we discuss and analyze trends that may affect our products and financial outlooks. We vote to recommend action to the full board on quarterly annuity rates. Further, we review investments and FCSLA's current financial status as presented by the National Treasurer. Since market conditions change over time, we believe it is important to maintain a diversified portfolio with tolerance for market volatility, time horizon, and financial goals. The Association's assets are invested according to faith-based ethical principles. We are ever vigilant to changes in regulatory and legal requirements, especially in our state of domicile and in states where we are licensed to do business.



#### **BOARD OF DIRECTORS**

As members of the board of directors, we participated and voted at quarterly meetings. Also, we analyzed sales statistics and statistics presented by our managing officers. The FCSLA's budget is prepared on a line item basis, with final approval at the December board meeting. Budget discipline is exercised with the Board's goal to achieve an operational budget surplus annually.

#### **VOUCHER OVERVIEW**

The Trustees review all of the Association's expense vouchers, which requires ongoing physical examination of vouchers at the home office. We do not approve vouchers until accuracy of the invoice is established and documentation of each bill transparent.

#### **FINANCIAL OVERVIEW**

As a fraternal, our Association has a strong solvency ratio (113%). Investments are comprised of a mix of equities, bonds and money market funds. As we ended the year, the Association recorded over \$700M in assets with a surplus over \$92M. The Board voted to double the 2015 dividend over 2014 levels in observance of the convention year.

#### IN CONCLUSION

Fraternal, benevolent and charitable works in our communities remain the vanguard of our efforts and goals, with development of branch activities and duties, matching funds projects, scholarships, and an annual charitable appeal. The FCSLA continued to establish new branches in 2014. Many challenges were encountered this year; we believe we have addressed these challenges in a timely and vigilant manner. Foremost, we remain steadfast in our commitment to provide you with prudent decisions that coincide with the needs of our members in building our FCSLA. We're committed to your well-being. We appreciate the trust you have placed in us. We have tried to justify that trust.

#### BUTTERNUT SQUASH LASAGNA

8 to 10 servings Butternut squash lasagna 1 tablespoon olive oil

1 (1½- to 2-pound) butternut squash, peeled, seeded, cut into 1-inch cubes Salt and freshly ground black pepper ½ cup water

3 amaretti cookies, crumbled

1/4 cup butter

1/4 cup flour

31/2 cups whole milk

3/4 cup (lightly packed) fresh basil leaves Pinch of nutmeg

12 no-boil lasagna noodles

2½ cups shredded whole milk mozarella cheese

1/4 cup grated parmesan cheese

Heat the oil in a heavy large skillet over medium-high heat. Add the squash and toss to coat. Sprinkle with salt and pepper. Pour the water into the skillet, then cover and simmer over medium heat until the squash is tender, stirring occasionally, about 20 minutes. Cool slightly, then transfer the squash to a food processor. Add the amaretti cookies and blend until smooth. Season the squash puree to taste with more salt and pepper.

Melt the butter in a heavy medium saucepan over medium heat. Add the flour and whisk for 1 minute. Gradually whisk in the milk. Bring to a boil over medium-high heat. Reduce the heat to medium and simmer until the sauce thickens slightly, whisking often, about 5 minutes. Whisk in the nutmeg. Cool slightly. Transfer half of the sauce to a blender. Add the basil and blend until smooth. Return the basil sauce to the sauce in the pan and stir to blend. Season the sauce with salt and pepper.

Position the rack in the center of the oven and preheat to 375 degrees F. Lightly butter a 13x9x2-inch glass baking dish. Spread ¾ cup of the sauce over the prepared baking

dish. Spread one third of the squash puree over 3 lasagna noodles. Arrange noodles, puree side up, atop the sauce (the noodles will expand as they bake). Sprinkle with ½ cup of mozzarella cheese. Drizzle ½ cup of sauce over the noodles. Repeat layering 3 more times.

Tightly cover the baking dish with foil and bake the lasagna for 40 minutes. Sprinkle the remaining mozzarella and parmesan cheeses over the lasagna. Continue baking uncovered until the sauce bubbles and the top is golden, 15 minutes longer. Let the lasagna stand for 15 minutes before serving.

#### **PULLED PORK BARBECUE**

1 boneless or bone-in Boston butt roast or pork shoulder, 5 pounds

1 teaspoon salt

½ teaspoon ground black pepper

1 tablespoon chili powder

11/2 teaspoons garlic powder

1/2 teaspoon onion powder

½ teaspoon ground mustard

1 cup apple juice

4 cloves garlic, coarsely chopped

#### **Barbecue Sauce**

2 cups ketchup

<sup>2</sup>/<sub>3</sub> cup cider vinegar

1/4 cup finely chopped onion

2 tablespoons Worcestershire sauce

2 tablespoons packed brown sugar

1/2 teaspoon dry mustard

½ teaspoon garlic powder

Heat oven to 450 degrees.

In a bowl, combine the salt, pepper, chili powder, garlic powder, onion powder, and mustard. Place the pork in a roasting pan and rub all over with the spice mixture.

Roast the pork for 1 hour. Remove from the oven

Reduce the oven temperature to 325 degrees. Pour apple juice over the roast and sprinkle the chopped garlic over the juice. Cover the roasting pan tightly with foil, return to the oven, and roast for about 2½ hours, or until the pork is very tender and easy to shred with a fork.

Meanwhile, prepare barbecue sauce. In a saucepan, combine the sauce ingredients. Bring to a boil, stirring constantly. Simmer, uncovered, stirring occasionally, for about 15 minutes, or until thickened.

Remove the pork from the liquids, shred, and serve with the sauce.

If desired mix about 1 cup of the sauce into the shredded pork and serve hot from a slow cooker or chafing dish. Serve with soft buns or rolls, coleslaw for topping, and reserved barbecue sauce.

#### **CHOCOLATE OAT BARS**

½ cup semisweet chocolate chips ¹/₃ cup fat-free sweetened condensed milk (from 14-ounce can) 1 cup whole wheat flour

½ cup old-fashioned or quick-cooking oats

½ teaspoon baking powder

½ teaspoon baking soda

1/4 teaspoon salt

3/4 cup packed brown sugar

1/4 cup canola or soybean oil

1 teaspoon vanilla

1/4 cup fat-free cholesterol-free egg product or 1 egg

2 tablespoons old-fashioned or quick-cooking oats

2 teaspoons butter, softened

Heat chocolate chips and milk in 1-quart heavy saucepan over low heat, stirring frequently, until chocolate is melted and mixture is smooth; set aside. Heat oven to 350 degrees. Spray square pan, 8x8x2 or 9x9x2 inches, with cooking spray.

Mix flour, ½ cup oats, the baking powder, baking soda and salt in large bowl; set aside. Stir brown sugar, oil, vanilla and egg product in medium bowl with fork until smooth; stir into flour mixture until blended. Reserve ½ cup dough in small bowl for topping.

Pat remaining dough in pan (spray fingers with cooking spray or lightly flour if dough is sticky). Spread chocolate mixture over dough. Add 2 tablespoons oats and the butter to reserved dough; mix with pastry blender or fork until crumbly. Drop small spoonfuls of oat mixture evenly over chocolate mixture.

Bake 20 to 25 minutes or until top is golden and firm. Cool completely, about 1½ hours. For bars, cut into 4 rows by 4 rows.

#### **RICE PUDDING**

½ cup uncooked regular long-grain rice 1 cup water

2 eggs or 4 egg yolks

½ cup granulated sugar

½ cup raisins or chopped dried apricots

21/2 cups milk

1 teaspoon vanilla

1/4 teaspoon salt

Ground cinnamon or nutmeg

In 1½-quart saucepan, heat rice and 1 cup water to boiling, stirring once or twice. Reduce heat to low. Cover; simmer 14 minutes (do not lift cover or stir). All water should be absorbed; if not, drain excess water

Heat oven to 325 degrees. In ungreased 1½-quart casserole, beat eggs with wire whisk or fork. Stir in hot rice and remaining pudding ingredients except cinnamon. Sprinkle with cinnamon.

Bake uncovered 45 minutes, stirring every 15 minutes. Top of pudding will be very wet and not set. Overbaking may cause pudding to curdle. Serve warm with whipped cream if desired. Store pudding covered in refrigerator up to 10 days.
