# JOY TO THE WORLD

## Very Reverend Monsignor Peter M. Polando, D. Min., J.C.L., National Chaplain

My dear Sisters and Brothers in Christ,

"In those days Caesar Augustus published a decree ordering a census of the whole world. This first census took place while Quirinius was governor of Syria. Everyone went to register, each to his own town. And so Joseph went from the town of Nazareth in Galilee to Judea, to David's town of Bethlehem – because he was of the house and lineage of David – to register with Mary, his espoused wife, who was with child. While they were there the days of her confinement were completed. She gave birth to her first-born son and wrapped him in swaddling clothes and laid him in a manger, because there was no room for them in the place where travelers lodged" (*Luke 2:1-7*).

As we gather together in our annual observance of the Nativity of Christ the Lord, my challenge to all of us is to keep in mind those people in our cities, nation, and world who have no place to lay down their heads, no meals to eat, and no access to the basic needs of health and human dignity to be afforded them that we may daily take for granted. The Blessed Virgin Mary and Saint Joseph were without a place for housing and food as they listened to God the Father's love bestowed upon them in bearing the Savior in Bethlehem. May all of us pray at the Christmas Eve Vilija and the festive meal on Christmas Day for those who have so little to celebrate with family and friends on Christmas. # Message from our National President

As we approach the Christmas season, we look forward to all the opportunities we have in our families, communities and branches for sharing and giving. Attending one of our branch events is a great way to get into the Christmas spirit, by seeing our friends and joining together to do good deeds in the communities where we live.

It is fitting for me to devote this article to some of the significant business topics covered at our 41st Quadrennial Convention. The following paragraphs are a summary of my Report as National President.

### REPORT OF THE NATIONAL PRESIDENT AT THE 41ST QUADRENNIAL CONVENTION

I am honored to serve you as National President of First Catholic Slovak Ladies Association of the United States of America. I am pleased to report that in the last four years, your national officers have stood in good stead as fiduciaries to steer our beloved Association to be an even stronger, sustainable premier fraternal benefit society through sound ethical and legal governance and financial management structures, processes and practices.

Our society has grown financially and fraternally. Currently, we have over \$800M in admitted assets, over \$1B of life insurance in force and our very robust surplus for ethnic fraternal benefit societies, even with generous fraternal expenditures, prior period adjustments and a low interest rate environment.

Since our 2014 Special Convention, we have the struggle of the bylaws behind us and we are well positioned to grow membership with the membership change, our licenses to do business in 48 states, and our plans for California, where we have recently been admitted to do business. These bylaws also contain new qualifications and governance standards to hold office. As part of the bylaws implementation process we are currently in the process of recruiting for our two other managing officer positions.

In accordance with our Mission and Vision, we have embarked on a renewed strategic planning process, where our focus is profitability, membership growth, infrastructure planning and most importantly, continuing to build on the foundation of our Catholic Faith and Slavic traditions.

In the last four years, we have made a number of critical decisions which have led to profitability during this term of office, good governance standards, and steady solid growth in sales, assets and surplus, with a generous value to Members. We have continued to declare dividends, as we have

done since 1924 and have offered a guaranteed issue program for eligible insured members. A.M. Best has reaffirmed our A-(Excellent) rating for four consecutive years and we received a clean public report from the Ohio Department of Insurance, after an all risk review of five years of operations.

Fraternally, we are strong, with the creation of 14 new branches in the last three and one half years in areas where we have not had a presence to date. In 2014, our 400+ branches have reported a record number of volunteer service hours and matching funds projects. We are truly the "Light of the World" in our communities!

To close, I am proud of the hard work, commitment and dedication of the board of directors, my fellow officers, the home office staff and the district and branch officers as we pursue a standard of excellence to be the premier fraternal benefit society in the United States of America.

### FCSLA ACCEPTING APPLICATIONS for Interim National Secretary and Interim National Treasurer Positions

As mandated by the changes to the bylaws and the effective dates adopted at the Special Convention held in October 2014, First Catholic Ladies Association is accepting applications from qualified individuals for interim positions for National Secretary and National Treasurer in accordance with the process as approved by the Special Convention.

The National Secretary directs the operating activities of the Association on a full time basis and reports to the National President. The minimum qualifications for such position include a Bachelor's Degree from an accredited college or university and possess ten years experience, demonstrating communication, organization and managerial skills. Insurance and/or fraternal benefit society experience a plus.

The National Treasurer monitors the financial conditions of the Association, oversees the Association's finances and investments on a full time basis and reports to the National President. All candidates must have either a CPA or MBA in finance or related fields from an accredited college or university and shall have ten years or more experience in the fields of business, finance or related fields.

If selected for the interim position, the candidate for each position has the potential of being considered for the permanent position and reports to the National President. Did you ever wonder why there is one Pink Oplatki in your packet? I love Oplatki. I remember as a child having Oplatki with Christmas Eve dinner at my Baba's house. I always liked the pink colored Oplatki. I had dibs on the pink one. Not that it tasted any different than the white, I just liked the color.

Last Christmas a question came up in a conversation I had with our President Cynthia Maleski. What does the pink Oplatki represent? Cynthia had heard different meanings but neither of us really knew for sure. I had a new mission – I went on the internet and looked up Pink Oplatki. I found the answer on the Catholic Company website – "The Pink Oplatki is made especially for pets. Traditionally this corresponds to the animals that were present at Christ's birth. However, in current times, this can also represent the important roles that pets play in the family". I guess that is why I have always been attracted to the pink Oplatki.... I LOVE animals!

The name Oplatki may vary depending on whether the tradition is being observed by families with a Slovak, Polish or Lithuanian background. It is sometimes called "Angel Bread" which is the English translation. In America the tradition is simply called "Christmas Wafers". Many nationalities have come to love this warm and wonderful Christmas tradition. The Christmas wafer tradition began because the word Bethlehem means "House of Bread." The breaking of bread has long been a sign of charity, unity and friendship in many cultures. The Oplatki Christmas tradition is commonly celebrated at home just before the Christmas Eve meal. Generally the eldest member of the family will begin the ritual by breaking off a piece of wafer and passing it to another family member. It is then passed from person to person at the table until everyone has a piece. The purpose of this act is primarily to express unconditional love and forgiveness for one another. The tradition can vary depending on nationality.

However you incorporate the Oplatki tradition into your family, it is a wonderful way to celebrate the Christmas spirit: peace, love, joy and goodwill.

## COURT OF APPEALS

Delegates arrived on Saturday and were treated to a get-acquainted dinner with entertainment. Sunday morning after a delicious brunch, committee meetings were held, along with a Parliamentary workshop and First Convention attendee orientation. Delegates then either walked or boarded buses for the Cathedral of the Assumption where the opening Mass was celebrated by Archabbot Douglas R. Nowicki, O.S.B. The beautiful opening liturgy was followed by a reception and opening banquet that commenced with the flag ceremony by the Host Committee from Indiana.

## Dedication of Father Murgas Room at King's College

The Slovak Heritage Society of NEPA is so pleased to announce the "Father Jozef Murgas Room" was dedicated on June 4, 2015. This room is located on the first floor of King's on the Square, former Ramada Inn, Public Square, Wilkes-Barre. It is open Monday to Friday 9 a.m. to 5 p.m. and Saturday and Sunday from noon to 5 p.m.

The dedication began with a prayer in Slovak and English by Rev. John Albosta, Chaplain of SHSNEPA. John Loyack, Vice President of Business Affairs at King's, offered greetings and remarks. He said the room pays tribute to a man who "epitomized Abraham Lincoln's advice that the best way to predict the future is to create it. Father Murgas did that, with everything from radio to reinventing the fishing reel".

Rev. John J. Ryan C.S.C., Ph. D, President of King's College, who blessed the room and the artifacts in his remarks, noted among Father's accomplishments he remained a priest and the room could "remind us that no matter how hard we work, we need a Sabbath moment ... To reflect on why we do what we do."

Dr. Thomas M. Check, D.D.S. gave a brief history on the life of Father Murgas; born 1864 and died May 11, 1929. Dr. Check was one of the first financial contributors to the room. He was baptized by Father Murgas whose name is on his baptismal certificate.

### United Slovak Society Presents Scholarships

On July 7, 2015, United Slovak Societies President Len Zilko and Scholarship Coordinator Helene Virant awarded six high school seniors \$1,000 college scholarships at the American Slovak Club in Lorain, OH. After the presentation, members, recipients along with their parents and grandparents enjoyed a lovely barbeque prepared for them by the Ladies Auxiliary of the Club. The recipients are Alison Harper, Shannon Solak and Katherine Ondeka of the FCSLA Branch 114, Stephanie DePuw and Olivia Dziak of National Slovak Society Assembly 160 and Cullen Grude of FCSU Branch 228.



It took 86 years but now there is a permanent place for the historical items that were shown in the SHSNEPA traveling exhibit. Father Albosta said the closing prayer and invited all to join in singing "Hej Slovaci".

Inside the room are the vestments of Fathers Murgas, a picture of him when he was ordained a priest, an original painting which he started on the reverse side, didn't like, and started over on the back, copies of the paintings that were on the alters at Sacred Heart Church, butterfly collection, picture of the Botanical Garden he envisioned at Sacred Heart Cemetery in Dallas, picture of the rare Beech tree that is in the yard by Sacred Heart Church, a copy of the Pittsburg Pact, his desk, and panels of the towers that transmitted sound from Wilkes-Barre to Scranton.

The 34 x 72 inch glass panels placed on opposite sides of the room were artistically hand carved and enhanced with LED lighting, symbolizing and honoring Father Jozef Murgas for his notable invention of the famous wireless telegraphy towers he built in Wilkes-Barre and Scranton.

The stained glass butterfly panel, in the center of the ceiling, is comprised of over 1,100 pieces of various shades of hand blown stained glass, brilliant bevels, and imported faceted jewels. Each piece is hand cut, ground, copper foiled and soldered in the tiffany tradition designed by Helfran Glass Co. of Edwardsville PA. The panel has a central Monarch butterfly linking the connection and gratitude of the Slovak Heritage Society to King's College for their involvement in helping to create this memorable room.

On the wall outside the room is a collage that shows his other paintings, articles in newspapers, his grave site, the Slovak prayer card from his funeral, and a stamp that Slovakia issued commemorating him.

The following Branches of the FCSLA gave financial donations to the project: Magdalen I. Iskra District, Sr. Branch 172, 035, 072 and 615. An anonymous donor requested the establishment of an endowed scholarship fund named for Father Jozef Murgas. The scholarship will provide annual support to a talented King's student with financial need. ## Holiday Treat Exchange

### GINGERBREAD PEOPLE

- 3 cups all-purpose flour (spooned and leveled), plus more for rolling
- 2 teaspoons ground ginger
- ¼ teaspoon ground cloves
- ¼ teaspoon ground nutmeg
- 1 teaspoon baking soda
- ½ teaspoon baking powder
- 1½ teaspoons salt
- 6 tablespoons (¾ stick) unsalted butter, room temperature
- ½ cup packed dark-brown sugar
- 1 large egg
- ¾ cup unsulfured molasses
- 2 cups confectioners' sugar
- 4 teaspoons powdered egg whites (meringue powder)

In a large bowl, whisk together flour, ginger, cloves, nutmeg, baking soda, baking powder, and salt; set aside. Using an electric mixer, beat butter and brown sugar until light and fluffy; beat in egg and molasses. With mixer on low, gradually add flour mixture; mix just until combined. Divide dough in half; flatten into disks. Wrap each in plastic, and refrigerate until firm, at least 2 hours and up to 2 days, or freeze up to 3 months (thaw before baking).

Preheat oven to 350 degrees, with racks set in upper and lower thirds. Working with one disk at a time, place dough on lightly floured parchment paper, and roll out to ⅛ inch thick, dusting lightly with flour as needed. Using paper, lift dough onto two baking sheets; freeze until firm, about 20 minutes.

Remove paper and dough from baking sheets. Using a long offset spatula, loosen dough from paper. Cut out shapes with cookie cutters, and brush off any excess flour. Transfer to baking sheets. (Gather scraps, briefly freeze, and re-roll.)

For softer cookies, bake 8 to 10 minutes; for crunchier cookies, bake 11 to 12 minutes, rotating sheets halfway through. Transfer cookies to a wire rack to cool completely.

Make icing: In a large bowl, whisk together confectioners' sugar, powdered egg whites, and ¼ cup water (if needed, adjust

consistency with confectioners' sugar). Transfer icing to a pastry bag with a small tip, or place in a resealable plastic bag, and snip a small hole in one corner. Decorate cookies as desired.

*Note: Make sure the disks of dough are well-chilled so they're easy to roll out thin. Roll from the center out, and aim for an even thickness, stopping just short of the edge of the dough. A quick dip in flour will keep the cookie cutter from sticking to the dough. Look for powdered egg whites in the baking aisle at your supermarket.*

### CHOCOLATE-ESPRESSO SNOWCAP COOKIES

- ½ cup all-purpose flour
- ¼ cup unsweetened cocoa powder
- 4 teaspoons instant espresso
- 1 teaspoon baking powder
- ⅛ teaspoon salt
- 4 tablespoons unsalted butter
- ⅔ cup packed light-brown sugar
- 1 large egg
- 4 ounces bittersweet or semisweet chocolate, melted and cooled
- 1 tablespoon milk
- Confectioners' sugar, for coating

In a medium bowl, sift together flour, cocoa, espresso, baking powder, and salt. With an electric mixer, cream butter and brown sugar until light and fluffy. Beat in egg until well combined; mix in cooled chocolate. With mixer on low, gradually add flour mixture; beat in milk until just combined. Flatten dough into a disk; wrap in plastic. Freeze until firm, about 45 minutes.

Preheat oven to 350 degrees. Line two baking sheets with parchment. Shape dough into 1-inch balls. Pour confectioners' sugar (about ½ cup) into a medium bowl; working in batches, roll balls in sugar two times, letting them sit in sugar between coatings.

Place on prepared baking sheets, 2 inches apart. Bake until cookies have spread and coating is cracked, 12 to 14 minutes; cookies will still be soft to the touch. Cool cookies on a wire rack.

### BISCOTTI BITES

- 1¼ cups all-purpose flour
- 1¼ cups fine cornmeal
- ½ teaspoon baking powder
- ½ teaspoon coarse salt
- ¾ stick unsalted butter, room temperature
- 1 cup granulated sugar
- 2 large eggs
- 1½ cups sweetened shredded coconut
- 2 tablespoons finely grated grapefruit zest (from 2 small grapefruits)
- 11 ounces bittersweet chocolate, finely chopped
- Fine sanding sugar, for sprinkling

Whisk together flour, cornmeal, baking powder, and salt.

Beat butter with a mixer on medium speed until smooth. Add granulated sugar and beat until pale and fluffy, about 3 minutes. Beat in eggs, 1 at a time, until well combined. Add flour mixture and beat on low speed until just combined. Then beat in coconut, grapefruit zest, and 5 ounces chocolate until evenly distributed.

Drop heaping teaspoonfuls of dough, spaced 1 inch apart, on parchment-lined baking sheets. Sprinkle tops with sanding sugar. Refrigerate 30 minutes.

Preheat oven to 350 degrees. Bake, rotating sheets halfway through, until golden, 18 to 20 minutes. Let cool completely on baking sheets set on wire racks.

Melt remaining chocolate in a bowl set over a saucepan of simmering water, stirring until smooth. Dip bottoms of cooled cookies in melted chocolate, scrape off excess against rim of bowl, and set on parchment-lined baking sheets. Refrigerate until chocolate is set, about 30 minutes.

### GOOEY LAYERED EVERYTHING BARS

- Nonstick cooking spray
- ¾ cup (1½ sticks) unsalted butter, cut into small pieces
- ½ cup confectioners' sugar
- 1½ cups all-purpose flour (spooned and leveled)
- ½ teaspoon coarse salt
- ¾ cup rolled oats (not quick-cooking)
- 1 cup semisweet chocolate chips (6 ounces)
- 1 cup walnut pieces, toasted
- ½ cup raisins
- 1 can (14 ounces) condensed milk
- 2 cups sweetened shredded coconut (7 ounces)

Preheat oven to 375 degrees. Line a 9x13-inch baking dish with parchment paper, leaving overhang on short sides; lightly coat paper with cooking spray.

In a food processor, pulse together butter, confectioners' sugar, flour, and salt until mixture resembles coarse meal. Add oats and pulse until just combined. Press dough evenly into bottom of dish and bake until lightly browned and firm, about 20 minutes.

Scatter chocolate chips, walnuts, and raisins on top of crust. Drizzle with condensed milk and top with coconut. Bake until coconut is golden, about 20 minutes. Let cool completely in dish on a wire rack before cutting into 18 squares. Store in an airtight container, at room temperature, up to 3 days.
