Dear Sisters and Brothers,

As we are all aware, the Christian Scriptures revolve around the life, preachings, passion, death, resurrection, and ascension of our Lord. Most of what we know of the Blessed Virgin Mary is contained in the Infancy Narratives of Matthew and Luke and the Passion Narratives of the four gospels. There are only several references of her outside of the Infancy and Passion Narratives. The rest of our knowledge of her has been handed down to us in the Sacred Tradition of Church teaching. When it comes to her husband, Joseph, there is no further mention of his activities outside the Infancy Narratives. But what we know of him in these sacred writings makes us respect him for all of his earthly actions in relationship to the God who created him and for the care he gave to the Son of God who would save him. Joseph was a man of obedience to his God as exemplified in the gospels.

After the genealogy of Jesus in the Gospel of Matthew, the birth of Jesus is described: When his mother Mary was betrothed to Joseph, but before they lived together, she was found with child through the Holy Spirit. Joseph her husband, since he was a righteous man, yet unwilling to expose her to shame decided to divorce her quietly. Such was his intention when, behold, the angel of the Lord appeared to him in a dream and said, 'Joseph, son of David, do not be afraid to take Mary your wife into your home. For it is through the Holy Spirit that this child has been conceived in her. She will bear a son and you are to name him Jesus, because he will save his people from their sins'...When Joseph awoke, he did as the angel of the Lord had commanded him and took his wife into his home" (1:18-21, 24). The descriptive word "righteous" in the describing the person of Joseph notes that he was faithful in observing the Law of Moses. Because Mary was pregnant and their marital process was not yet complete, Joseph decided to follow the Law and divorce Mary quietly, meaning not to expose her to the Law which may have led her to death by stoning. Instead, Joseph heeded the angel of the Lord's words and took Mary into his home.

Because of the magi request of Herod for the whereabouts of the child Jesus, and after the magi adoration, Joseph obeyed the angel's command to flee: "Rise, take the child and his mother, flee to Egypt and stay there until I tell you. Herod is going to search for the child to destroy him. Joseph rose and took the child and his mother by night and departed for Egypt" (2:13-14). And when it was once again safe, the angel appeared to Joseph, "and said, 'Rise, take the child and his mother and go to the land of Israel, for those who sought the child's life are dead.' He rose, took the child and his mother, and went to the land of Israel. But when he heard that Archelaus was ruling over Judea in place of his father Herod, he was afraid to go back there. And because he had been warned in a dream, he departed for the region of Galilee" (2:20-22). Note in these passages how obedient Joseph was to the commands of the angel without demands or challenges. He quietly obeyed.

Pope John Paul II had an intimate devotion to Saint Joseph. In 1989, he wrote: "The Second Vatican Council made all of us sensitive once again to the 'great things which God has done,' and to that 'economy of salvation' of which Saint Joseph was a special minister. Commending ourselves, then, to the protection of him whose custody God 'entrusted his greatest and most precious treasurers,' let us at the same time learn from him how to be servant of the 'economy of salvation.' May Saint Joseph become for all of us an exceptional teacher in the service of Christ's saving mission, a mission which is the responsibility of each and every member of the Church: husbands and wives, parents, those who live by the work of their hands or by any other kind of work, those called to the contemplative life and those called to the apostolate. Saint Joseph pray for us.

As we approach the national celebration of our 125th anniversary, everyone is looking forward to the Mass, dinner, open house and rededication of the St. Anne statue at the home office with excitement and anticipation. As we told the girls/young ladies of what had just happened, it brought tears to our eyes. Thank you ladies! You ROCK!

One of the young ladies, Anna has been coming to FCSLA events with her mom, Kathy ever since she was a baby. She is my buddy. It is such a pleasure for me to seeing her grow into a beautiful young lady and see her at the Join Hands Day with her friends working in "their garden". I am so proud of Anna. I hope you keep coming for many years and keep bringing your friends to Join Hands Day. Maybe one day you will be able to take over for me in helping plan this very special day.

Moments like this are what FCSLA is all about, who we are and what makes us so unique from the commercial insurance companies. A Look Back At The Drill Teams

Today, the drill teams are still recalled with fond, memories as one of the Society's most rewarding activities.

They were officially organized in Cleveland on July 11, 1934 by Joseph Matuscak, husband of Junior Order Secretary, Susan Matuscak.

One of the teams' goals was to engage the younger members in the philosophy and work of the Society.

The first team had 88 Sr. Order ladies, all decked in bright military-style uniforms. Soon junior teams were also organized. The drillers seemed to enjoy the exercise and regimentation of performing the intricate and brisk-stepping marching patterns.


At the St. Louis Convention in 1937, 500 girls competed in the first national FCSLU drill team meet. In 1938 the Board of Directors appointed Frances L. Mizenko as national commandress of the teams. Katherine Vinca of Ohio and Maria Hrabina of Illinois were appointed regional supervisors and served for about a year. They were succeeded by Catherine Steibly of Farrell, PA, Anna Dolak of Youngstown, Ohio and Theresa Krasula of Chicago.

The drill teams were a bright promise for the future of the organization. As the teams continued to receive national acclaim, they became more and more popular among members and even non members. By 1942 about 3,000 young ladies belonged to 32 Senior Order and 23 Junior Order teams. In that year, about 770 girls from Milwaukee, WI to New York highlighted the 50th anniversary of the Society in Cleveland by competing in the third national meet. The prize to the winning team in each Order was a trophy and \$125.

A sense of apathy during the post war years led to the gradual decline of the teams. When the program was completely ended in 1948, the Society had the record of having sponsored four national meets.





National President's Comments

President Maleski informed the committee that a break would be taken during the meeting today for a special meeting of the board of directors to consider the approval of the Polish Women's Alliance of America (PWAA) merger agreement and to consider the approval of an individual for the position of National Treasurer.

Pro-Life March

FCSLA will participate again in the March for Life in Washington D.C. on January 27, 2017. In conjunction with the First Catholic Slovak Union, FCSLA will sponsor two buses for attendees. At the District Presidents' meeting in April, President Maleski encouraged districts and branches to participate in pro-life activities in their own areas and churches, as well as the national event.

Monsignor Polando joined the meeting.

Strategic Planning Process

Merger Updates

Backyard Celebrations

GRILLED BURGERS

2 pounds lean ground beef

1/2 cup quick-cooking or old-fashioned oats 1/4 cup milk

- 1 egg, beaten
- 1/4 cup ketchup
- ¹/₂ cup chopped onion
- 3 teaspoons finely diced green pepper
- 1 teaspoon salt
- Dash pepper
- 8 hamburger buns

Combine first nine ingredients in a large bowl and mix well. Shape into eight patties. Grill until burgers reach desired doneness. Serve on buns with lettuce, tomato and cheese if desired.

GRILLED CORN

For the Garlic Butter

8 tablespoons butter, at room temperature 3 cloves garlic, minced

- ¹/₄ teaspoon red pepper flakes
- 1 tablespoon finely chopped fresh parsley
- 4 ears of corn, husked
- 1 tablespoon butter
- Kosher salt
- Freshly ground black pepper
- ¹/₂ cup Parmesan cheese
- 1/2 cup Pecorino Romano

To make the garlic butter, whisk together butter, garlic, red pepper flakes, and parsley in a small bowl. Set aside.

Lightly butter the corn with 1 tablespoon of butter and season with salt and pepper to taste. Wrap ears individually in aluminum foil.

Place the foiled corn on the grill and cook until tender and slightly charred, about 20 minutes, turning 4 times during cooking. Remove from the grill and let cool for 3 to 5 minutes.

Mix Parmesan and Pecorino cheeses together on a large plate. Open the foiled corn, slather each ear in the garlic butter, roll in the cheese mixture, and serve.

BACON POTATO SALAD

- 4 cups cubed red potatoes
- 1 cup chopped onion
- 7 Bacon strips, cooked and crumbled
- 2 tablespoons minced fresh parsley
- 11/3 cups mayonnaise
- 3 tablespoons grated Parmesan cheese
- 3 tablespoons prepared ranch salad dressing
- 2 tablespoons prepared mustard
- 4 teaspoons white vinegar
- 1/2 teaspoon minced garlic
- 1/4 teaspoon salt
- 1/4 teaspoon pepper

Place potatoes in a large saucepan and cover with water. Bring to a boil. Reduce heat; cover and cook for 10-15 minutes or until tender. Drain.

In a large bowl, combine the potatoes, onion, bacon and parsley. In a small bowl, combine the remaining ingredients. Pour over potato mixture; toss to coat. Refrigerate for 1 hour or until chilled.

SOUTHERN BAKED BEANS

- 1 large onion, diced
- 2 (16-ounce) cans pork and beans
- 3 tablespoons prepared yellow mustard
- 1/4 cup maple syrup
- 1/4 cup light brown sugar
- 4 tablespoons ketchup
- 1 tablespoon lemon juice
- ¹/₂ pound bacon strips,
 - cut into 1/2-inch pieces

Preheat oven to 350 degrees F. In a Dutch oven, mix onion, pork and beans, mustard, maple syrup, light brown sugar, ketchup, and lemon juice. Top with the bacon pieces. Bake, covered, for 45 to 60 minutes.

LEMON LUSH

- 1 pouch (17.5 oz.) Betty Crocker™ sugar cookie mix
- Butter and egg called for on cookie mix pouch for drop cookies
- ¹/₄ cup butter, melted
- 1 package (8 oz.) cream cheese, softened
- 1 cup powdered sugar
- 1 tablespoon finely grated lemon peel
- 1 container (12 oz.) Cool Whip™ frozen whipped topping, thawed
- 2 boxes (4-serving size each) Jello lemon instant pudding & pie filling mix
- 3 cups cold milk

Heat oven to 375 degrees. Make and bake drop cookies as directed on pouch.

Cool completely, at least 30 minutes. Set aside 6 cookies for garnish.

In food processor, process half of the remaining cookies to coarse crumbs. Remove to medium bowl. Continue to process second half of remaining cookies to coarse crumbs; add to bowl. Stir in melted butter until well blended. In ungreased 13x9-inch pan, press cookie crumb mixture firmly in bottom. Set aside.

In medium bowl, beat cream cheese, powdered sugar and lemon peel with electric mixer on medium speed until smooth, scraping down sides of bowl frequently. Beat in 2 cups whipped topping. Spread over cookie crust.

In another medium bowl, beat dry pudding mix and milk with whisk about 2 minutes or until thick. Spread over cream cheese mixture. Spread remaining whipped topping over pudding layer. Cover and refrigerate 4 hours.

When ready to serve, place 6 reserved cookies into quart-size resealable foodstorage plastic bag. Seal bag; coarsely crush cookies with rolling pin. Sprinkle on top. Cut into 6 rows by 4 rows. Cover and refrigerate any remaining pieces.

TOMATO SALAD WITH RICOTTA SALATA AND CREAMY GARLIC VINAIGRETTE

2 pounds ripe tomatoes, sliced ¹/₂-inch thick

- 2 cups fennel, julienned
- Salt and freshly ground pepper
- 2 tablespoons minced chives
- 1/4 cup fresh chervil leaves
- 4 basil leaves, shredded


4 ounces ricotta salata cheese, crumbled ¹/₂ cup nicoise olives, pitted

Creamy garlic dressing, recipe follows Arrange tomatoes on a platter. Toss fennel in a bowl with a few tablespoons of the creamy garlic dressing and season with salt and pepper. Mound the fennel in the middle of the platter on top of the tomatoes. Sprinkle with the herbs, cheese and olives and drizzle with some more of the creamy garlic dressing.

- Creamy Garlic Dressing:
- 2 tablespoons prepared mayonnaise
- 3 tablespoons red wine vinegar
- 1 tablespoon fresh lemon juice
- 1 tablespoon Dijon mustard
- 2 cloves garlic, smashed
- 1 cup olive oil

Salt and freshly ground pepper

Combine mayonnaise, vinegar, lemon juice, mustard and garlic in a blender and blend until smooth. Slowly add the olive oil until emulsified and season with salt and pepper to taste.
