

# **ANNUAL REPORT FOR 2016**



125 years of providing security, faith and traditions! "We are the light of the world"

Very Reverend Monsignor, National Officers and Members of the First Catholic Slovak Ladies Association:

Your National President is pleased to present my annual report to all of you.

Pochváleny bud Pan Ježiš Kristus!

First, I would like to thank fellow officers and members of our board of directors, and national, district and branch officers who continue to serve First Catholic Slovak Ladies Association with dedication and commitment.

Thanks are also in order to everyone in the home office and in the field who work for our society with diligence and pride in our mission of providing financial security to our members, while embracing our Catholic values and Slavic traditions.

We will open our 125<sup>th</sup> anniversary year in 2017 with much gratitude for the vision, fortitude, perseverance and grit of our foundress, Mrs. Anna Hurban, and the eight other Slovak immigrant women who organized our society on January 1, 1892 to provide for death and injury benefits to protect families from the hazards and toll of industrial labor.

<u>Governance and Strategic Planning</u> – A Smooth Transition Year with a Number of Changes.

During an extensive board orientation session for the new board of directors, your national president presented an overview of trends and initiatives that are essential for us for long term future sustainability and growth for our association. As we build a cohesive board of directors, we need to thank all newly elected members of the board for their commitment and dedication and look forward to positive energy as we create the building blocks for the future of our society. During the third and fourth quarters 2016, we appointed new members to the board strategic planning committees; namely, strategic relations, philanthropic and scholarship, board review and performance and property advisory, in addition to our standing committees. The audit committee works diligently in assisting the board of directors in its oversight of the Association's financial statements. Members of the board are also provided with opportunities for board development and training, including attendance and participation at several day meetings and educational sessions through the American Fraternal Alliance in Nashville, Tennessee and various regional meetings. Members of the board were also trained in 2 workshops for the use of IPads to maintain security and confidentiality of board materials. We anticipate implementation of this upgrade in the first quarter of 2017.

A good measure of focused leadership time was spent on the selection/election process for vacancies on the Court of Appeals, Interim National Secretary, Interim National Treasurer and Interim National Editor, as well as a realignment of several of the operating units of our national headquarters, including appointment of long time employee Paula Dalpiaz as Insurance Manager/IT Coordinator. The second half of the year was spent in developing and implementing search and recruitment tools for full time officer and staff positions, including National Treasurer, National Secretary and National Editor, in accordance with our new governance standards set forth in our newly adopted bylaws.

# **Merger Opportunities at the Forefront**

As short and long term strategies for growth, the Strategic Relations Committee of the board of directors, which I chair, explored, developed and negotiated two merger opportunities with two fraternal benefits societies with a common bond. At every key decision making point at special or regular meetings of the board, each board member was able to fully participate in the decision making process by receiving the information needed to make collective decisions to move forward for the long term growth of our society. I led operating leadership teams, as well as outside consultants, to call a special convention by mail, to negotiate each agreement separately for each society, to perform regulatory work with regulators in key states (Ohio, Pennsylvania and Illinois) and to develop communication packets for delegates. These two business combinations have been approved by a resounding affirmative vote of our delegates in March 2017 for both short and long term growth of our Association.

# Internal and External Risk Environment – an Ongoing Process and Assessment

We continually evaluate and assess both our internal and external risk environments, including operational and transactional risk. We keep abreast of legal and regulatory changes which affect our business model. 2016 was an especially crucial year in regard to tax exemption, corporate governance; U.S. Department of Labor fiduciary standards, principle based reserving and several other compliance topics, all in the fore front at this present time. As part of leadership responsibilities, I serve on the board of directors

of American Fraternal Alliance, which enables our society to obtain timely information on these significant topics. Several of our board members serve on state and regional alliance boards as well, to keep us informed on a formal and informal basis.

# <u>Several Records Achieved in Annual Operating</u> Performance.

In 2012, during my first year as National President, I articulated an overall strategy of managed growth and profitability; we have now even further refined our goal of <u>sustained</u> managed growth. According to reports of our independent actuary, Grant Hemphill of Bruce & Bruce and our outside auditors H2R CPA, we saw a number of records achieved in 2016, including record total assets (\$866.94 million), record total revenues of (\$101.9 million) record total annuity premiums (\$54.9 million) and record surplus (over \$99 million), despite the ongoing challenges in transitioning leadership and staff.

In 2016 we paid bonus dividends of \$1.4 million to members. A.M. Best reaffirmed our A- (Excellent) rating in a review process which takes a significant amount of our executive time as well, including preparation of metrics, strategy narratives and an in depth interview session. Our risk based capital (RBC) value well exceeds that of the regulatory benchmark of 300%.

FCSLA continues to hold over \$1 billion of insurance in force. Our strategic team has appropriately focused on the key long term opportunity of mergers with likeminded fraternal benefit societies having insurance blocks of business. In the short term, our operating team made up of Mr. Albert Heiles, National Sales Manager; Katherine Bowes, Interim National Secretary and others have focused on short term incentive campaigns and support of our producers, since we anticipated the challenges in sales on the insurance portion of our business. Our National Sales Manager Al Heiles conducts monthly training sessions for our producers on a regular basis.

Congratulations to our management, our sales leaders, producers and home office staff who all have worked hard to achieve these results. It is a tribute to your perseverance and dedication on behalf of our association. What a great way to begin our 125th Anniversary! We are the light of the world!

# <u>Fraternal Operations –Provide a generous value to members</u>

Fraternally our society continues to provide a very generous value to members and branches. We created three new branches in 2016. Our branches, over <u>400</u> strong, have reported a combined record 5,834,313 hours of volunteer community and fraternal activity hours. In 2016, 104 branches in 17 states completed 157 matching funds projects in the communities we serve, where we raised \$516,313.66 for approved projects within the scope of our mission and vision.

Our second branch membership challenge has been a success where seventy-six branches across the country worked hard in collaboration with our producers where each branch was asked to bring in at least five new members.

Congratulations to each and every one of you.

Our magazine Fraternally Yours continues to provide the major vehicle for communicating with our members in a colorful, meaningful way about our strategic direction, our finances, our fraternal districts, and branch activities and programs and our products. Thank you, National Editor Carolyn Bazik and all those who write articles or submit information or photos. In fall 2015, the board of directors, through the scholarship and philanthropic committee, designated our Anna Hurban Scholarship Fund as our 2017 National President's Appeal. Funds collected will be added to the annual \$250,000 we already designate to the Scholarship Fund. We welcome all donations, both large and small, and all will be acknowledged in Fraternally Yours. What a better way to celebrate our 125th Anniversary than to donate for the benefit of our young members! Our branch newsletters, our major communication to our branch officers, are filled with relevant branch officer information every month, thanks to our National Fraternal and Youth Director, Kelly Shedlock. We are the light of the world!







As this is being written, our credentialed delegates are voting by mail on whether or not to merge with these fine organizations.

Sales: 2016 was the first full year of our new National Sales Manager (NSM) Albert Heiles. This year in a new focus area, I collaborated with the NSM in a variety of ways to bolster sales, increase membership, and support our producers. The Friends and Family referral program to reward current members for referring potential new members brought in 438 new members. FCSLA now has Regional Sales Managers (RSMs) in all areas of the country except the deep South and NSM Heiles anticipates hiring someone for that area in the near future. As FCSLA is newly licensed to do business in California, Mr. Heiles and I supported the new RSM based in that state in his effort to reach out to current members and new members. Through our RSMs, FCSLA has hired new agents throughout the country in our desire to bring the benefits of our financial products to a wider audience. Our NSM also assists the FCSLA licensed recommenders and non-licensed recommenders in their sales. If you wish to become a licensed producer, please contact the home office for information.

**Tech Enhancements:** Our National President and board of directors took a big step this year in embracing modern technology by approving the purchase of iPads and a board portal service to enhance security and confidentiality in their communication. In anticipation of the arrival of the iPads, the old boardroom tech equipment and wifi capability were upgraded. Computer software and hardware requirements are reviewed regularly for compliance, security, and potential obsolescence.

**Districts:** Districts are integral to our fraternal system, supporting the branches in their district, disseminating information, and promoting our association. FCLSA currently has 15 active districts. At the annual District Presidents' meeting in April, the attendees heard reports from the national managers, discussed the business of running a district, were informed of the details of the National President's Annual Appeal (the Anna Hurban Scholarship Fund), and were the first to learn about the potential merger opportunities with PUNA and PWAA. \$17,132 was paid out for the district quota for 2016.

Branches and Fraternal Outreach: Our branches are the center of our fraternal heart. FCSLA currently has 416 branches in 26 states. Branches serve their members and communities in a variety of ways, from welcoming new members and serving the long-time members, to conducting Matching Funds activities to raise money for community projects. To boost membership and sales, many branches participated in the 2016 sales challenges: the Meet & Greet Initiative, and the Branch Challenge. Our branches shined in their Matching Funds activities, with 104 branches raising \$519,314 so that FCSLA could match their funds with an additional

\$91,261. 50 branches completed the maximum of two Matching Funds projects and 16 branches completed a Matching Funds project for the first time! FCSLA sponsored two buses that travelled to the 2016 March for Life in Washington, D.C. (many thanks to the Cleveland District for providing food for the hungry passengers). Many branches also participated in the annual Join Hands Day, a national day of community service. Lastly, our Fraternal and Youth Director Kelly Shedlock opened three new branches in 2016 – a junior and senior branch in Holland, OH and a junior branch in David City, NE.

**Scholarships:** In 2016, FCSLA awarded 223 scholarships in the amount of \$251,750 to students from elementary school to graduate school. At the 2015 Quadrennial Convention, our National President announced the formation of the Anna Hurban Scholarship Fund which will enable FCSLA to help even more students for generations to come. Look for more information on this exciting opportunity to help our student members by contributing to the new Fund in upcoming issues of *Fraternally Yours*.

Home Office Staff: Our staff continues to work hard to service our current members, new members, branch & district officers, and producers. The managing officers also rely on this dedicated staff on a daily basis, as they are the people with the daily working knowledge of this organization. In 2016, FCSLA hired new staff members and made other internal personnel changes to fill open positions.

**125th Anniversary Celebration:** 2017 will be a big year for FCSLA as we celebrate our 125th anniversary and it takes a long time to plan such a momentous event. The steering committee and key internal staff members began working out all the details for this grand occasion in 2016. Both national and district events are being planned.

In closing, I would like to thank my fellow national officers, National President Cynthia Maleski and National Treasurer Stephen Hudak, for affording me the opportunity to serve with them during this year of transition. I would also like to thank the excellent home office staff for their patience and understanding. May the First Catholic Slovak Ladies Association continue to grow and thrive for generations to come.

# POCHVÁLENÝ BUD' PÁN JEŽIŠ KRISTUS!

I present to you the 2016 financial report of the FCSLA. This report includes comparative balance sheets and income statements for 2016 and 2015. These statements are based on the Association's general ledger balances. A list of acquired and disposed investments follows the financial statements. Please refer to them during the following comments.

## **Operating Performance**

I am excited to announce that 2016 was a year of financial records for FCSLA. This includes record annuity premiums, record investment income, record total revenue, record total assets and record surplus. Our overall strategy of managed growth and profitability continues as evident by our growth in assets and surplus.

Total assets grew by over \$50 million to a total of \$866.9 million at December 31, 2016. This represents an increase of 6.2% over 2015. This compares to growth of \$34 million and 4.4% that occurred between 2015 and 2014. Consistent with our investment guidelines the vast majority of these assets are held in high quality investment grade corporate bonds.

In 2016, our life reserves increased \$.4 million or less than .2% over last year. This includes an increase in the estimate for prior paid up additions. Our annuity reserves driven by record annuity sales increased by \$45.1 million or 10.1%. Life reserves represent 34.0% and annuity reserves represent 66.0% of the total year end product reserves. In aggregate, the balance of the remaining liabilities increased by 7.7% mainly due to the increase in the Asset Valuation Reserve. This increase correlates with the increase in the market value of our common stock holdings and the increase in overall investments. The increase in surplus will be discussed later.

Turning to the income statement, total revenue for 2016 was a record \$101.9 million. This is the first year that FCSLA had total revenue exceeding \$100 million. This is a 20.5% increase from the \$84.5 million in 2015. As expected insurance premiums were less than last year for two main reasons; 2015 insurance premiums were significantly impacted from sales of our guarantee issue that was offered to our existing members and the special convention year dividend used to purchase paid-up additions.

Our annuity premium for 2016 totaled a record \$54.9 million representing a significant 47.3% growth over the prior year. This increase was primarily due to sales of our Elite line of annuity products which include the following: Silver Elite, Gold Elite and Platinum Elite. This year the Silver Elite was the clear leader based on new sales. Congratulations to all our dedicated agents and recommenders that participated to achieve this record. All these products offer competitive credit rates, guarantee rates and surrender periods. For additional information on these products including guarantee and credit rates please refer to our website or a current copy of *Fraternally Yours*.

Our investment income, including amortization of the Interest Maintenance Reserve, was a record \$42.9 million, an increase of 6.3% from last year. This increase is the result of the increased amount of invested assets and to several bonds that were called in 2016 prior to their scheduled maturity date. Upon their call we received interest in 2016 that would have been received in 2017 and subsequent years. This had the effect of increasing our 2016 interest income and will have a slight reduction of the interest to be received in 2017 and subsequent years. The annualized return on investible assets was 5.2%. The historical trend is for this percentage to get lower each year as higher-yielding bonds mature or get called and are replaced by lower-yielding bonds. However, due to the additional interest earned from the bonds that were prematurely called this rate slightly increased when compared to 2015.

The lower-yielding bonds mentioned above are reflective of the current low interest rate environment which is directly impacted

by federal monetary policies, the overall US and world economies and as we saw in 2016 the presidential elections. Despite the December 2015 treasury rate increase, 2016 was a difficult year for treasury yields. However, after a difficult summer and early fall, which included record lows, yields started to recover after the November elections. Overall long term (10 - 30 years) US treasury yields were lower in 2016 than in 2015. These rates are significantly lower than their historical averages and hit record lows during the summer. In late December 2016 the Feds had the second rate increase in a decade, the first was in December 2015. As I am writing this, there is talk in the news of aggressive rate increases in 2017. I am cautiously optimistic that we will see increases in the longer term rates. Again, the .25% increase in the short term rates in December, 2015 was followed by record lows in the long term rate during the summer to 2016. As mentioned above these rates are affected by many different influences. Regardless of what the Fed and overall interest rates do, we will continue to invest in high quality investments with acceptable vield and duration.

Changes in life and annuity reserves are directly impacted by new premiums received and benefits and surrenders paid. Our insurance benefits represent death benefits paid to beneficiaries of our members. This amount increased slightly from 2015. Our annuity benefits include annuity surrenders, annuity withdrawals and annuity payments to beneficiaries have increased over 20% from 2015. More of our annuity members are withdrawing funds to help supplement the increasing costs of retirement. Surrender benefits represent life insurance surrenders which were almost \$1.1 million less compared to 2015 as conservation efforts continue. Please continue to stress to your children and grandchildren the long term benefits of life insurance as many individuals overlook them when they are faced with temporary difficult economic times. During 2016, Post Mortem Benefit (PMB) of \$1.3 million was paid to the beneficiaries of our deceased members. FCSLA continues to be one of the few fraternals that still provides this fraternal benefit. In December, the Board approved the PMB for eligible certificates for 2017.

After direct insurance and annuity related expenses and benefits, the remaining other operating expenses, in aggregate, increased only 1.6% as we continue to do an excellent job in controlling our expenses which includes additional costs related to the two mergers. These costs include services of external professionals including legal, accounting and actuarial to name a few. We continue to make investments in our staffing, home office operations and external marketing and promotions and plan on additional investments in 2017. A significant portion of these other operating expenses relate to fraternal expenses which will be discussed later.

In addition to the external professionals mentioned above a significant amount of resources (both financial and human) were spent relating to the mergers in 2016. This includes everything from site visits, due diligence, reporting, regulatory and special convention preparation. Acquiring these two blocks of business will financially benefit FCSLA and increase our member base.

Keeping with our long history of paying dividends from income generated from operations, the Board of Directors approved approximately \$1.4 million of dividends to be paid in 2017.

After accounting for capital gains, overall income for 2016 was \$3.8 million. In summary 2016 was an outstanding financial year for FCSLA which included many milestones.

# Fraternal Expenses

Fraternal costs represent a major expense for FCSLA. This year we spent about \$3.8 million on fraternal related activities. These costs include branch and districts bonuses, fraternal activities, official publications, conventions, donations, matching funds, scholarship awards, and Post Mortem Benefits (\$1.3 million) to name a few. In addition to these fraternal costs, FCSLA paid dividends (\$1.4 million) for the direct benefit of our members. This brings the grand total of the benefits to our members, beneficiaries, and the communities they live, work and worship in to \$5.2 million. This amount far exceeds amounts spent by similar and larger sized fraternals. Fraternal expenses like all expenses have a direct correlation to the growth of our surplus.

## Investments

A complete list of all bonds and stocks purchased, matured or called during 2016 is included at the end of this report for your review. As mentioned earlier, finding suitable investments with the acceptable yield and duration relationship continues to remain challenging.

# **Financial Strength**

There are several ways to look at FCSLA's financial strength including surplus, solvency ratios, Risked Based Capital and independent outside rating agencies.

At year end our surplus, total assets less liabilities, was over \$99.6 million dollars. This amount represents the accumulative effect of many years of profits and even a few years when we incurred losses. Overall, we continue to be blessed with this large surplus and we need to give thanks and credit to the great stewardship of our predecessors and our current and former National Officers, Board members and employees. Everyone including our members contributed to give FCSLA the ability to continue to fulfill our financial promises.

Another way to compare our Association's surplus and financial strength with others is our solvency ratio. Our solvency ratio is 113.0% at the end of 2016. This means that we have approximately \$113 in assets to cover every \$100 of liabilities. Our solvency ratio is one of the highest amongst all the fraternals.

Risked Based Capital (RBC) has become another indicator of financial strength primarily used by regulators. Regulators have put the RBC benchmark at around 300% which our Association easily surpasses.

In May 2016, A.M. Best renewed our A- (Excellent) rating as an independent outside indication of our financial strength. This articulates how solid they view our finances as very few fraternals achieve the "A-" or above designation. In addition, few fraternals even attempt to get rated by A.M. Best as it is an extensive process that consumes significant resources.

# **Closing Remarks**

After discussing another outstanding financial year, I would be remiss by not commenting on the financial challenges that face FCSLA now and in the future. As I discussed in prior years, the sustained low interest rate environment that we are currently operating in will remain one of FCSLA biggest financial challenges. This was discussed in depth earlier in my report. Our challenge will be to maintain the growth of our asset base in a profitable manner while fortifying our organization for the future.

I would like to thank the outstanding home office staff that keeps the FCSLA operating on a daily basis. I would also like to

thank my fellow managing officers, National President Cynthia M. Maleski and Interim National Secretary Katherine Bowers and the Board of Directors for their commitment and the professionalism exhibited throughout the year. I would like to thank our National President Cynthia M. Maleski for having the confidence in me to hire me as the National Treasurer after servicing as Interim during 2016.

Finally, special thanks to all of our branch and district officers that devote a significant of your valuable time and talents to keeping FCSLA alive and well at the grassroots level. Last but not least, I would like to thank our members for everything they do to make the FCSLA the great fraternal it is.

We, the first elected National Directors of our Association according to our new bylaws structure are proud to present our 2016 Annual Report. This is a new position replacing the previous position of National Vice President. We were present at the Home Office for all four scheduled meetings. We also participated by conference call, in all of the Special Meetings called by our National President. The National Directors actively participate on several committees.

At our first meeting in January an Orientation Meeting was held prior to the first board meeting which described the following: structure of our Association; position responsibilities; home office diagram and a Strategic Plan. This was an important training program created by leadership to jump start new board members and give them all the necessary tools to govern our Association. The information shared has proven to be critical in making swift and concise contributions to the board's decision making process. At this meeting, everyone was given an opportunity to ask questions and express their suggestions or concerns for the benefit our Association's future during the brainstorming portion. Within the Strategic Plan there are several board committees; the National Directors were given the opportunity to volunteer as members of these committees.

Our National President appoints board members to serve on these committees depending on the magnitude of each committee. In our report, we have listed our individual participation in board committees where we were appointed to serve. We have also reported our participation in Association events by individual involvement or appointed by our National President to represent our Association.

All members of the Board of Directors attended an informational session on using an iPad at our September Board of Directors Meeting. At our December meeting all board members were given an iPad and instructed to become familiar and comfortable with using it. The iPads are for sharing Association information and reports on a secured site.

National Director Jeanette Palanca is the Recording Secretary and participating member of the Philanthropic and Scholarship Committee. She is also a member of the 125th Anniversary Steering Committee and has participated in numerous meetings by conference call. Jeanette also represented the FCSLA, as a Board Member at the American Fraternal Alliance Annual Meeting held in Nashville, TN, in September of 2016. She attended several workshops and sessions, gaining valuable information on issues impacting our industry in the following: building a united fraternal services platform; forecasting the changes anticipated by the Department of Labor Fiduciary Rule; and innovations and communication strategies in our fraternal industry. Jeanette has attended all in-person meetings and conference calls spending a majority of time working with leadership on the mergers. She is now prepared to focus on our organization's relationship with our members, peers and competitors. Jeanette serves on the Convention Selection Committee. She and another board member visited

a hotel in the Chicago area recommended by a convention planner. Jeanette developed a spreadsheet that was very valuable in recording all the information obtained at a prospective hotel site in order to present information at our Board of Directors' Meeting. In her Anna Hurban District of Chicago, Jeanette serves on the district's board of directors as the recording secretary. She attends all district and local Association events as feasible.

National Director Sue Ann M. Seich serves on the Strategic Relations Committee. She has participated in several home office and conference call meetings with managing officers, actuaries, attorney and accounting personnel preparing information and statistics to be presented to the Board Members and membership. Sue Ann is a member of the Executive Committee and attended all home office meetings. She also serves on the Philanthropic and Scholarship Committee. ## YEAR OVERVIEW

The year 2016 is now a memory. In retrospect, it was a year of prudent adjustments and vigilant implementation of the bylaws adopted by the 41st Quadrennial Convention. The melding of incumbent members of the board and incoming members of the board, as always, required a period of adjustment, but we strive to be a cohesive board and to act for the good of the Association.

# STRATEGIC PLAN and COMMITTEES of the BOARD

We continued to administer principal aspects of our strategic plan through board committees. We served namely on the following committees: Philanthropic and Scholarship, Strategic Relations, Interim Secretary Interview, Board Performance and Review, 125th Anniversary and Convention Site Committees.

## **EXECUTIVE COMMITTEE**

By virtue of Article III, Section J of the Constitution and Bylaws, we serve on the Executive Committee where we discuss and analyze trends that may affect our products and financial outlooks. Furthermore, the convention minutes were reviewed and approved. We recommend action to the full board on quarterly annuity rates. Moreover, we review investment and FCSLA's current financial status as presented by the Treasurer. As part of our responsibilities, we approve acquisition of investments when called upon by the Treasurer. We recognize ongoing market volatility and continue to believe a prudent response to uncertainty is to maintain a diversified portfolio with tolerance for market volatility, time horizons and financial goals. The Association's assets are invested according to faith-based ethical principles. We are ever vigilant to changes in regulatory and legal requirements; especially in our state of domicile and in states where we are licensed to do business.

## **FINANCIAL OVERVIEW**

As a fraternal, our Association has a strong solvency ratio (1.13%). Investments are comprised of a mix of equities, bonds and money market funds. At year end, the Association recorded over \$866.5M in assets with a surplus of over \$99.5M. Consistent with our history of paying dividends, the Board of Directors approved approximately \$1.3M of dividends to be paid in 2016.

## **VOUCHER OVERVIEW**

A significant portion of vouchers are reviewed as well as all Visa and strategic files. Additionally, the 2015 conventions financial statements and files were audited. Vouchers are not approved until accuracy of the invoice is established and documentation of each bill is transparent.

## **BOARD OF DIRECTORS**

As members of the board of directors, we participated and voted at quarterly meetings and conference calls. Also, sales statistics and information presented by our managing officers were analyzed. The FCSLA's budget is prepared and reviewed on a line item basis, with final approval at the December board meeting. Budget discipline is exercised with the goal to achieve an operational budget surplus annually.

Compatible, solid opportunities for a merger with Polish Union of the United States of America (PUNA) and Polish Women's Alliance of America (PWAA) were presented to the board. After intense scrutiny and evaluation of documents presented to the board from the due diligence, discovery process performed by managing officers, actuaries, outside auditors and attorneys, the board approved submitting these mergers to the delegates for a vote to approve. The exercise of this task represented continuous time, special meetings and conference meetings with the managing officers and outside consultants on the part of the board. The board recognized the gravity of their decision, and the approval to put the question to the delegates for approval was not taken lightly.

## IN CONCLUSION

Fraternal, philanthropic, and benevolent works in our communities remain at the forefront of our efforts and goals with development of branch activities and duties, matching funds projects, scholarships and an annual charitable appeal. Relatedly, we attended Pennsylvania Fraternal Alliance Meeting and serve on board of the PFA, attended Pennsylvania Legislative luncheon, Northeast Pennsylvania Fraternal Alliance meeting, American Fraternal Alliance meeting, St. Vincent's benefit concert. Likewise, we are active at District and Branch functions and serve as officers of same. Many challenges were encountered this year; we believe we have addressed these challenges in a timely, perceptive manner.

# A Pinch of This ... A Dash of That!

## TURKEY SHEPHERD'S PIE

2 tablespoons extra-virgin olive oil

3 small carrots

1 cup frozen pearl onions

1 lb. lean ground turkey

1 tablespoon all-purpose flour

1 cup frozen peas

2½ teaspoons chopped fresh rosemary salt

Freshly ground pepper

3/4 cup low-sodium chicken broth

3 cups leftover mashed potatoes

Preheat oven to 400 degrees. In a large pan, heat olive oil over medium heat. Add carrots and onions and cook until soft, about 5 minutes. Add turkey and cook, breaking up meat with a wooden spoon, until browned, about 6 minutes. Stir in flour and cook 3 more minutes. Stir in peas and rosemary. Season with salt and pepper. Pour in chicken broth and stir. Bring to a simmer and cook until slightly thickened, about 5 minutes. Season with more salt and pepper. Transfer to a 9- to 10-inch deep-dish pie pan.

Spread mashed potatoes atop turkey mixture. Bake until golden on top and heated through, about 25 minutes.

# **VEGGIE FRIED RICE**

vegetable oil

3 garlic cloves, minced

1 onion, diced

1 carrot, diced

3 cup leftover cooked white rice

1 teaspoon kosher salt

½ cup frozen peas

½ cup frozen corn kernels

3 eggs, scrambled

2 scallions, chopped

In a large skillet over medium heat, warm

1 tablespoon oil and cook garlic, onions, and carrots, 4 to 5 minutes. Increase heat to medium-high, fold in rice and 1 teaspoon salt and cook until lightly toasted, 3 to 4 minutes. Add peas and corn and mix until warmed through.

Meanwhile, in a small non-stick skillet over medium-low heat, scramble eggs. Fold eggs and scallions into fried rice and serve immediately.

# SLOW-COOKER BALSAMIC CHICKEN

2 cup Brussels sprouts, trimmed and halved 2 cup baby red potatoes, halved

or quartered if large

4 boneless skinless chicken breasts

½ cup balsamic vinegar

1/4 cup low-sodium chicken broth

1/3 tablespoon brown sugar

2 tablespoons Dijon mustard

2 teaspoons dried thyme

2 teaspoons dried rosemary

1 teaspoon dried oregano

1 teaspoon crushed red pepper flakes kosher salt

Freshly ground black pepper

2 cloves garlic, minced

Freshly chopped parsley, for garnish

In a large slow cooker, add Brussels sprouts and potatoes in an even layer and place chicken on top.

In a small bowl, whisk together balsamic vinegar, chicken broth, brown sugar, mustard, dried thyme, rosemary, and oregano, and crushed red pepper flakes. Season generously with salt and pepper.

Pour marinade over chicken and vegetables. Scatter all over with garlicup

Cover and cook on high until chicken is fall-apart tender,  $4\frac{1}{2}$  to 5 hours.

Garnish with parsley and serve with the juices.

# CHEESECAKE-STUFFED STRAWBERRIES

1 cup cream cheese, softened

½ cup heavy cream

1/4 cup confectioners' sugar

1 pt. strawberries, bottoms and tops sliced off and hollowed out

Crushed graham cracker, for garnish

In a stand mixer fitted with the paddle attachment, beat cream cheese, 2 to 3 minutes. Add heavy cream and confectioners' sugar and beat until fluffy.

Transfer mixture to a piping bag and pipe into strawberries.

Garnish with crushed graham crackers and serve.

## TWIX CHEESECAKE

2 blocks cream cheese, softened

½ cup powdered sugar

½ cup caramel, plus more for drizzling

2 cups heavy cream

1 teaspoon vanilla

pinch of kosher salt

2 cups chopped Twix candy bars

1 prepared graham cracker crust

2 tablespoons melted chocolate,

for drizzling

In a large bowl using a hand mixer, beat cream cheese, sugar, and caramel until light and fluffy for 2 minutes.

Gradually add heavy cream and beat until stiff peaks form, then fold in vanilla, salt, and half the chopped Twix.

Pour pie filling into prepared crust and smooth top.

Refrigerate until firm, at least 6 hours and up to overnight.

Drizzle with caramel and melted chocolate. Sprinkle all over with remaining chopped Twix, then drizzle with more caramel.

# **CANNOLI CONES**

8 oz. cream cheese, softened

to room temperature

1/2 cup whole milk ricotta

1 teaspoon cinnamon

Pinch nutmeg

3/4 cup powdered sugar

2 cups heavy cream

1 cup mini chocolate chips

12 waffle or sugar cones

In a large bowl, beat cream cheese, ricotta, powdered sugar, cinnamon and nutmeg until smooth.

Gradually add in heavy cream and beat until light and fluffy. Fold in mini chocolate chips. Scoop into cones.

# **HEATH BAR DIP**

8 oz. cream cheese, softened to room temperature

½ cup brown sugar

1/4 cup powdered sugar

1 teaspoon vanilla extract

2 cups heavy cream

3 Health bars, chopped

1/4 cup caramel sauce

Pretzels, for serving

Apple slices, for serving

In a large bowl, beat cream cheese, sugars and vanilla together until smooth and fluffy. Gradually, beat in heavy cream, adding about ½ cup of cream at a time. Beat on high until light and fluffy. Fold in about two-thirds of Heath Bars. Transfer to a serving bowl and chill in the refrigerator until ready to serve.

When ready to serve, top the dip with the remaining chopped Heath bars. Drizzle with caramel sauce. Serve with preztels and apples for dipping.
