## **GROUNDS FOR INVALIDITY OF MARRIAGE**

My dear Sisters and Brothers,

Beginning in January of this year, our focus in these articles has been Irregular Marriages and most recently, what constitutes grounds for the invalidity of marriage according to the 1983 Code of Canon Law of the Roman Catholic Church. Namely, what is the meaning of some of the grounds and what proofs and requirements fall within the perimeter of these same grounds?

Last month I touched briefly on Canon 1095. Canon 1095 is basically referred to as being a psychological ground. The law presumes that individuals contracting marriage are willing and able to give consent to the marriage they wish to enter. However, if the consent of a party is defective, a true marriage cannot take place. Canon 1095 is made up of three parts. Number 1° deals with those who at the time of marriage lack a sufficient use of reason. A good example of this would be Stan who arrives for his wedding after partaking in a "few" drinks to "calm his nerves." Unfortunately he has calmed his nerves to the extent that he is slurring his words and is having some difficulty walking the proverbial "straight line." The marriage takes place, but was Stan able to give true consent in speaking his vows? In actuality the state of drunkenness negates his ability to give proper consent. Looking down the road, when the union eventually ends because of Stan's perpetual calming of his nerves through inebriation, his spouse most likely will petition for a Church annulment based on Canon 1095, Number 1°. A second example of a person who was unable to give valid consent would be an individual who is in and out of a coma. Is the individual's judgment impaired? Do they know what they consented to? Or was consent to marry given while in a delirium? This particular individual's consent is easily

Canon 1095, Number 2°, pertains to a person's inability to seriously evaluate the obligations and responsibilities of marriage as the Church understands. The ground is defined as "Grave Lack of Due Discretion." In the Tribunal where I serve as Judicial Vicar and Judge, in dealing with this ground we most commonly ask whether anything may have prevented either party from making a decision to marry that was truly free and well informed, such as: immaturity; fear or anxiety; a difficult home life; or a lack of positive examples of marriage and family life in their backgrounds. To illustrate, if Karen was raised in a home with an abusive and/or alcoholic parent, she would lack a positive example of family life which would prohibit a true understanding of the properties of Catholic marriage. Karen may also so desperately desire to leave her difficult family situation to the point that she consents to marry Bob despite the fact that she has reservations about his character. In this case Karen sees Bob as the first person who basically offers to be her rescuer. Marriage to Bob is simply the way out of her dysfunctional home life, and her consent is based on this. In either case, Karen's consent to marry would be defective. Immaturity is another good example of this ground. If two parties whose courtship and engagement consists of frequent

arguments and break-ups, or perhaps is fraught with evidence of abuse or of a partying lifestyle that shows no signs of stopping; yet they still move ahead with marriage despite the advice of family and friends not to marry; one can easily question their judgment and ability to make a true and evaluative decision to enter a lifelong marriage. In this case, the "red flags" were glaringly there yet the parties did not heed them.

Canon 1095, Number 3°, deals with an individual's actual incapacity to assume the essential obligations of marriage. The incapacity refers to a psychological or mental disorder that renders a person incapable of assuming the essential obligations of marriage as the Church understands. Some examples that fall within this ground are alcoholism, drug addiction, gambling, homosexuality/transvestitism and post-traumatic stress disorder. In cases of an actual mental disorder, proofs required for this ground normally must include evidence from at least one expert witness who can testify regarding the disorder.

In the Tribunal in which I serve, as well as the United States in general, Canon 1095 is the most widely used and proven grounds in Church annulment cases. In looking at divorce statistics in general, can one doubt the prevalence of defective consent in today's society when entering the sacred bond of Marriage?

#### MAY CROWNING AT YOUNGSTOWN DISTRICT MEETING

The Youngstown District held its spring meeting on Sunday, May 20, at the Ala Cart Catering Center in Canfield, OH. Dolores Sonoga, President of Branch 169 which hosted the event, welcomed the attendees.

President Bernadette Demechko also greeted the group and explained some important business would be held before the meeting. The Board had voted to increase the Board membership by adding one more Trustee since Branch 161 had no representative on the Board. Although the President is on the Board from Branch 161 the District Bylaws state that the President cannot vote on motions, except in the case of a tie vote. Therefore, at their April meeting Branch 161 members elected their President, Melanie Leonard, to represent them on the Board. The President administered the Oath of a New Member to Melanie and she spoke briefly about her commitment to serving her Branch, the District and FCSLA.

Since May is the month of the Blessed Mother, the Youngstown District always precedes its meeting with the crowning of the Blessed Mother Statue. Dolores and Melanie put a small wreath of flowers on Our Lady's statue while the group sang, "On This Day, O Beautiful Mother."

Following the May Crowning, a delicious sit-down dinner was served.

Secretary Dolores Sonoga read the roll and there were 125 attending from all eight Branches. She read the minutes which were approved and also the correspondence.

Treasurer Shelly Zura, read the financial report. Annual audit of the financial books will be held in June.

Bernadette stated she had attended the District Presidents' meeting at Headquarters in May. The National Board has a new policy of awarding funding to the Districts. They will still grant a bonus of \$3 for every new insurance/annuity certificate sold but only 5 of the 15 Districts met the quota of selling a \$1,000,000 in a year. The new system will include District projects: one insurance seminar available to District members a year can earn a District \$750 (money given according to District membership). \$250 per District event will be awarded and includes dinners, spiritual activities, or any group get-together. Maximum award will be three events or \$750. Our District received \$818 this year for our District events of the scholarship dinner, Christmas party and Mass/ dinner honoring the 125th anniversary of the First Catholic Slovak Ladies Association (FCSLA). The comparison was great - last year we received only \$350 and this year after completing and mailing in a District Activities Report we received \$815.

Bernadette gave the final report of the District's 125th FCSLA Mass and dinner. The District had been allotted \$3,000 (amount per District membership) and spent \$2,965 on the dinner, all rental items, and mailing of the 125th Anniversary calender, souvenir, pen, and dinner program booklet to 41 members who are in nursing homes, homebound or unable to attend but are interested in District events.

For the 125th anniversary, each District was asked to compile its history.

Agatha Fabiny, past District President, translated the District minutes from 1939-1981. They were written in long-

hand, in Slovak, in three journals. Since we now have those translations in English, the President took the three journals to Headquarters for their archives. They will be scanned so records will be at Headquarters but the actual journals will be donated to the Research Library of the Benedictine Monastery in Cleveland.

The President stated that President Cynthia Maleski gave an update on the merger of the Polish Union of the U.S. of North America (PUNA) and the Polish Women's Alliance of America (PWAA). 


officers. The District expressed their appreciation for the excellent luncheon and presented a check for the District's contribution and a Mass for the members of Branch 313.



## HOT CUCUMBER AND ARTICHOKE DIP

½ cup mayonnaise

1/2 cup grated Parmesan cheese

1/4 cup chopped green onion

1 (14-ounce) can artichoke hearts, drained and chopped

1 seedless cucumber, chopped

1 garlic clove, crushed, optional Crackers or rye bread

Heat oven to 350 degrees. Mix mayonnaise and cheese in a small bowl. Stir in green onion, artichoke hearts, cucumber and garlic. Spoon into a 1-quart casserole.

Cover and bake for 20-25 minutes, or until hot. Serve warm with crackers.

## GRILLED SPICY SCALLOPS

3 pounds scallops

2 teaspoons finely chopped fresh ginger

2 teaspoons finely chopped garlic

2 teaspoons finely chopped cilantro leaves

2 tablespoons chili sauce

2 tablespoons low-sodium soy sauce

½ cup fresh-squeezed orange juice

Pinch of ground black pepper

½ cup peanut oil

2 teaspoons toasted sesame oil

20 ounces European salad mix

2 carrots, julienned

½ cup prepared raspberry salad dressing

1 pint fresh raspberries

½ cup crumbled Gorgonzola cheese

Clean scallops and set aside. Prepare marinade: combine ginger, garlic, cilantro, chili sauce, soy sauce, orange juice, pepper, and peanut and sesame oils and mix well. Place scallops in the marinade and refrigerate for 1 hour, stirring from time to time.

Place scallops on a hot grill and cook approximately 2 minutes per side, depending on how well-done you like your shellfish.

Toss the salad greens and carrot with the raspberry vinaigrette, place on your favorite plate, set scallops around or on top of the salad, place a few fresh berries all around your plate, sprinkle with crumbled Gorgonzola.

## SPICY TOMATO BRUSCHETTA

Preheat oven to 325 degrees. Cut baguette diagonally into 24 slices; arrange on a baking sheet. Brush both sides of bread slices with 2 tablespoons of the olive oil. Bake until toasted and golden, about 6 minutes per side.

1 baguette

6 tablespoons extra-virgin olive oil, divided 12 tomatoes-on-the-vine, 6 red and 6 yellow, seeded and finely diced

4 garlic cloves, finely minced

2 small jalapeño peppers, seeded and minced

1/2 cup chopped fresh basil

Generous pinches of salt and freshly ground black pepper

6 ounces soft, mild goat cheese

Combine 4 tablespoons olive oil, tomatoes, garlic, jalapeños, basil, and salt and pepper to taste in a medium bowl. Spread goat cheese over toast; arrange in a single layer on a baking sheet. Mound tomato mixture on toast. Bake on the center oven rack until heated through, 5-8 minutes. Transfer bruschetta to a platter and serve immediately.

#### GRANDMA JANE'S APPLE CAKE

1½ cups sugar

½ cup vegetable oil

2 large eggs

2 cups unbleached white flour

1 teaspoon baking soda

1 teaspoon baking powder

½ teaspoon salt

1 teaspoon ground cinnamon

½ teaspoon ground nutmeg

½ teaspoon ground cloves

3 cups peeled, sliced Washington apples (any combination of Braeburn, Fuji, Gala or Red Delicious)

1 cup chopped pecans or walnuts

Preheat oven to 350 degrees. Combine all ingredients in a large bowl. Mix with a wooden spoon until combined; dough will be very stiff. Spread in a buttered 9x13-inch pan.

Bake for 35 minutes, or until a toothpick inserted in the center comes out clean. This is excellent for picnics; it keeps well and stays moist.

#### **COUNTRY PEACH TART**

Pastry dough for single-crust 9-inch pie 4 cups peeled, sliced fresh peaches

or frozen peaches, thawed

12 packets Equal sweetener (or ½ cup Equal Spoonful or Equal Sugar Lite)

1 tablespoon all-purpose flour

½ teaspoon ground cinnamon

1/4 teaspoon almond extract

Preheat oven to 425 degrees. Roll out pastry dough on a floured surface into a 12-inch circle; transfer to an ungreased baking sheet. In a bowl, combine peaches, Equal, flour, cinnamon and almond extract; toss until peaches are coated.

Arrange peaches on pastry, leaving a 2-inch border around the edges. Bring pastry edges toward the center, overlapping as necessary.

Bake for 25-30 minutes, or until the crust is golden brown and the peaches are tender. Serve warm or at room temperature. Makes 8 servings.

#### **APPLE SAUCE BROWNIES**

1 cup firmly packed brown sugar

½ cup margarine or butter, softened

2 eggs

1 cup Regular or Cinnamon Apple Sauce

1 teaspoon vanilla extract

1 cup all-purpose flour

1/4 cup unsweetened cocoa

1 teaspoon cinnamon

½ teaspoon baking powder

½ teaspoon baking soda

1/4 teaspoon salt

1/2 cup chopped nuts

Preheat oven to 350 degrees. Grease a 9-inch square pan. In a large bowl, combine brown sugar, margarine and eggs; mix well.

Stir in apple sauce and vanilla; blend thoroughly. Stir in flour, cocoa, cinnamon, baking powder, baking soda and salt; mix well. Stir in nuts. Pour into prepared pan.

Bake for 25-35 minutes, or until a toothpick inserted in the center comes out clean. Cool on a rack; cut into squares.

#### CHERRY-BERRY SMOOTHIE

3 cups fresh pitted dark sweet cherries

3 cups frozen whole strawberries (unsweetened)

3 cups cran-cherry juice

In a blender, purée half the fresh pitted dark sweet cherries, half the frozen strawberries and half the cran-cherry juice, stirring as needed, until smooth.

Pour into 2 serving glasses. Repeat with the remaining ingredients for 2 more servings. Makes four 12-ounce servings.
