

As I was sitting outside this morning sipping my coffee and watching the sun climb over the horizon, I looked down and saw a curved stick on the ground that reminded me of a boomerang.

Suddenly I was caught up in memories of me as a youngster, playing for hours on end in my backyard with a small wooden boomerang I had been given as a gift.

Remember when you were a kid, how fascinated you were with boomerangs? (At least I was!) You take this flat, curved piece of wood and throw it, then watch in amazement as it curves around in the air and comes right back to you!

As "miraculous" as that seemed when we were kids, I've found as I have gotten older that most of our life is like that. Whatever we "throw" out there, comes back to us.

We live in a "boomerang" world. Let me explain. If you smile at someone, in almost every case, they will smile back. Try it now with someone nearby, and see if it works.

My dear Sisters and Brothers,


In the past two articles written by yours truly, the focus was on two widely used grounds for Catholic Church annulment; namely, Canon 1095 and Canon 1101. There are, of course, other possible grounds, and this month I will briefly highlight some of them.

Canon 1096–Ignorance. §1. For matrimonial consent to exist, the contracting parties must be at least not ignorant that marriage is a permanent partnership between a man and a woman ordered to the procreation of offspring by means of some sexual cooperation. §2. This ignorance is not presumed after puberty. Examples of this would be a person who is developmentally disabled, quite young or naïve, or who had a very sheltered upbringing, all characteristics that might render a person ignorant of one or more properties of marriage. Can a 13-year old give valid consent to marriage? Does a 13-year old really know what marriage entails?

Canon 1097 – Error of Quality (or Error of Fact). **§1.** *Error concerning the person renders a marriage invalid.* §2. *Error concerning a quality of the person does not render a marriage invalid even if it is the cause for the contract, unless this quality is directly and principally intended.* It is an error regarding some characteristic in the other person that must be an enduring quality. An example: Brad tells Melissa that he is a millionaire; Melissa is overjoyed and marries him; Melissa then discovers that in actuality not only is Brad not a millionaire, he is bankrupt.

#### In Honor of the Sorrows of the Blessed Virgin Mary

O most holy and afflicted Virgin! Queen of Martyrs! thou who didst stand motionless beneath the Cross, witnessing the agony of thy expiring Son--through the unceasing sufferings of thy life of sorrow, and the bliss which now more than amply repays thee for thy past trials, look down with a mother's tenderness and pity on me, who kneel before thee to venerate thy dolors, and



place my requests, with filial confidence, in the sanctuary of thy wounded heart; present them, I beseech thee, on my behalf, to Jesus Christ, through the merits of His own most sacred death and passion, together with thy sufferings at the foot of the cross, and through the united efficacy of both obtain the grant of my present petition. To whom shall I resort in my wants and miseries if not to thee, O Mother of Mercy, who, having so deeply drunk of the chalice of thy Son, canst compassionate the woes of those who still sigh in the land of exile? Offer for me to my Savior one drop of the Blood which flowed from His sacred veins, one of the tears which trickled from His divine eyes, one of the sighs which rent His adorable Heart. O refuge of the universe and hope of the whole world, do not reject my humble prayer, but graciously obtain the grant of my petition. Had Melissa known this about Brad, she may not have married him.

Canon 1098 – Fraud (or Imposed Error): A person contracts invalidly who enters into a marriage deceived by malice, perpetrated to obtain consent, concerning some quality of the other partner which by its very nature can gravely disturb the partnership of conjugal life. For example, an individual married not knowing that his or her spouse was a felon, or perhaps not knowing that his or her spouse had a disease like AIDS. If either of these would have been concealed, the marriage would be invalid because the individual was deprived of the freedom of choice had he or she known.

Canon 1099 – Error of Law (Or Determining Error): Error concerning the unity or indissolubility or sacramental dignity of marriage does not vitiate matrimonial consent provided that it does not determine the will. A good example of this is a person who has a divorce mentality formed by the beliefs of a family background that is prevalent with divorce to the point that the person is convinced that a possible future divorce is clearly acceptable when entering his or her own marriage.

Canon 1102: Condition: §1. A marriage subject to a condition about the future cannot be contracted validly. §2. A marriage entered into subject to a condition about the past or the present is valid or not insofar as that which is subject to the condition exists or not. In other words, the condition is attached to the marriage and can refer to a circumstance from the past, present or future. Some examples: "I will marry you if you promise to build me a big house" or "will be a pop star" or "will be rich by the time you are 40" or "are a virgin." Is it a valid marriage if you marry with a circumstance attached to the marriage?

Canon 1103: Force and Fear – "A marriage is invalid if entered into because of force or grave fear from without, even if unintentionally inflicted, so that a person is compelled to choose marriage in order to be free from it." An example here is one with which we are all familiar: Shotgun wedding!

Ron is very involved in FCSLA at the District level as well. He currently serves as the District Treasurer. He organizes the Nebraska District Summer Picnic in North Bend every year. He manages the Nebraska District Christmas Party held in Prague each December. Ron also has served on the National FCSLA Court of Appeals. Ron and his wife Deb attend the National Conventions held every four years, serving as Delegates and they both represent our local and district chapters well. He is a strong advocate for FCSLA at the local, District and National levels.

Ron is instrumental and involved in every one of Branch W013 sponsored

activities. Branch W013 is very active, and Ron is at the forefront in managing and assisting with ALL of the events. Every year our Branch has participated in the Matching Funds program by sponsoring projects and events. 



#### Congratulations to Frances A. Miklovic of Jr. Branch 11, St Louis, MO FCSLA 2018 Youth of the Year

Frances has initiated, the first ever for Jr. Branch 11, Matching Funds Projects at St. Simon the Apostle Parish, (where she attended grade school) First there was the Backpack Buddies' program where monetary donations were collected throughout the school and parish (St. Simon the Apostle) to procure backpacks and fill them with nutritional food items for distribution to schools where a significant number of students, who are at-risk of hunger, don't have consistent access to enough nutritious food. Many of these children rely on school meals to provide breakfast and lunch during the school year. During breaks, such as weekends and holidays, many of these children go home to little or no meals.

The second project was the Ugandan Cow Project fundraiser securing funds, throughout the school and parish

(St. Simon the Apostle), to procure milk cows for families at a ranch in Uganda who will then raise the cows for milk and mate them to breed additional cows that could be sold or used to generate more milk that can be sold, in essence, to decrease the malnutrition among Ugandan children. Doing community service and helping other people made Frances realize that she is very blessed and she wanted to give back to others the opportunity to be strong and healthy. Frances' efforts reaped three cows from school collection. Each cow cost \$800.

Next, Frances created for Sr. Branch 101 a Matching Fund golf challenge at golf course green #14 that challenged golfers to 'land' on the green with their initial drive during the St. Simon the Apostle Parish Youth Ministry Golf Tournament. Frances welcomed over 250 golfers at green #14 verbally 'challenging' each one of them to donate \$5.00 to support the transportation needs of the Youth Ministry for their summer Steubenville Retreat in Springfield, MO. Every golfer accepted her challenge without reservation – generating \$476 – Total net receipts for the tournament was over \$8,007.

During our annual Branch Business and Holiday Luncheon, Frances and other Jr. Branch 11 members act as hostesses welcoming other branch members distributing FCSLA 'freebies' as attendance prizes.

For quite a few years Frances has participated in a program called "Ryan's Pillow Case for Smiles" where pillowslips are created for children struck with cancer who spend time in the hospital for chemotherapy – at St. Simon the Apostle & St. Mary Magdalen Parishes. A hospital experience can be terrifying and traumatic for both a child and their family. While others strive to find a cure, Ryan's Pillow



Case for Smiles helps with the stress and emotional impact of illness in the here and now. The whimsical pillow cases, created by the two groups that Frances sews for, gives children an emotional boost, while resources and tools help families better understand and cope with the experience. Sadly, the stream of sick children never ends!

After the Freshmen girls' volleyball season had ended, Frances learned that her coach, who had never coached volleyball, was the school's mentor for the debate team. Frances' coach advised that the only reason he took the volleyball coaching position was because he had learned that if no one 'stepped-forward' there would be no team. Now the coach was having a hard time filling the debate team with participants. Frances volunteered to help her 'coach' by volunteering to participate.

Frances, and other teenaged high school girls, 'started' a Church Ministry group, "The Pro-s," supporting the following activities - pro-life and service at St. Dominic Savio Catholic Church in South County St. Louis; at the Pauline Books & Media (inventorying and categorizing religious books); the Franciscan Sisters (sorting donated baby clothes for the local Birthright Agencies). With minimal adult supervision, this group of young women adopted their own bylaws and a vision statement for spreading the pro-life message which advocates that human life begins at conception and that the human embryo is a person and, therefore, has a right to life. The Pro-s also provided 'fundraising service' where needed in the pro-life community thru fundraisers benefiting The Mother's Inn & Nurses for Newborns. She received her Girl Scout Marian award thru the Pro-s. The Pro-s also assisted the St. Dominic Savio Catholic Church in South County with the planting of spring flowers on their Parish campus.

The Youth Ministry at St. Simon the Apostle has a group called – Luke 18 Retreat Leaders. Frances is a youth-leadermember of this Youth Ministry that assists in the Luke 18 Retreat. Luke 18 is a youth group focused on helping kids find their way to God through a spiritual retreat held at St. Simon the Apostle Church annually. The group's 'vision' is based on that bible passage. The retreatants are aged anywhere from 11-15 who find their way to God through this retreat.

Frances helped promote and 'run' the children's Holy Hour at St. Simon the Apostle which encompassed one hour, weekly, of adoration with confession followed by benediction – the process being 'kid-friendly.'

Frances was selected to be a St. Simon the Apostle Ambassador, which entailed acting as a Hostess to parents

and outsiders for school events and being tour guides during Catholic Schools Week celebrations and Open Houses. Frances has participated in this service for three years, which is normally a one-year assignment. While at St. Simon the Apostle she has been an Honor Student for four years in a row – 5th thru 8th grade.

Frances assisted, at St. Simon the Apostle, during the summer, as a counselor for the following summer programs 1) Vacation Bible School – Camp Counselor organizing and supervising snack and game time; 2) Lady Bug Camp – Camp Counselor for girls ages 3-9 supervising craft projects / nature education / addressing proper etiquette thru the study of the Blessed Mother.

Frances is a genuine, polite, energetic and kindhearted soul. Frances has made meaningful contributions in not only her personal life with family and friends, but also for her school and surrounding communities and religious agencies. Her participation in church activities is motivated by a strong sense of moral and human ethics as she demonstrated with her participation with her church and Catholic ethic by attending the January 2018 Pro-life March in Washington, D.C. with her Youth Ministry Club sponsored by her parish. Additionally, in her first year of high school, she has maintained 4.00 GPA. Her intelligence, confidence, and strong values and respect are undoubtedly making a difference in the community around her.

Frances is the oldest of five children and there are two birds and one fish that cohabitate in her residence. Frances loves all sports, and, as previously reported, participated in high school volleyball and looks forward to being the boy's volleyball high school manager. She is an excellent seamstress (sewing Boy Scout patches for her brothers and Dad who are all 'scouters') and she loves to knit hats for babies!

Branch President Jerry Holmes presented Lauren and Josh with a gift from the branch.



#### My Mom: Martha Parry

On July 28, 2018, my mom, Martha Sipka Parry turned 100 years old. She was the former president of St. Mary's Branch 2 of Yonkers, NY. Other members of the branch are grandsons Clifford and Matthew Ainsworth, niece Sue Gagner, and me, her son Richard Parry.

The 100<sup>th</sup> birthday celebration was well attended by friends and family from all over the US as well as maternal and paternal family members from Bratislava and Veselé Slovakia.

Mom's mother, Suzanna Nemec, came to America in 1912 from Šaštín, Slovakia. Mom was delivered at home by a midwife in Newark, NJ. She was a first generation born



American, the oldest of three children.

Suzanna was unable to support three children, so my mother entered a foster home at the age of 5. It was not uncommon for my mother to be treated badly including corporal punishment which was a prevalent practice in foster homes at the time.

Mom was raised in a Slovak neighborhood in New Jersey and spoke only Slovak. It wasn't until she was in a foster home that she was exposed to English.

My mother married in 1941. Dad joined the Navy during WWII and mom worked in a factory riveting military planes, she was "Rosie the Riveter".

My sisters and I lived in the Bronx and attended Catholic schools. We all made it through school and have mom to thank.

Mom worked for New York City in various administrative positions. She would routinely take civil service exams to advance in her career.

It was not until my sisters and I left home that my mother was able to pursue her dream of a college degree. For 5 years she worked during the day and attended school at night. At the age of 60 she received a BS degree from SUNY.

In 1984 mom retired. She travelled several times to Slovakia to bond



the family and keep the family relationship alive. She also entered several Senior Olympic events and has medals to prove it.

Mom lost her husband in 1991, her daughter Lonnie in 2002 and her other daughter Joanne in 2013.

In 2013 mom moved to San Diego where we both live today. She has lived through the Great Depression, the loss of a mother, a father, a husband, two sisters, two daughters, and yet she overcame these tragedies. She is a friend to all that meet her. She smiles and laughs and few would believe the many bumps in the road she travelled; I'm proud to call her my mom.

#### **Epiphany of Our Lord Parish Benefit**


Monessen Jr. Branch recently conducted a matching funds project for the Epiphany of Our Lord Parish in Monessen, PA.



#### **HONEY GARLIC GLAZED** SALMON

- 3 tablespoons extra-virgin olive oil
- 4 (6-oz.) salmon fillets, patted dry
- with a paper towel
- <sup>1</sup>/<sub>3</sub> cup honey
- 1/4 cup soy sauce
- 2 tablespoons lemon juice 1 teaspoon red pepper flakes
- kosher salt
- Freshly ground black pepper
- 3 cloves garlic, minced
- 1 lemon. sliced into rounds

In a medium bowl, whisk together honey, soy sauce, lemon juice and red pepper flakes.

In a large skillet over medium-high heat, heat two tablespoons oil. When oil is hot, but not smoking, add salmon skin-side up and season with salt and pepper. Cook salmon until deeply golden, about 6 minutes, then flip over and add the remaining tablespoon of oil.

Add garlic to the skillet and cook until fragrant, 1 minute. Add the honey mixture and sliced lemons and cook until sauce is reduced by about a third. Baste salmon with the sauce. Garnish with sliced lemon and serve.

#### **FAVORITE SLOW COOKER CHICKEN**

2-3 lbs. boneless chicken breasts 2 (8 oz.) blocks cream cheese 2 (1 oz.) packets dry Ranch seasoning 8 oz. bacon, cooked crisply and crumbled

Place first three ingredients in a slow cooker. Cook on low setting for 8 hours, until chicken is cooked through.

Uncover. Shred the chicken. Add in crumbled bacon and stir to incorporate. Serve warm.

#### **MARINADED PORK CHOPS**

1/2 cup extra-virgin olive oil 1/4 cup apple cider vinegar 1/4 cup brown sugar 2 tablespoons grainy mustard 2 garlic cloves, minced <sup>1</sup>/<sub>2</sub> teaspoon red pepper flakes Kosher salt Freshly ground black pepper

4 pork chops

In a large bowl whisk all ingredients together and season with salt and pepper. Pour marinade over pork chops and refrigerate at least 2 hours.

In a large skillet over medium heat, heat oil and cook pork chops until golden and cooked through, 7 minutes per side.

#### PERFECT ZUCCHINI BREAD

#### Cooking spray

- 1<sup>1</sup>/<sub>2</sub> cups all-purpose flour
- 1 teaspoon cinnamon
- 1 teaspoon nutmeg
- 1 teaspoon baking soda
- 1/2 teaspoon baking powder
- 1/4 teaspoon kosher salt
- 1/2 cup (1 stick) unsalted butter, melted, cooled slightly
- 1 cup sugar
- 1 teaspoon pure vanilla extract
- 1 egg plus 1 egg yolk
- 1<sup>1</sup>/<sub>2</sub> cup grated zucchini (about 1 medium zucchini)

Preheat oven to 350 degrees. Grease an 9"x5" loaf pan with cooking spray, line with parchment, then lightly grease again.

In a large bowl, whisk together flour, cinnamon, nutmeg, baking soda, baking powder, and salt.

In another large bowl, stir together melted butter, sugar, and vanilla. Mix in egg and egg yolk, then fold in zucchini.

Fold wet ingredients into flour mixture until completely incorporated.

Transfer mixture to prepared pan and bake until a toothpick comes out clean, 45 to 48 minutes.

Let cool slightly in pan, then transfer loaf to a wire rack to let cool completely.

#### CHEESECAKE POPS

- 12 oz. cream cheese, softened
- 3 tablespoons sour cream
- 1/2 cup powdered sugar
- 1 teaspoon pure vanilla extract
- 1/4 teaspoon kosher salt
- 1 cup chopped strawberries
- 1/4 cup crushed graham crackers
- 15 popsicle sticks (depending on your ice cube tray)

In a large bowl using hand mixer, beat cream cheese, sour cream, powdered sugar, vanilla, and salt until smooth. Fold in strawberries.

Spoon mixture into ice cube tray then sprinkle graham crackers on top.

Insert a popsicle stick into the middle of each cheesecake cube.

Freeze until the cheesecake mixture is solid. Remove from ice cube tray and serve immediately.

#### **FROZEN SAMOA PIE**

For The Crust: 50 Vanilla Wafers 6 tablespoons melted butter 1/4 cup sugar For The Filling: 4 oz. cream cheese, softened 1 can sweetened condensed milk 1 teaspoon pure vanilla extract 1/2 teaspoon kosher salt 1 cup Cool Whip, defrosted 4 cups toasted coconut, divided 2 cups caramel, melted and divided

- 1 cup mini chocolate chips
- 1 cup semisweet chocolate chips, melted

Crust: In a food processor, pulse vanilla wafers until they are fine crumbs. Transfer crumbs to a bowl, then add butter and sugar and stir until combined. Grease a 9" pie plate and press in the crust mixture.

Filling: In a large bowl using a hand mixer, beat cream cheese until smooth. Mix in sweetened condensed milk, vanilla and salt until fully incorporated. Fold in Cool Whip.

Middle layer: In a medium bowl, mix 2 cups toasted coconut with 1 cup caramel.

Pour half the cream cheese mixture into the pie pan and cover with coconut caramel. Smooth to the edges to make a layer.

Top with the remaining cream cheese mixture, then add the remaining 2 cups toasted coconut and mini chocolate chips. Drizzle with remaining caramel and melted chocolate and freeze until firm, about 4 hours. Serve.

#### **BAILEYS FROZEN** HOT CHOCOLATE

Ice, for blending 4 cups chocolate milk 4 (1-oz.) packets hot cocoa mix 4 oz. Baileys Irish Cream Whipped cream, for serving Chocolate syrup, for serving Chocolate shavings, for garnish

Fill a blender with ice, then pour over chocolate milk, hot cocoa mix, and Baileys. Blend until frothy.

Drizzle chocolate syrup inside each glasses, then pour over frozen hot chocolate. Top with whipped cream and chocolate shavings.
