DIRIMENT IMPEDIMENTS

My dear Sisters and Brothers in Christ,

This month we conclude our year-long topic of the Sacrament of Marriage and especially the processes with which the Church handles invalid and irregular marriages. In this final article for 2018 I give you a brief explanation of "diriment impediments."

We all should know what the word "impediment" means; namely, an obstacle or impairment. However, the phrase "diriment impediment" is not used as commonly and is mostly attributed to Catholic marriage. It is defined as "a disability that makes void a marriage contracted even with the required legal solemnities." This is not the same as grounds which need to be proven in order to receive a Church annulment. So what does this exactly mean? Canon 1066 states, "Before a marriage is celebrated, it must be evident that nothing stands in the way of its valid and licit celebration." It refers to a factor or impedi-

ment which invalidates a marriage, such as the existence of a prior marriage. Allow me to provide you with a list of diriment impediments. Some are rare while others are more common.

Canon 1083 refers to the age requirement for a valid marriage. If the man is under 16 years of age, or the woman is under 14 years of age, then their marriage is invalid.

Canon 1084 is regarding "antecedent and perpetual impotence to have intercourse, whether on the part of the man or the woman."

Canon 1085 states that if one of the parties to a marriage was bound by a previous, valid marriage at the time of the exchange of consent, the validity of the marriage can be challenged. This type of case is called *ligamen* (prior, valid bond).

Canon 1086 concerns with what we call Disparity of Cult (or Worship). A marriage between a Catholic and a non-baptized person is invalid, unless they receive a dispensation from the Bishop or his delegate.


Canons 1087 and 1088 refer to those who have received Sacred Orders or who have taken a perpetual vow of chastity. Any attempt at marriage by either is invalid.

Canon 1089 states that no valid marriage can exist between a man and a woman who has been abducted.

Canon 1090 is something that may be seen in today's headlines. A pair who wishes to marry collaborated to kill the spouse of one of them in order that they might be free to marry. An interesting fact: Only the pope may dispense this impediment but there are no instances in which any pope has done so.

Finally, Canons 1091 through 1094 refer to lineage and the marriage of parties who are closely related by blood or even adoption.

This past year you have all taken a short course in the various Church canons pertaining to marriage. As Judicial Vicar in the Diocese of Youngstown it has been my privilege to provide you with an insight into these processes that take place in the Tribunals of each diocese. As we approach the celebration of Christmas, I ask that you all recall the message of the heavenly angels on the glorious night of Our Lord's birth: "Glory to God in the highest; and on earth peace to men of good will" (Luke 2:12). And to all of you, *Vesele Vianoce*!

LIFE INSURANCE: TOO MANY QUESTIONS, TOO MANY CHOICES AND TOO MANY DECISIONS

Question 1: What type of life insurance should I consider? There are two basic types of coverage: PERMANENT or TERM.







Consular Tour Huge Success



Cookie Swap!

PINE NUT COOKIES

Makes 3 dozen cookies ½ cup (1 stick) unsalted butter, at room temperature

½ cup plus 2 tablespoons sugar 1 teaspoon pure vanilla extract

1 teaspoon ground fennel seed

1/4 teaspoon salt

1 large egg

1/4 cup pine nuts

11/4 cups all-purpose flour

In a large bowl, beat the butter, sugar, vanilla, ground fennel seed, and salt with an electric mixer until light and fluffy. Beat in the egg. Add the flour and mix just until blended.

Transfer the dough to a sheet of plastic wrap and shape into an 8-inch-long log. Wrap the dough in plastic and refrigerate for 2 hours. Preheat the oven to 350 degrees. Line 2 heavy, large baking sheets with parchment paper.

Cut the dough log crosswise into ½-inch-thick slices. Transfer the cookies to the prepared baking sheets, spacing evenly apart. Press the pine nuts decoratively atop the cookies, and bake until the cookies are golden around the edges, about 15 minutes. (The cookies can be made 1 day ahead. Store airtight at room temperature.)

LEMON RICOTTA COOKIES

Makes about 45 cookies

21/2 cups all-purpose flour

- 1 teaspoon baking powder
- 1 teaspoon salt
- 1 stick unsalted butter, softened
- 2 cups sugar
- 2 eggs, at room temperature
- 1 (15-ounce) container whole milk ricotta cheese
- 3 tablespoons lemon juice
- 1 lemon, zested

For the glaze:

11/2 cups powdered sugar

- 3 tablespoons lemon juice
- 1 lemon, zested

In a medium bowl combine the flour,

baking powder, and salt. In the bowl of an electric mixer combine the butter and the sugar. Beat the butter and sugar on medium speed until light and fluffy, about 5 minutes. Add the eggs, 1 at a time, mixing between additions until well incorporated. Add the ricotta cheese, lemon juice, and lemon zest. Beat to combine. Fold in the dry ingredients. Tightly cover the dough with plastic wrap and refrigerate overnight.

Preheat the oven to 375 degrees. Line 2 baking sheets with parchment paper. Scoop the dough (about 1½ tablespoons for each cookie) onto the baking sheets. Bake for 15 minutes, until cooked through but still pale. Remove from the oven and let the cookies rest on the baking sheet for 15 minutes. Continue with the remaining dough.

For the glaze, combine the powdered sugar, lemon juice, and lemon zest in a small bowl and stir until smooth. Spoon about ½-teaspoon onto each cooled cookie and use the back of the spoon to gently spread. Let the glaze harden for about 2 hours.

CHEWY SUGAR COOKIES

Makes 4 dozen cookies

23/4 cups all-purpose flour

1 teaspoon baking soda

½ teaspoon baking powder

1 cup softened butter

11/2 cups white sugar

1 egg

1 teaspoon vanilla extract

3 to 4 tablespoons buttermilk

Sprinkles or colored sugar, for decorating Preheat oven to 375 degrees.

In a small bowl, stir together flour, baking soda, and baking powder. Set aside.

In a large bowl, cream together butter and sugar until smooth. Beat in the egg and vanilla. Gradually blend in dry ingredients. Add enough of the buttermilk to moisten the dough and make it soft, not wet.

Roll rounded teaspoons of dough into balls and place on an ungreased cookie sheet. With a brush or fingers, moisten the top of each cookie with the remaining buttermilk and slightly flatten the top of each cookie. Sprinkle with raw sugar or colored sprinkles.

Bake for 8 to 10 minutes or until slightly golden. Let stand for 2 minutes before removing to cool on a rack.

WHITE CHOCOLATE CRANBERRY COOKIES

Makes 2 dozen cookies

½ cup unsalted butter, softened

½ cup packed light brown sugar

1/2 cup granulated sugar

1 tablespoon vanilla extract

1 large egg

1½ cups all-purpose flour

11/2 teaspoons baking soda

1 cup dried cranberries, chopped

3/4 cup white chocolate chips

3/4 cup macadamia nuts, chopped

Preheat the oven to 350 degrees F. Line 2 baking sheets with parchment paper.

With an electric mixer, cream the butter and both sugars together until smooth. Add the vanilla and egg, mixing well.

Sift together the flour and baking soda. Spoon the flour mixture gradually into the creamed sugar mixture. Stir in the cranberries, white chocolate chips and macadamia nuts.

Drop by heaping spoonfuls, about 2 tablespoons, onto the prepared baking sheets, 2 inches apart. Bake one sheet at a time until lightly golden on top and the edges are set, 12 to 15 minutes. Cool on the sheet about 5 minutes, and then transfer to a wire rack to cool completely. Store in an airtight container for up to 2 weeks.

COCONUT MACAROON

Makes about 20 cookies

14 ounces sweetened shredded coconut

14 ounces sweetened condensed milk

1 teaspoon pure vanilla extract

2 extra-large egg whites, at room temperature

1/4 teaspoon kosher salt

Preheat the oven to 325 degrees. Combine the coconut, condensed milk, and vanilla in a large bowl. Whip the egg whites and salt on high speed in the bowl of an electric mixer fitted with the whisk attachment until they make medium-firm peaks. Carefully fold the egg whites into the coconut mixture. Drop the batter onto sheet pans lined with parchment paper using either a 1¾-inch diameter ice cream scoop, or 2 teaspoons. Bake for 25 to 30 minutes, until golden brown. Cool and serve.

PEANUT BUTTER-CHOCOLATE NO-BAKE COOKIES

Makes about 60 cookies

2 cups sugar

½ cup milk

1 stick (8 tablespoons) unsalted butter

1/4 cup unsweetened cocoa powder

3 cups old-fashioned rolled oats

1 cup smooth peanut butter

1 tablespoon pure vanilla extract

Large pinch kosher salt

Line a baking sheet with wax paper or parchment. Bring the sugar, milk, butter and cocoa to a boil in a medium saucepan over medium heat, stirring occasionally, then let boil for 1 minute. Remove from the heat. Add the oats, peanut butter, vanilla and salt, and stir to combine.

Drop teaspoonfuls of the mixture onto the prepared baking sheet, and let sit at room temperature until cooled and hardened, about 30 minutes. Refrigerate in an airtight container for up to 3 days.
