



SECOND JOYFUL MYSTERY: THE VISITATION

Dear Sisters and Brothers,

Our second Joyful Mystery is the Visitation. The Visitation is the visit of Mary, who was pregnant with Jesus, to St. Elizabeth, who was pregnant with John the Baptist, as recorded in the Gospel of Luke. The spiritual fruit associated with this mystery is love of neighbor. The story of the Visitation gives us a timeless lesson of our need to take care of each other.

At the time of the Annunciation, which was our first Joyful Mystery, we know the Angel Gabriel came to announce to Mary that she had been chosen by God to bear his Son by the power of the Holy Spirit. We also know that initially Mary may have had some doubt as to what was being revealed to her. It was not that Mary doubted the word of God. It was simply that she was filled with fear and astonishment. Sensing this the Angel Gabriel reassured Mary that he spoke the truth by making it known to her that with God nothing is impossible, for God had blessed her cousin Elizabeth by allowing her to conceive a child. Elizabeth had suffered with infertility and was now past her childbearing years but was miraculously in the sixth month of a pregnancy.

Learning of her cousin's condition, the first thing Mary did was prepare to go to Elizabeth, to be of service to her in any capacity needed. She could have considered her own condition since she now too was with child, and not just any child, but the Son of God! Instead Mary was most likely overjoyed at hearing the news about her cousin. And since both were in the same condition and since both were carrying children as a result of God's miraculous intervention, they certainly had much to share between them.

The journey to Elizabeth's home was almost 100 miles. According to the Bible, Elizabeth lived in the hill country

of Judea. It would take four or five days of an arduous trip marked by rough terrain, in some type of rude transportation or perhaps even by foot. Yet Mary had so much love and joy in her heart that she never considered the hardship, only her mission of charity, inspired by her devotion to God.

Upon arriving Mary entered and greeted Elizabeth. "At the sound of Mary's greeting, Elizabeth's child leaped within her, and Elizabeth was filled with the Holy Spirit." (Luke 1:41) This was the meeting of their unborn children. One might say that the child Elizabeth was carrying, John the Baptist, was already anticipating his role of preparing the way for the Messiah. At that moment he is sanctified in Elizabeth's womb and cleansed from original sin. The unborn John was filled with the Holy Spirit by Christ himself who Mary had just conceived by the Holy Spirit. Elizabeth then exclaims, "Blessed are you among women, and blessed is the fruit of your womb! And how have I deserved that the mother of my Lord should come to me?" (Luke 1:42-43) By these words Elizabeth recognized and confirmed the Angel Gabriel's message that Mary had indeed conceived the Son of God and that all ages would proclaim Mary blessed as the Mother of God.

The Visitation is one of the sources of the Hail Mary whose words have been prayed many billions of times in countless languages and will go on for ages to come. How appropriate that the Hail Mary is a vital part of the Rosary in which the second Joyful Mystery is the Visitation. With Easter coming this month, may we all continue to pray the Rosary in anticipation. May you and your family reap the harvest of your Lenten tasks as you enter once again into the Paschal Mystery of Jesus.

IMPORTANT 2020 IRA TAX LAW CHANGES

MINIMUM REQUIRED DISTRIBUTION (MRD) – The age requirement to begin minimum required distributions was increased from age 70½ to age 72 for individuals who attain age 70½ after 12/31/19.

CONTRIBUTION AGE RESTRICTION – The maximum age restriction for contributions to traditional IRA's has been removed. Individuals can contribute at any age as long they meet all other criteria including having earned income.

NON-SPOUSE INHERITED IRA – Required distribution rules for non-spousal inherited IRAs have been changed. Please consult with your tax advisor to review these changes.

Blessing Baskets



The blessing of food baskets on Holy Saturday is a long-standing Central/Eastern European tradition that has been brought to the U.S. by immigrants from Slovakia, Poland, Lithuania, etc. Many times the baskets of food are covered with elaborate, hand embroidered cloths that are only used on Holy Saturday.

The tradition celebrates our joy of the Resurrection. The foods in the basket are our Easter meal and represent fare traditionally abstained from during Lent (in times when Lenten regulations were much more severe than today): meat, butter, rich breads, desserts. The food is placed in a wicker basket and brought to the church on Holy Saturday where it is blessed in a short liturgy.

The rules are relaxed for the modern Easter basket at the pre-feast blessing, but Slovak tradition calls for nine items to be in it.

They are:

Eggs: Brightly decorated eggs are a symbol of new life in the risen Christ.

Pascha, or Easter bread: It's sweet and rich in eggs and butter. It's a symbol of Christ, Christians' "true bread."

Kielbasa: A spicy sausage that indicates God's favor and generosity.

A piece of uncooked bacon, cured with spices: It symbolizes the abundance of God's mercy.

Salt: It reminds people to flavor their dealings with others by Christ's example.

Ham: It was popular with Czechoslovakians because of its richness, and it is symbolic of Easter's great joy and abundance.

Cheese: A custard-style cheese, shaped into a ball and having a bland but sweet taste, indicates the moderation Christians should have in all things.

Horseradish and beets: They symbolize the suffering of Christ, who was put to death on a cross and rose from the dead three days later, defeating the sins of the world.

Butter: It's shaped like a lamb, a small cross or placed in a glass dish. It reminds people to have Christ-like goodness toward all things.

HONEY GLAZED HAM

1 (5 pound) ready-to-eat ham

1/4 cup whole cloves

1/4 cup dark corn syrup

2 cups honey

²/₃ cup butter

Preheat oven to 325 degrees.

Score ham, and stud with the whole cloves. Place ham in foil lined pan.

In the top half of a double boiler, heat the corn syrup, honey and butter. Keep glaze warm while baking ham.

Brush glaze over ham, and bake for 1 hour and 15 minutes in the preheated oven. Baste ham every 10 to 15 minutes with the honey glaze. During the last 4 to 5 minutes of baking, turn on broiler to caramelize the glaze. Remove from oven, and let sit a few minutes before serving.

SLOVAK EASTER PASKA BREAD

2 cups milk

½ cup sugar

2 teaspoons salt

12 ounces butter (3 sticks)

3 (1/4-ounce) packages active dry yeast

1 tablespoon sugar

1 cup warm water (no hotter than 110 F)

3 large eggs (room-temperature)

8 cups all-purpose flour (divided)

1 cup milk (or 1 beaten egg yolk, to wash the dough)

Grease three (7x3-inch) round bread pans and set aside.

In a small saucepan, heat 2 cups milk, ½ cup sugar, salt, and butter over low heat until butter melts and sugar dissolves. Cool to lukewarm and set aside.

Dissolve yeast and 1 tablespoon sugar in warm water placed in a mixing bowl or

stand mixer bowl that has been warmed. Let proof for 5 minutes.

Add eggs, reserved milk mixture, and 4 ½ cups of the flour. With the dough hook attachment, mix on speed 2 for 1 minute.

Continue mixing on low speed, and add remaining flour, ½ cup at a time and mix about 2 minutes or until dough clings to hook and cleans sides of the bowl.

Continue mixing 2 minutes longer or until dough is smooth and elastic. It will be sticky to the touch.

Place dough in a greased bowl, turning to grease top. Cover and let rise in warm place about 1 to 2 hours or until doubled.

Punch down dough and divide into thirds, reserving a small piece of dough from each to make decorations.

Shape each third piece of dough into a round loaf in the prepared pans. Using reserved dough, decorate with a cross in center or braids around the edge. Cover and let rise in warm place, 1 to 2 hours or until doubled.

Heat oven to 350 degrees. Gently brush tops of risen dough with milk or beaten egg yolk. Bake 40 minutes or until golden brown and an instant-read thermometer registers 190 degrees.

Remove from pans immediately and cool on wire rack.

FRESH BEET HORSERADISH

2 medium (10 ounce) beets

One 4-ounce fresh horseradish, peeled

1/4 cup cider vinegar

2 teaspoons salt

1 teaspoon sugar

Scrub beets; trim stems to ½ inch. Place beets in a medium saucepan; add water to cover by 1 inch. Bring to a boil over high heat. Reduce heat to medium high; cook at a gentle boil until beets are tender when pierced with a small, sharp knife, 30 to 40 minutes. Remove from heat, drain, and set beets aside until cool enough to handle.

Meanwhile, grate horseradish on small holes of a box grater. Place in a small bowl; stir in vinegar, salt, and sugar.

Peel beets; grate on small holes of box grater. Add to horseradish mixture; stir well to combine. Keep covered to preserve flavor, and refrigerate until needed.

POPPY SEED ROLL

1/2 pound poppy seeds

3/4 cup white sugar

1 tablespoon butter, melted

1 teaspoon lemon juice

½ cup hot milk

1 (.25 ounce) package active dry yeast

½ cup warm water (100 degrees

F/38 degrees C)

2 tablespoons white sugar

2 cups all-purpose flour, or more if needed ½ teaspoon salt

½ cup butter

1 egg, separated (white reserved)

Place poppy seeds into a food processor and process until seeds are ground, about 1 minute. Mix poppy seeds with ¾ cup sugar, 1 tablespoon melted butter, lemon juice, and hot milk in a bowl; stir to combine. Cover poppy seed filling and refrigerate while making bread (filling will set up and thicken as it chills).

Mix yeast with water and 2 tablespoons sugar in a small bowl. Allow to stand until the yeast forms a creamy layer.

Whisk flour with salt in a bowl; use a pastry cutter to cut ¼ cup butter into the flour mixture until the mixture resembles coarse crumbs.

Pour yeast mixture and egg yolk into flour mixture and stir to make a soft dough.

Turn dough out onto a floured work surface and knead until smooth and slightly springy, about 5 minutes. If dough is too sticky, knead in more flour, about 2 table-spoons at a time.

Cut dough into 2 equal pieces. Roll each piece out into a 12x16-inch rectangle.

Spread half of the poppy seed filling in each rectangle, avoiding the edges.

Roll up (on the long side), pinching to seal the dough, tucking the end underneath and pinching to keep the filling from leaking out.

Line a baking sheet with parchment paper; place rolls seam sides down on the baking sheet. Cover with dish towel and allow to rise in a warm place until doubled, about 1 hour.

Preheat oven to 350 degrees F (175 degrees C).

Beat egg white in a bowl until frothy; brush the rolls with beaten egg white.

Bake in preheated oven until dark golden brown on top, 30 to 40 minutes. Remove from oven and cover rolls with a clean kitchen towel until cool to keep crust soft. Cool completely before slicing.

PUFFED RICE EASTER BASKETS

3 tablespoons dark corn syrup

1 tablespoon butter

½ cup sugar

1/₃ cup water

1/4 teaspoon salt

2 tablespoons vinegar

Boil the above ingredients. Remove from stove and add ¼ teaspoon baking soda.

Place one box of Puffed Rice cereal in large bowl. Pour syrup mixture over top and mix with wooden spoon. Mold while hot in cereal bowls, forming a nest in center.

Color one package of coconut with green food coloring. Arrange coconut in nest for green grass. Add candy chicks and bunnies, and Easter eggs.
