

My dear Sisters and Brothers,

It may seem strange to be writing about the Christmas story in June when our summer is coming but we are specifically writing about the Nativity, which is our third Joyful Mystery. Actually it may not be so strange to write about the Nativity at this time of year since it is believed that Christ's birth actually happened in late spring when it would be normal for shepherds to be tending to their sheep and baby lambs. The spiritual fruit associated with this month's joyful mystery is Poverty of Spirit and Detachment from the Things of the World, inviting us to question what possessions we truly need, as well as what we can share with others.

We all have Nativity scenes displayed in our homes during the holiday season. Some are simple figurines; others are life-size versions like those we see in front of churches or in some front yards. The display, of course, features Mary and Joseph along with the Christ Child in a manger. Going further we would include perhaps at least two shepherds with their lambs, and of course the three wise men set back a little further since they were not part of the first group of worshipers. And we can't forget the ox and the donkey in the background. Topping it all off is an angel standing behind the Holy Family or perhaps near the roof of the stable, glorifying this miraculous event. This manger scene is a tradition in many homes, as it is in mine, a scene that has been carried on for many generations.

You may be surprised to know that this centuries-old tradition of the Nativity that we share now is not so much described in such detail in the Bible as it is credited to St. Francis of Assisi who first displayed the Nativity scene with which we are all familiar.



St. Francis was truly a holy man who devoted his life to observing the holy Gospel while espousing a life of poverty. Several years before his death, Francis asked a loyal friend to help him prepare a live Nativity scene that would vividly display the humble and difficult circumstances of Christ's birth. That Christmas in a cave near Greccio, Italy, the friend prepared St. Francis' vision of how the infant Jesus was born in Bethlehem, laid in a manger upon the hay that was there for the ox and ass nearby. The scene exemplified poverty and humility which, of course, was the intent of St. Francis, whose Order was founded with these same principles.

We ask ourselves how is it that the King of Kings was born in the humblest of surroundings? He was not born into a wealthy or prominent family in the city of Jerusalem, but in Bethlehem, which by today's standards would have been considered a "Podunk" town. The Child Jesus was not laid on a soft covering in a cradle but in a feeding trough for animals. The first visitors who came to greet the Son of God were not the overly religious men of Jerusalem but lowly shepherds who were looked down upon since their work kept them from participating in religious activities that were expected at that time. God's plan was clear at the Nativity to show through the birth of his Son how we are called to live – that a humble life was the path to eternal life. Christ's life would be a continuing example of this.

Ironically, despite God's message at the Nativity, the Christmas season has become one of lavish spending and decorating. Each time we pray the rosary and as we repeat this third Joyful Mystery of the Nativity, let us all be reminded to strive to live a more humble and meek life. All of the worldly possessions we accumulate mean nothing if we forget God's message as shown in the Nativity. In the end God will not judge us by our net worth but by whether we lived a life as set by the example of Christ's life from the time of His Nativity until His death.

# **FCSLA** Introduces Our New Term Life Insurance Products

Through the hard work and dedication of the leadership of FCSLA we now have two additional products to augment our portfolio of enhanced insurance products. In April, we covered our new and improved permanent life insurance products that are available to protect you, your family, and your future. This month I would like to also give you a brief description of FCSLA's two term products.

Let's start with our 20-year level term plan which is available for members ages 18 to age 75. Minimum face amount is \$25,000 with a maximum of \$100,000. With this term life certificate:

- Your family will receive large, short term (20 Years) death benefit coverage at an affordable price.
- It allows your family to replace your income, pay off debts, fund education savings plans, and more in the event of your death during the term period.
- Premiums are guaranteed not to increase for the entire term of 20 years.
- Prior to age 75, you can convert to any permanent plan offered by FCSLA for the same or less insurance coverage, without evidence of insurability before the end of the 20 years term.
- The certificate may not be renewed.
- This is a participating term life contract and may be eligible for dividends.\*

(\*dividends are a return of premium and are not guaranteed)

Most people, when they think of life insurance, do not picture a policy with cash values. They envision life insurance as simple as paying premiums in exchange for a death benefit when they die. This is exactly the principle of term life insurance. Let me give you a few common uses of term life insurance.

#### • PAY OFF FINAL EXPENSES

When a person dies, his family is grief-stricken from the emotional loss. The last thing they want to deal with is final expenses as a result of the death. Such expenses include burial costs, final medical bills, probate costs, lawyer's and executor's fees, and the final tax return. Proceeds from a term plan can be used to pay for these expenses.

#### • MORTGAGE ON THE HOME

Family could select a death benefit that matches the mortgage on the home, so the spouse does not have the burden of monthly mortgage payments. Besides mortgages, term life insurance is also effective for paying off other debts.

Many folks have student loans, car loans, credit card debt and the list could go on and on.

#### • INCOME REPLACEMENT

It is difficult when you lose a family member and a tremendous burden if they are an income earner and you lose their paycheck too. After all, bills still need to be paid and food still needs to be put on the table after the death of the income earner. FCSLA's 20-year term life insurance can be used to alleviate the financial loss. The certificate is taken on the income earner(s) of the family to provide for his/her family in case of death during his/her prime working years. This often necessitates the family sitting down together and calculating figures such as the annual income, annual fixed expenses, number of years till retirement, and inflation to reach a conclusion on just how much death benefit will be required.

#### CONVERT TO PERMANENT PROTECTION

One of the most common use of term life insurance is conversion. That is, foreseeing a future permanent need while also having a temporary need for life insurance. A temporary need may be to provide for the family, with the permanent need being to leave an enough to the surviving spouse so as not to change her/his style of living. - At conversion, a maximum credit of \$1.00 for each \$1,000 of insurance times the number of years the Next Gen Term has been in effect. # **Update on Polish Women's Alliance Archive Preservation Project**

In cooperation with the Women & Leadership Archives (WLA) at Loyola University in Chicago, the preservation of our historical documents, photos and memorabilia began in late 2019 after fundraising efforts over several years.

The total amount needed to fund this important project totaled \$ 27,600. Through the generous support of individuals, Z-Groups, Councils & Districts, that goal was realized in 2019.

Antoinette Trela delivered the final donation to the PWA Preservation Project at the 25th Anniversary of the Women & Leadership Archives that took place on September 27th, 2019.

Currently, our treasured historical items are being worked on by the conservators at The Conservation Center of Chicago. As many of these items are very old and, in some cases, in need of major restoration, this process will take some time. In addition, the WLA is handling some of the work in house. The final objective is to have our Archives available in digital format on the WLA internet platform so that individuals, researchers, and parties world-wide, interested in the significant accomplishments of women throughout the past century will have this information readily available. In addition, the physical items are housed at the WLA located in the historic Piper Mansion on the grounds of Loyola University's Lakeshore Campus. Anyone wishing to view a sampling of these items are welcome to contact the WLA to schedule an appointment.

The latest treasures that were added to our Collection in November 2019 are a Medal and Certificate issued by the Polish government, honoring PWA President Honorata Wolowska as being the founding Vice President of the Pol-

Father said he had no intention of becoming a priest after studying speech therapy at Edinboro University, but a friend who happened to be a priest mentioned to him the prospect of joining the priesthood. "I planned on going to graduate school" he said. "I never gave it much thought".

Regardless of where he serves, Father Mike works to bring the community together through prayer and activities that involve all ages. He is a very caring person and everyone enjoys listening to him. Sunday's parade only reinforced to Crookston that he made the right choice 40 years ago. "It all has to do with the people here" he said. "It all comes down to the warmth and the goodness of the people".





#### Vit J. Kreil, W109





#### **Approval of the Minutes**

President Maleski noted the minutes were distributed in advance and if there are no corrections, then the minutes will stand as approved.

#### **National President's Comments**

#### Sales

President Maleski noted that Pennsylvania was #1 in life and annuity sales combined as of September 30, 2019. Nebraska was second and Ohio was third. Life and annuity sales were up 31% from the prior year. We had the guaranteed issue program this year until August 31, 2019, the branch membership challenge and the Cruise to the New Membership Drive and all 3 programs had an impact on increasing our sales.

#### 2017 CSO Mortality Table Plan Project

President Maleski stated all 7 products have been filed with the IIPRC. The IIPRC covers 42 states and we also have filed our products with the 7 other states. The two SPWL products have been approved by the IIPRC. We have three whole life products that have been developed. In addition, two term products have been developed, the 20-year level term and the juvenile term to age 30. Internal testing has been completed, marketing materials are being developed on the remaining products and we await approval from IIPRC for these remaining products. National Trustee Virginia A. Holmes joined the meeting at 9:45 a.m. and it was noted that National Chaplain Monsignor Peter M. Polando due to an illness will be absent.

#### 2019 Quadrennial Convention

President Maleski states that in order to continue to enhance our image and build more engagement with the branches and the district, we sent out a letter to the board, district presidents and donation committee to work together to make the donation check presentations. We believe this effort will continue to build our image and presence as a charitable and benevolent society in the communities across the country. President Maleski suggested that we contact the local media and that we take photos of the check presentations. In the past, we sent out the checks directly to the charities. To build more engagement with the members and to enhance the process we asked for local participation to deliver the checks by November 20, 2019. The checks remaining in the home office by this date will be sent directly to the charities.

#### **Court of Appeals**

There are 2 vacancies on the Court of Appeals that need to be filled by this board. The vote will take place at the December board meeting. The vacancies were announced at the convention, it was advertised in the magazine and letters were sent to previously interested candidates who had previously expressed an interest in this role. As of today, 15 members have asked for intent forms and 3 intent forms have been returned.

#### **Marketing Rebranding**

The marketing firm that we have engaged is working on Phase II (Brand Development) and will update the officers on naming concepts, logo, brand positioning statement and tagline options. Then we will present Phase II to the board. We asked the marketing firm for their assistance on a new name for our new product series.

#### 2023 Convention Planning

President Maleski stated that there needs to be some discussion regarding the goal of the convention in terms of accessibility of those who are in our strong bands of membership. Several fraternals are making parts of the members/ branches in their convention or as a tag along at the end as a family focus event for broader engagement.

#### **Ohio Department Insurance (ODI)**

The five-year focus exam has begun with FCSLA presenting material in an electronic format. Phase I the IT portion has been submitted and in mid-November we will need to submit a report on several other areas including planning, governance, and other areas. The exam has expanded from being a financial exam only to a focus review of several other areas. We anticipate ODI will be on site for face to face meetings after the first of the year.



Participation is open to members of the following Fraternals: First Catholic Slovak Ladies Association, Polish Falcons of America, Polish National Alliance and Polish Roman Catholic Union and to student members of a Polish American Congress Division or National. Membership will be verified prior to your acceptance. #### SUN-DRIED TOMATO AND RICOTTA BRUSCHETTA

 $\frac{1}{2}$  (12-ounce) baguette 2 tbsp. refrigerated pesto

<sup>1</sup>/<sub>2</sub> cup part-skim ricotta cheese

- 1⁄4 tsp. salt
- 1/4 cup drained chopped oil-packed

sun-dried tomatoes

Prepare outdoor grill for direct grilling on medium.

Meanwhile, brush cut sides of baguette with pesto. In small bowl, combine ricotta and  $\frac{1}{4}$  teaspoon salt.

Place baguette on grill, cut sides down, and cook about 2 minutes or until toasted. Transfer to cutting board.

Spread ricotta mixture on grilled sides of baguette; top with sun-dried tomatoes. Cut each crosswise into 6 pieces.

#### STRAWBERRY COBB SALAD

For the green goddess dressing

- 1 cup store-bought ranch dressing
- 1/2 bunch flat-leaf parsley

3 tbsp. thinly sliced chives

8 large basil leaves

For the salad

2 tbsp. extra-virgin olive oil

2 (6-oz.) boneless skinless chicken breasts kosher salt

- Freshly ground black pepper
- 2 romaine hearts, shredded
- 12 strawberries, hulled and thinly sliced
- 1 avocado, pitted, peeled and thinly sliced
- 1/8 red onion thinly sliced
- 4 oz. crumbled goat cheese
- 2 oz. thinly sliced prosciutto
- 1 hard-boiled egg, quartered

Make the dressing: Place all ingredients in a blender and blend until smooth. Set aside.

Preheat oven to 350. In a skillet over medium-high heat, heat oil. Season each chicken breast with salt and pepper and place in the skillet. Sear chicken, 3 to 4 minutes per side. Transfer skillet to oven and continue to cook, 8 minutes. Remove from heat and transfer chicken to a cutting board. Cool 7 to 10 minutes before slicing.

To assemble: Pour half the dressing into a large mixing bowl and toss together with shredded romaine. Transfer coated romaine to a serving bowl and top with sliced chicken breasts, strawberries, avocado, onion, goat cheese, prosciutto, and egg. Season entire salad with salt and pepper.

Serve entire salad, family style, alongside remaining dressing.

#### SHRIMP SCAMPI FLATBREAD

2½ tbsp. extra-virgin olive oil, divided
2 tbsp. butter
3 cloves garlic, minced
Pinch crushed red pepper flakes, plus more for garnish
1½ lb. large shrimp, peeled and deveined kosher salt
Freshly ground black pepper
Juice and zest of 1 lemon
1 large store-bought flatbread
2 cup shredded mozzarella
Chopped fresh parsley, for garnish Preheat oven to 400. In a large skillet

over medium-high heat, add 2 tablespoons oil and butter. Add garlic and cook until fragrant, 1 minute. Add red pepper flakes and continue to cook, 1 minute more. Add shrimp and season with salt and pepper. Sear 2 minutes per side. Deglaze pan with lemon juice until most of the liquid has evaporated, then remove from heat.

Place flatbread on a baking sheet and brush with remaining  $\frac{1}{2}$  tablespoon oil. Sprinkle with  $\frac{1}{2}$  cups mozzarella and top with shrimp mixture. Top with remaining mozzarella and bake until cheese is melty and flatbread golden, 12 to 15 minutes.

Garnish with red pepper flakes, parsley, and lemon zest.

#### BAKED GARLIC-BUTTER SALMON

- 2 lemons, thinly sliced 1 large salmon fillet (about 3 lb.) Kosher salt
- Freshly ground black pepper

6 tbsp. butter, melted

2 tbsp. honey

- 3 cloves garlic, minced
- 1 tsp. chopped thyme leaves

1 tsp. dried oregano

Chopped fresh parsley, for garnish

Preheat oven to 350. Line a large rimmed baking sheet with foil and grease with cooking spray. To the center of the foil, lay lemon slices in an even layer.

Season both sides of the salmon with salt and pepper and place on top of lemon slices.

In a small bowl, whisk together butter, honey, garlic, thyme, and oregano. Pour over salmon then fold up foil around the salmon. Bake until the salmon is cooked through, about 25 minutes. Switch the oven to broil, and broil for 2 minutes, or until the butter mixture has thickened. Garnish with parsley before serving.

#### **OREO CHEESECAKE BITES**

Oreo Cookies (18 whole cookies plus about 8 to chop up) 12 oz. cream cheese at room temperature ½ cup sugar

2 eggs, lightly beaten

1/2 cup of sour cream

- 1 tsp. vanilla
- ¼ tsp. salt

Preheat the oven to 275 degrees, place 18 cupcake liners in muffin tins, then place an Oreo at the bottom of each one.

In a large mixing bowl, beat the cream cheese until it is smooth. Add in the sugar and mix until smooth. Mix in the beaten eggs and the vanilla, scraping down the sides of the bowl when necessary. Add in the sour cream and salt. Mix well. Carefully spoon batter into lined muffin tins until they are filled about  $\frac{2}{3}$  of the way.

Coarsely chop Oreos and add to the top of each mini cheesecake. Bake at 275 for about 20-23 minutes until set. Let cool completely and refrigerate for at least 2 hours before serving.

To serve, carefully peel off the cupcake liners and arrange on a platter.

#### **CARAMEL APPLE GRAPES**

1/2 lb. seedless green grapes

1 cup caramel vodka, for adults

(or any other type of fruit juice)

1 cup melted Caramels, approximately 25 1 cup chopped peanuts

Soak grapes in caramel vodka (or juice) and refrigerate 1 hour. Drain grapes and pat dry with paper towels.

Poke toothpicks in grapes, then dip in caramel and peanuts. Transfer to a parchment-lined baking sheet to let set.

#### PEANUT BUTTER MARSHMALLOW SQUARES

Cooking spray

2 cups butterscotch chips 1 cup peanut butter 4 tbsp. butter ½ tsp. pure vanilla extract Pinch kosher salt

1 (10-oz.) bag rainbow marshmallows

Grease a 8"-x-8" baking pan with cooking spray. In a medium saucepan over medium heat, melt butterscotch chips, and peanut butter together. Turn off heat then stir in vanilla and a pinch of salt. Let cool to room temperature. Stir in marshmallows then pour into prepared pan. Refrigerate until set, 2 hours.
