FCSLA Bylaws Proposed Revision

DECLARATION ON THE RELATIONSHIP OF THE CHURCH TO NON-CHRISTIAN RELIGIONS (*Nostra Aetate*)

My dear Sisters and Brothers,

It is amazing to me that you and I journey in this world amid more than seven billion other human beings that inhabit the earth. We are different nationalities yet we strive to better ourselves and those around us in order to build up a better environment through the basics – food, shelter, employment, the raising of our families, health care, and in reaching self-fulfillment. You and I as members of the First Catholic Slovak Ladies Association attempt to build on these basics through the expression of our Catholic Faith. We note, however, that other people do so through their expression of their beliefs – other Christians and non-Christians. The bishops of the Second Vatican Council made some profound statements about other world religions in the Declaration on the Relationship of the Church to Non-Christian Religions, entitled in Latin as *Nostra Aetate*. The document is short but I believe that it expresses Christianity's respect for these world religions and I am going to quote to you some of the Fathers words when it comes to these particular expressions of belief.

The bishops begin by stating, "For all peoples comprise a single community, and have a single origin, since God made the race of man dwell over the entire face of the earth (cf. Acts 17:26). One also is their final goal: God. His providence, His manifestations of goodness, and His saving designs extend to all men (cf. Wis. 8:1; Acts 14:17; Rom. 2:6-7; 1 Tim. 2:4) against the day when the elect will be united in that Holy City ablaze with the splendor of God, where the nations will walk in His light (cf. Apoc. 21:23) [paragraph one].

The Fathers of the Council then gave deep respect for the religions of the world and noted them in the following ways:

- Thus in **Hinduism** men contemplate the divine mystery and express it through an unspent fruitfulness of myths and through searching philosophical inquiry. They seek release from the anguish of our condition through ascetical practices or deep meditation or a loving, trusting flight toward God.
- **Buddhism** in its multiple forms acknowledges the radical insufficiency of this shifting world. It teaches a path by which men, in a devout and confident spirit, can either reach a state of absolute freedom or attain supreme enlightenment by their own efforts or by higher assistance [paragraph two].
- Upon **Moslems**, too, the Church looks with esteem. They adore one God, living and enduring, merciful and all-powerful, Maker of heaven and earth and Speaker to men. They strive to submit wholeheartedly even to His inscrutable decrees, just as did Abraham, with whom the Islamic faith is pleased to associate itself. Though they do not acknowledge Jesus as God, they revere Him as a prophet. They also honor Mary, His virgin mother; at times they call on her, too, with devotion. In addition they await the day of judgment when God will give each man his due after raising him up. Consequently they prize the moral life, and give worship to God especially through prayer, almsgiving, and fasting [paragraph three].
- The Church, therefore, cannot forget that she received the revelation of the Old Testament through the people with whom God in his inexpressible mercy

deigned to establish the Ancient Covenant. Nor can she forget that she draws sustenance from the root of that good olive tree onto which have been grafted the wild olive branches of the Gentiles (cf. Rom. 11:17-24). Indeed, the Church believes that by His Cross, Christ, our Peace, reconciled Jew and Gentile, making them both one in Himself (cf. Eph. 2:14-16). Also, the Church ever keeps in mind the words of the Apostle about his kinsmen, 'who have the adoption as sons, and the glory and the covenant and the legislation and the worship and the promises; who have the fathers, and from whom is Christ according to the flesh' (Rom. 9:4-5), the son of the Virgin Mary. The Church recalls too that from **the Jewish people** sprang the apostles, her foundation stones and pillars, as well as most of the early disciples who proclaimed Christ to the world [paragraph four].

The Fathers emphasized that the Church rejects nothing that is true and holy in these world religions and it repudiates all persecutions against any person. As people who are made in the image and likeness of God, we must reflect our belief in the Creator who showed His love in making us and we in turn reflect that image in the love we have for one another. We must not discriminate because of race, color, or religion.

But when we turn on the news each evening, violence and wars are tearing our world apart, sometimes in the name of religion. Let us attempt to eradicate these by living good Christian lives and exhibit Christ's as faithful followers in the Catholic Church! Pokoj!

Waller, has devoted countless hours in orchestrating the committee meetings, developing timelines for the work as divided into several areas, and keeping the committee on target with the timeframes we have developed. Each committee member also devoted many hours to studying and arriving at consensus to develop this document.

Please join me again in thanking the Chair, Barb Waller, and all members of the committee for the REMARKABLE JOB they have done in arriving at a document which is customized to meet our needs, taking into account our history and traditions, to move us forward well into the 21st century.

On the opposite page, a summary of the essential elements of this core corporate document is highlighted for your information. Our branch officers, members of our board of directors and other leaders have received drafts and have been given an opportunity for comments which have been reviewed and responded to by the committee.

These recommendations provide membership criteria which allow for a reasonable path for our growth while recognizing our roots. They concisely lay out positive standards for qualifications for leadership for our association, which is of considerable financial strength and stability and doing business across our country.

We have the opportunity to take a positive leap forward in approving this revision for the benefit of our beloved association for many years to come. Please pray that the Holy Spirit will continue to guide us!

DRAFT BYLAW REVISION HIGHLIGHTS

as of July 21, 2014

It is important to note that much of the content of the draft Bylaw revision is very similar to the current Bylaws of the Association. (FCSLA). Throughout the entire process the Bylaw Revision Committee has worked to retain the tenants and principles of our founding members as set forth in our Articles of Incorporation.

This Bylaw draft has been through many committees reviews and restructuring processes both on the sub-committee and full Bylaw Revision Committee levels. During the review/restructuring, all of our members' comments were incorporated into the process. It has always been reviewed by our attorney for legal requirements, structure and necessary content.

There are five (5) significant areas that differ from our current bylaws. These points are listed below:

1. Membership – The Association will have two membership categories in order to expose more people to our traditions, culture and values. To advance fraternalism and share our common bond, all members are encouraged to participate in fraternal activities.
 - a. Principal Member
 - i. Slovak, Slavic descent
 - ii. Catholic of any Ritual Church
 - iii. A person of any other creed who is married to a Catholic of Slovak/Slavic descent.
 - iv. Family member of a principal member subject to review by the Board of Directors (BOD).
 - v. Insured in only those classes of insurance, including annuities and in such amounts as approved by the BOD.
 - vi. Not to exceed the age of fifteen(15) years for a juvenile applicant, and not less than sixteen(16) years for an adult applicant, or as defined from time to time by the BOD.
 - b. Affiliate Member
 - i. A Christian who is following their belief.
 - ii. Insured in only those classes of insurance, including annuities and in such amounts as approved by

the BOD, but does not meet the principal member qualifications.

- iii. Entitled to all the Association's fraternal benefits.
- iv. Does not have voting privileges at any level.
- v. Not eligible to hold office at any level.
- vi. Not to exceed the age of fifteen(15) years for a juvenile applicant, and not less than sixteen(16) years for an adult applicant, or as defined from time to time by the BOD.

2. Leadership (Governance)

- a. Composition of the Board of Directors (BOD) elected by the Convention
 - i. National President
 - ii. National Chaplain
 - iii. Two (2) Trustees
 - iv. Three (3) Auditors
 - v. Four (4) Directors
 - b. National Secretary and National Treasurer
 - i. Hired by the National President subject to approval of the BOD
 - ii. Reports to the National President
 - iii. Serve as staff at the BOD meetings with no voting rights
 - c. Qualifications of all elected members of the BOD and Court of Appeals
 - i. At least age thirty-five (35) years of age
 - ii. Be a Principal Member of the Association for a minimum of four (4) years prior to December 31st of the year preceding the Convention
 - iii. Be of Slovak/Slavic heritage
 - iv. Be a Catholic of any Ritual Church
 - v. Have active Association experience
 - vi. Possess a Bachelor's Degree with five(5) years work experience in fields including but not limited to fraternal, non-profit, management, insurance, and/or business or other relevant work experience; **OR** possess ten (10) years work experience in fields including but not limited to fraternal, non-profit, management, insurance, and/or business or other relevant work experience.
 - vii. Meet the qualification specific to the office that he/she is seeking
 - viii. Several restrictions for BOD candidates have been added to reduce the possibility of any conflict of interest.
 - d. Convention Election Process
 - i. All candidates seeking elected office (National Officers and Court of Appeals) will submit an intent form and resume sixty (60) days prior to the convention.
 - ii. All the intent forms and resumes will be verified by an outside company or committee of non-Association members as to their accuracy. This verification process will be determined by the BOD at least one hundred twenty days (120) prior to the Convention.
 - iii. All qualified candidates will be put forward as the final slate of candidates for each elected office.
- ## 3. Court of Appeals
- a. Will consist of five (5) members
 - b. Will appoint a presiding moderator for each appeal
- ## 4. Special Conventions
- a. Will have the same number of delegates as the Quadrennial Convention
 - b. Delegates and alternates chosen for the Quadrennial Convention will retain their voting privileges until the next Quadrennial Convention; therefore, if a Special Convention is called they will serve as the delegates.
 - c. Will be conducted by all acceptable means as described in the most current version of Roberts Rules of Order. At this time it would allow for voting by mail.
- ## 5. Districts are defined in these draft Bylaws.

Is Life Insurance Bought or is it Sold?

Early in my career, while attending my company's Leaders Conference, I heard a veteran salesman speak. The reason he was speaking is that he had not had one week in 20+ years where he had not sold at least one life insurance policy. He started his talk by saying that he had been asked to speak about how he sold life insurance which had enabled him to compile such a fabulous sales record. In his best Oklahoma drawl, this gentleman said the words which I have

remembered for over forty years. He said, **"Well, I'll tell you how I sell, but before I do, I'm going to tell you how I really sell. If I don't have an application on Thursday, somebody in Muskogee is fixin' to buy some life insurance!"**

I have always remembered this remarkable statement by a truly dedicated salesman and have used it many times to remind myself (and other salespeople) that, in most cases, a life insurance policy is sold rather than bought.

In recent years, with the advent of the internet, it is easy to go to virtually hundreds of websites and get quotes on life insurance. A motivated person could spend all day, every day, checking prices from a myriad of insurance companies, only to wind up more confused than before starting the search for the "best" price. There are just too many companies, too many policies and too many unanswered questions. The end result of the search is probably no life insurance being purchased at all! This is a real tragedy for the survivors of a death! While the intention to take care of the family through the purchase of life insurance was there, the final "push" to solve the problem was not present and so no life insurance was purchased.

I have always believed that a life insurance agent provides several "value added" features in the purchase of a life insurance policy. First, a good agent will do some fact finding and use this information to help the prospect see how much life insurance is required to solve whatever problem exists. I have always reminded agents that they did not create these problems; rather they have the responsibility to provide solutions to the problems. And this is a tremendous value of buying from an agent. He or she has the knowledge

of different kinds of life insurance which the consumer cannot possibly have. He or she can recommend a solution to problems uncovered by the fact find, tailor-made for the prospect's situation and pocketbook.

A final (and perhaps most important) benefit of the life insurance agent is his or her ability to motivate people to take action, and to solve their problems rather than just thinking about doing it. When an agent asks a wife if she could live on the income provided by the husband's current life insurance and the money which they have saved, he/she is motivating both of them to take action and to purchase life insurance to take care of the shortfall. (And there is almost always a large shortfall.) When an agent asks the partners in a business if they would like to be in business with the other partner's wife in event of that partner's death (and the answer is always "no") he/she is motivating those partners to take action, not just check prices or get quotes. And when an agent points out that the lack of life insurance will mean a severe change in the standard of living for his wife and children if, God forbid, he dies prematurely, he/she is motivating that man to take immediate action. Internet sites don't do that and neither do toll-free phone numbers.

The overwhelming evidence is that life insurance, unlike most other purchases, is sold, not bought, and it is sold by professional, licensed insurance agents and in some cases licensed FCSLA recommenders who have been trained to properly evaluate life insurance needs and understand the policies which they are selling. Getting back to the gentleman I quoted earlier; he has gone to his eternal reward, leaving millions and millions of dollars behind for the most vulnerable in society, namely widows and children. It is a legacy of great significance! As always, I would advise our members to consult a licensed agent or recommender to discuss their life insurance needs.

CREAMY MANGO SMOOTHIES

2 mangoes, seeds removed, peeled and chopped (2 cups)
2 cups mango sorbet
2 containers (6 oz. each) Fat Free French vanilla yogurt

1½ cups fat-free (skim) milk or soymilk

In blender, place all ingredients. Cover; blend on high speed until smooth. Serve immediately.

COCOA-PEANUT BUTTER-BANANA SMOOTHIES

1½ cups Fat Free vanilla yogurt (from 2 lb. container)

1 cup chocolate milk

¼ cup creamy peanut butter

2 small bananas, sliced

3 to 5 ice cubes

1 cup cocoa flavored cereal, coarsely crushed

Place all ingredients except cereal in blender. Cover; blend on high speed about 30 seconds or until smooth.

Pour into 4 glasses. Sprinkle with cereal. Serve immediately.

MINI KEY LIME CUPCAKES

Topping

1 box (4-serving size) vanilla instant pudding and pie filling mix

1½ cups whipping cream

¼ cup Key lime or regular lime juice

4 drops green food color

1½ cups powdered sugar

Cupcakes

48 regular-size paper baking cups

1 box yellow cake mix

Ingredients called for on cake mix box

Frosting

1 container whipped fluffy white frosting

1 tablespoon Key lime or regular lime juice

½ teaspoon grated Key lime or regular lime peel

In large bowl, beat pudding mix and whipping cream with wire whisk 2 minutes.

Let stand 3 minutes. Beat in ¼ cup Key lime juice and the food color; stir in powdered sugar until smooth. Cover and refrigerate.

Heat oven to 375°F (350°F for dark or nonstick pans). Place paper baking cup in each of 24 regular-size muffin cups. Make cake batter as directed on box. Spoon about 1 rounded tablespoonful batter into each muffin cup, using about half of the batter. (Muffin cups will be about ⅓ full.) Refrigerate remaining batter. Bake 12 to 16 minutes or until toothpick inserted in center comes out clean. Remove from pan to cooling rack. Repeat with remaining baking cups and batter. Cool cupcakes completely, about 15 minutes.

Remove paper baking cups from cupcakes. Swirl about 2 teaspoons topping on top of each cupcake.

Stir frosting in container 20 times. Gently stir in 1 tablespoon Key lime juice and the lime peel. Spoon frosting into 1-quart resealable food-storage plastic bag. Cut ½-inch opening from bottom corner of bag. Squeeze 1 rounded teaspoonful frosting from bag onto topping. Garnish with fresh lime wedge, if desired. Store in refrigerator.

LAYERED SALAD

1 pound bite-size pieces iceberg lettuce

16 ounces broccoli slaw (6 cups)

1 can (15 ounces) garbanzo beans, rinsed and drained

½ cup chopped red onion

1 medium red bell pepper, chopped

1 cup mayonnaise

½ cup creamy Italian dressing

¼ cup shredded Asiago cheese

2 tablespoons chopped fresh parsley

In deep 3-quart serving dish, layer lettuce, broccoli slaw, beans, onion and bell pepper.

Mix mayonnaise and Italian dressing until well blended. Spread over vegetables. Sprinkle with cheese. Cover and refrigerate at least 2 hours until chilled or overnight. Sprinkle with parsley just before serving.

BROWNIE ICE CREAM CAKE

1 box (1 lb. 6.5 oz.) brownie mix (with chocolate syrup pouch)

Ingredients called for on brownie mix box

½ gallon (8 cups) vanilla ice cream, slightly softened

1 cup hot fudge topping, warmed if desired

2 tablespoons candy sprinkles

16 red maraschino cherries with stems, drained

Heat oven to 350°F. Line 2 (9-inch) round cake pans with foil; grease bottoms only with cooking spray.

Make brownie mix as directed on box—except divide batter evenly between pans. Bake 22 to 26 minutes or until toothpick inserted 2 inches from side of pan comes

out almost clean. Cool completely in pans, about 1 hour. Do not remove from pans.

Spread slightly softened ice cream evenly on brownies in pans. Freeze at least 2 hours or until ice cream is firm.

Remove desserts from pans; remove foil. Place on serving plates. Cut each dessert into 8 wedges. Drizzle each wedge with hot fudge topping. Decorate with candy sprinkles and cherries. Store covered in freezer.

GRILLED SOUTHWEST STEAK AND SALSA SANDWICHES

1 boneless beef sirloin steak,
1-inch thick (1 lb.)

½ teaspoon seasoned salt

½ teaspoon garlic-pepper blend

½ teaspoon chili powder

½ teaspoon dried oregano leaves

6 hoagie buns, split

¾ cup chunky salsa

1 medium avocado, pitted, peeled and thinly sliced

6 slices (1 oz. each) Colby-Monterey Jack cheese blend

Heat gas or charcoal grill. Sprinkle both sides of beef with seasoned salt, garlic-pepper blend, chili powder and oregano.

Place beef on grill over medium heat. Cover grill; cook 8 to 9 minutes, turning once or twice, until desired doneness. Add buns, cut sides down, for last 4 minutes of grilling or until toasted.

Cut beef crosswise into thin slices. Spread about 2 tablespoons salsa on bottom of each bun. Top with beef, avocado, cheese and tops of buns.

QUICK SPICY TACO SALAD

1 lb. lean (at least 80%) ground beef

¾ cups hot water

1 box Hamburger Helper® chili macaroni

3 teaspoons chili powder

½ teaspoon dried oregano leaves

¼ teaspoon red pepper sauce

2 large cloves garlic, finely chopped

12 leaves romaine lettuce

2 large tomatoes, chopped

¾ cup sour cream

In 10-inch skillet, cook beef over medium-high heat 5 to 7 minutes, stirring occasionally, until thoroughly cooked; drain.

Stir in hot water, uncooked pasta and sauce mix (from Hamburger Helper box), chili powder, oregano, pepper sauce and garlic. Heat to boiling, stirring occasionally.

Reduce heat; cover and simmer 5 minutes, stirring occasionally. Uncover and cook 5 minutes longer. Remove from heat; cool 5 minutes.

Serve beef mixture over lettuce leaves. Sprinkle with tomato and top with dollop of sour cream.
