#### Very Reverend Monsignor Peter M. Polando, D. Min., J.C.L., National Chaplain

My dear Sisters and Brothers in Christ,

There are four important events that occur during the month of February. The celebrations of three coincidentally take place on the same day and are of spiritual value for us who belong to the Catholic Church and being a Catholic, Slovak association. The fourth, however, is mine! Let rue reveal these events without placing them in any particular order.

Whether Catholic, Christian, or not, February 14 is Valentine's Day! I was in the Hallmark store on the day after New Year's (hunting a good price for 2024 Christmas cards) and the workers were clearing out the previous holiday's goods and putting out the Valentine Day cards! Just think about it. Here it is, the celebration of a saint's feast day, and there is a magnet of consumerism that is involved with it - cards, public media exposition, dinner celebrations, rings for affection and engagement, even cars, and it goes on and on. Please do not think that I dislike Valentine's Day. I remember being in grade school placing Valentine's in brown lunch bags taped on trays of our classroom's chalk boards for everybody in the class. And if you were able to afford the money, some gave a special Valentine to the teacher (my teachers received the same one I gave to everyone else). I do like the day in the depths of my cold heart because in the end, it makes people realize who they really love and want a distinct relationship with the one who receives the cards and gifts. LOVE

The second celebration is one that has been exiled this year because of the third event of the date. The Calendar of the Roman Catholic Church usually celebrates the Memorial of Saints Cyril, monk, and Methodius, bishop, on February 14. Who are they, you may ask? The answer may be found in the Collect (Opening Prayer) of their Mass on that day. It states:

"O God, who enlightened the Slavic peoples through the brothers, Saints Cyril and Methodius, grant that our hearts may grasp the words of your teaching, and perfect us as a people of one accord in true faith and right confession Through our Lord Jesus Christ, your Son, who lives and reigns with you in the unity of the Holy Spirit, God forever and ever. Amen" Cyril and Methodius were blood brothers born in Thessalonika in the ninth century. They were men with great faith and courage to spread the Gospel in modern day countries such as the Slovak Republic. Cyril developed an alphabet that was the basis for the Russian language and the celebration of liturgy in Slavonic was approved for usage in the Eastern Church. Cyril died in Rome on 14 February 869 (this may be the reason for their Memorial to be set in the Roman Calendar). Methodius was an evangelizer and translated much of the Sacred Scriptures in Slavonic. He died in Velehrad (located in the modern day Czech Republic) on 6 April 884. These two brothers where instrumental in bringing Christianity to our ancestors in Eastern Europe and because of their work in evangelization, we are grateful. FAITH

The third is not so much a celebration of happiness but the annual beginning of forty days plus of repentance, reconciliation, and turning one's self around one hundred eighty degrees from sin to the grace of Almighty God. February 14 this year is the beginning the Season of Lent-Ash Wednesday. Lent is quite early this Leap year but not as early as February 7, 2035 or February 10, 2027! As a reminder, Ash Wednesday is a day of fast and abstinence. My article in March will delve more deeply on the Season of Lent and how we can make our resolves, our remissions from sin, and a better way to follow our Lord Jesus Christ in His preaching and teachings more holistic in our daily lives. **HOPE** 

The fourth event which is mine in February - I turn seventy. **REALITY**


# **Bryson Christopher Merrell**

# **MATCHING FUNDS ACTIVITIES**

#### SR. BRANCH 141, CLEVELAND, OH

#### Supports Ohio Western Reserve National Cemetery in Seville, Ohio

16 December 2023 – 0600 Hours was the wake-up call for the volunteers of Sr. Br. 141, Cleveland, Ohio to hit the road to head to Ohio Western Reserve National Cemetery in Seville, Ohio to place wreaths on veterans' graves.

From October 1, 2023 through November 29, 2023 the branch reached out to family and friends to sponsor wreaths to be placed on veterans' graves, not only at the national cemetery, but also at three local cemeteries in the Cleveland area as part of the national Wreaths Across America program.

The branch's efforts secured 190 sponsorships for the 2023 Wreaths Across America program. Of the 190 sponsorships, 27 were grave specific at Ohio Western Reserve National Cemetery, 10 at the local cemeteries, one wreath was delivered to the spouse of a deceased veteran, and 2 were delivered to two retired veterans in honor of their service to our country. One of the recipients is a retired US Air Force Chaplain, and the other is a US Marine Corps veteran. Sr. Br. Vice President, Sandra Kraft and her husband Richard placed a wreath on her Dad's grave at Holy Cross Cemetery and the volunteers placed wreaths on Richard Kraft's Dad and uncle's graves at Ohio Western Reserve National Cemetery.

We would be amiss if we did not mention that the volunteers "adopted" an individual who had heard about the wreath program and came to the national cemetery to help out. We know refer to her as "Aunt Sherry". She shared with

# REV. MSGR. PETER M. POLANDO, NATIONAL CHAPLAIN Youngstown, OH

Peter M. Polando (S156) was born on 17 February 1954 in Youngstown, Ohio, a son of Mary T. (Horney) Polando and the late Paul H. Polando. He attended Holy Name of Jesus School, West Junior High School and Chaney High School. Following his graduation from high school, he entered Saint Gregory Seminary, Cincinnati, Ohio, where he was awarded a Bachelor of Arts degree, majoring in ecclesiastical and United States histories in May, 1976. He continued his graduate studies at Mount Saint Mary Seminary of the West, Cincinnati, and earned a Master of Arts degree in sacred theology.

He completed his deacon internship in 1979 at Saint Aloysius Church, East Liverpool, Ohio, and was ordained to the priesthood on 21 June 1980 by the Most Reverend James W. Malone at the Cathedral of Saint Columba. He was assigned to the Church of Saint Mary, Massillon, Ohio, as parochial vicar and was the Catholic chaplain at Indian River Correctional Institute for Boys. He was an adjunct instructor at Walsh University in Canton, lecturing in the department of theology.

In July 1982, Father Polando was transferred to Cardinal Mooney High School in Youngstown where he served as an instructor in religion and western civilization and in August 1984, was appointed associate principal. During his tenure at Cardinal Mooney, he was head coach for boys and girls cross country and head coach for boys track. In August 1986, he was awarded a Master of Arts degree in liturgical studies from the University of Notre Dame, South Bend, Indiana, and in May 1989, was awarded a Master of Arts degree in non-public school administration from Ursuline College, Cleveland, Ohio. During that time he did additional studies at the University of San Francisco and Kent State University.

In August 1988, Father Polando was appointed pastor of Saint Mary Church, Newton Falls, Ohio, for one year and then was appointed pastor of Saint Joseph Church, Newton Falls. He was elected Supreme Chaplain of the First Catholic Slovak Union of the United States and Canada at its forty-fourth convention in Anaheim, California, in 1991. At that time he was an adjunct instructor at Ursuline College and pursued doctoral studies in systematic theology at Duquesne University, Pittsburgh, Pennsylvania. Father Polando continued studies in canon law at The Catholic University of America, Washington, D.C. in 1992. At the Slovak Catholic Federation's fifty-third convention held in Youngstown, he was elected First Vice President in 1993.

After receiving his licentiate in canon law, Father Polando was assigned pastor of Saint Matthias Church, Youngstown, and was appointed judge on the Tribunal of the Diocese of Youngstown in 1994. In that same year he was elected to a second term as Supreme Chaplain for the First Catholic Slovak Union at its forty-fifth convention held in Chicago, Illinois. He was the president of the Slovak Catholic Federation from 1997 through 2001, a position he was elected to at its fifty-fourth national convention in Wilkes-Barre, Pennsylvania, in 1996.

His Holiness, Saint John Paul II, conferred the honor of Chaplain of His Holiness upon him on Palm Sunday, 23 March 1997. On 12 May 1998, the Most Reverend Thomas J. Tobin appointed him to the Board of Mediation and Arbitration for the Diocese of Youngstown's Office of Conciliation. He was elected to a third term as National Chaplain for the First Catholic Slovak Union at its forty-sixth convention held in Toronto, Ontario, in 1998.

On 1 July 2003, Bishop Tobin appointed Monsignor Polando Adjutant Judicial Vicar of the Diocese of Youngstown. In addition to his pastorate at Saint Matthias Church, he was made administrator of Holy Name of Jesus Church, Youngstown, on 1 March 2006. He received his doctor of ministry degree from the Graduate School of Theology at Saint Mary Seminary, Cleveland, Ohio, in May 2007.

Monsignor Polando was welcomed into the Equestrian Order of the Knights of the Holy Sepulchre on 27 August 2011 in Vatican City and invested on 18 September 2011 by His Eminence, Francis Cardinal George, Archbishop of Chicago at Holy Name Cathedral and promoted to Knight Commander having been announced on 7 July 2015 in Vatican City and conferred on 24 October 2015 at Saint Patrick Church, Columbus, Ohio, by the Most Reverend William Shomali, Patriarchal Vicar and Auxiliary Bishop of Jerusalem. On 9 October 2011, he was awarded the Medal of Honor of the Ambassador of the Slovak Republic to the United States, by His Excellency, Peter Burian, for his contributions to the preservation of Slovak Heritage and Culture in the United States of America. On 1 August 2011, he was additionally appointed pastor of Saints Cyril and Methodius Church in Youngstown. Monsignor Polando was made the first pastor of the newly merged churches of Saint Matthias, Holy Name of Jesus, and Saints Cyril and Methodius that were established under the title of Our Lady of Sorrows Parish on 31 May 2012.

On 22 March 2013, the Most Reverend George V. Murry, S.J., appointed Monsignor Polando as the eleventh pastor and sixth rector of the Cathedral of Saint Columba. On 1 July 2015, Bishop Murry appointed Monsignor as the Judicial Vicar of the Diocese of Youngstown. He is a member of the Youngstown Diocesan Finance Council (2002), Diocesan Presbyteral Council (2015), Diocesan Liturgical Commission (1995), and Office of Conciliation (1998). In addition, Monsignor Polando was appointed pastor of Christ the Good Shepherd Church, Campbell, Ohio on 1 September 2017. On 1 March 2022, Bishop David Bonnar appointed Monsignor to St. Paul Church in Salem, Ohio and St. Patrick Church in Leetonia, Ohio. Recently, he has been appointed a senior priest of the diocese, and sacramental minister in three deaneries of the diocese.

Currently he is a member of the Canon Law Society of America; member and immediate past secretary/treasurer of the Midwest Canon Law Society; National Chaplain of the First Catholic Slovak Ladies Association, having been elected to that position at its thirty-ninth national convention in Saint Louis, Missouri, in 2007 and four times re-elected to that chaplaincy at its fortieth national convention in Baltimore, Maryland, in 2011, the forty-first national convention in Louisville, Kentucky, in 2015, its forty-second convention in Tampa, Florida, in 2019; and most recently at its forty-third convention in Indianapolis, IN in 2023; past president of the Slovak Catholic Federation; immediate past secretary of the Conference of Slovak Clergy; member of the First Catholic Slovak Ladies As- sociation Branch 169; member of Branch 731 of the First Catholic Slovak Union; member of the Slovak Catholic Sokol Wreath 54 and of Wreath 108; member of the Ladies Pennsylvania Slovak Catholic Union; member of the Mahoning Valley Slovak Cultural Association; member of the Ohio Cultural Alliance; spiritual moderator of the Youngstown Council of Catholic Nurses; member of the Notre Dame Club of the Mahoning and Shenango Valleys; a Fourth Degree member of the Knights of Columbus - Bishop James W. Malone Assembly of Youngstown; and, a Third Degree member of the Knights of Columbus -Youngstown Council 274.

Monsignor Polando has a brother, Paul M. and his wife Toni L. (Pedulla) of Clermont, Florida. Another brother, John P., died in 2002 and his wife, Michelle S. (Rand) lives in Liberty Township, Ohio. He has six nieces, two nephews, six great nieces and six great nephews.

#### CYNTHIA M. MALESKI, NATIONAL PRESIDENT Natrona Heights, PA

Cynthia M. Maleski (S313), our current National President, brings over four decades of significant leadership in executive and professional roles in insurance, strategic planning, budgetary, fund management, business, regulatory and non-profit management to the position. Cynthia was re-elected National President/CEO at the October, 2023 Quadrennial Convention and will continue to shepherd the transition for a number of significant governance changes and continue FCSLA Life on a growth path.

After presenting an updated innovative "building block" approach to growth in early 2016, she has led our board and our association along this growth path, while introducing a 10-year visioning project to the board of directors in March, 2019. A refreshed strategic

We have made great strides as a national fraternal benefit society despite the worst pandemic in over 100 years and in an uncertain, volatile economic environment.

Cynthia's previous executive experience includes over twenty-five years of increasingly responsible executive positions at a large insurance company, at a Catholic hospital, and as Insurance Commissioner and Cabinet Secretary for the Commonwealth of Pennsylvania. While Commissioner, Cynthia implemented the first Children's Health Insurance Program in the United States and worked for successful passage of the Model Fraternal Benefit Code in Pennsylvania. She has been named in Who's Who in American Women, Who's Who in American Law and Who's Who in America for a number of years.

Cynthia also designed and taught Insurance Law at a recognized Catholic law school and has been recognized as an expert in insurance law. She founded and operated her own law practice for many years. Cynthia retired from her law practice to assume her current position as National President. A list of other significant accomplishments can be found in her attached resume.

She also served the society as National Trustee for eight years and as President and Financial Secretary for Branch 313 for many years. She served in a number of leadership roles at various conventions, including bylaws chair and credentials committee. With extensive leadership experience in a number of cultural and nonprofit institutions, she has been recognized nationally, regionally, and locally for achievements and advocacy for various humanitarian causes. In 2017, she was honored to receive the Pope Francis Ambassadorial Leadership Award from Caritas en Veritate International from Pope Francis. She served on a volunteer basis and represented FCSLA on the Board and is past Chair of the American Fraternal Alliance. She currently serves on the AFA board Advocacy and Policy Committee.



#### CREAM OF MUSHROOM SOUP

4 tablespoons butter

1 tablespoon oil

2 onions diced

4 cloves garlic minced

- 1 1/2 pounds fresh brown mushrooms sliced
- 4 teaspoons chopped thyme divided
- 1/2 cup any dry red or white wine
- 6 tablespoons all-purpose flour
- 4 cups low sodium chicken broth or stock

1-2 teaspoons salt adjust to taste

1/2-1 teaspoons black cracked pepper adjust to taste

2 beef bouillon cubes, crumbled

1 cup heavy cream or half and half (sub with evaporated milk)

Chopped fresh parsley and thyme to serve

Heat butter and oil in a large pot over medium-high heat until melted. Sauté onion for 2 to 3 minutes until softened. Cook garlic until fragrant, about 1 minute.

Add mushrooms and 2 teaspoons thyme, cook for 5 minutes. Pour in wine and allow to cook for 3 minutes.

Sprinkle mushrooms with flour, mix well and cook for 2 minutes. Add stock. mix again and bring to a boil. Reduce heat to low-medium heat, season with salt, pepper and crumbled bouillon cubes.

Cover and allow to simmer for 10-15 minutes, while occasionally stirring, until thickened.

Reduce heat to low, stir in cream or half and half. Allow to gently simmer (do not boil). Adjust salt and pepper to your taste.

Mix in parsley and remaining thyme.

#### **CRACK CHICKEN SOUP**

- 4 slices bacon, diced
- 1 tablespoon butter
- 1 small yellow onion, diced
- 3 cloves garlic, minced
- 4 to 6 cups low sodium chicken broth
- 1/2 teaspoon garlic powder
- 1/2 teaspoon onion powder
- 1/2 teaspoon dried dill weed
- 1/2 teaspoon dried chives
- salt and fresh ground pepper, to taste

- 4 cups cooked shredded chicken
- 1 package (8 ounces) softened cream cheese
- 1 cup shredded cheddar cheese
- 3 to 4 cups baby spinach
- 1/4 cup heavy cream

sliced green scallions, for garnish

Cook diced bacon to a crisp in a Dutch Oven or soup pot.

Remove bacon from pot with a slotted spoon, leaving bacon grease in the pot.

Add butter to the pot and melt over medium-high heat.

Stir in onions and cook for 3 minutes. Stir in garlic and cook for 20 seconds.

Add chicken broth and scrape up all the browned bits from the bottom of the pot.

Season with garlic powder, onion powder, dill weed, chives, salt, and pepper.

Add bay leaf and bring to a boil; lower heat to medium low and cook for 5 minutes.

Stir in shredded chicken; cook for 5 minutes.

Add cream cheese and whisk in until completely melted and combined.

Stir in shredded cheese; whisk until melted and thoroughly combined.

Add baby spinach; cook for 2 minutes. Stir in heavy cream and cook for 1 minute.

Taste for seasonings (salt and pepper) and adjust accordingly. Remove bay leaf.

Remove soup from heat; top with scallions and previously prepared bacon.

#### SAUSAGE SOUP WITH ORZO

- 1 tablespoon olive oil
- 1 pound Italian sausage mild or spicy 1/2 medium onion diced (about 1 cup)
- 2 ribs celery diced
- 3 cloves garlic minced
- 1/2 cup Orzo Pasta (uncooked) or 1 cup
- larger pasta type

2 (14.5-ounce cans) tomatoes (diced or

- crushed) don't drain 4 cups chicken broth
- 1 teaspoon Italian seasoning

1/2 teaspoon sea salt

1/4 teaspoon Black Pepper

Water as needed to adjust consistency

Heat olive oil in pot over medium-high heat.

Add Italian sausage to the pot and saute until browned. Use a slotted spoon to transfer out of pot and set aside.

Drain excess grease from the pot, leaving a small amount for the vegetables. Or add another splash of olive oil if needed.

Add onion, celery, and garlic. saute until tender.

Add cooked sausage, orzo pasta, tomatoes, chicken broth, Italian seasoning, salt, and pepper.

Bring everything just to a boil, then reduce heat to medium-low and simmer 10-15 minutes, or until pasta is cooked through, stirring as needed.

Add water in small amounts to adjust consistency, if needed during simmering process.

#### **GRANDMA'S CREAMY** POTATO SOUP

1 large onion diced

- 1/2 cup thinly sliced carrots
- 1 lb bacon chopped
- 2 stalks celery diced
- 3 cloves garlic minced
- 8 potatoes peeled and cubed
- 4 cups chicken broth or enough to cover potatoes
- 3 tablespoons butter
- 3 tablespoons flour
- 1 cup heavy cream or half and half
- 1 teaspoon dried tarragon

1/3 cup kale can use frozen thawed kale as well, stems remove and chopped fine Salt and pepper to taste

Cook the bacon in a dutch oven until done. Remove the bacon, drain off all but 1/4 cup of the bacon grease. Cook celery, carrot and onion in the 1/4 cup bacon grease until soft. Stir in the minced garlic, cook for 1 minute more. Add cubed potatoes, toss to coat. Saute potatoes 3 or 4 minutes. Place the fried bacon back in the pan. Add enough chicken broth to the pan to cover the potatoes, cover and simmer until potatoes are tender.

In a heavy duty sauce pan, melt the butter over medium heat, whisk in the flour, cook and whisk the mixture for 2 minutes to remove the flour taste. While still whisking add the cream in a slow stream to the flour mixture. Cook and whisk until mixture thickens, add the tarragon and Kale to the pot. Stir the cream mixture into the potato mixture. Season with salt and pepper to your liking.
