REFLECTIONS ON SPRING

THE EASTER SEASON ... ORDINARY TIME ...

PART I

My dear Sisters and Brothers in Christ,

We are now in the midst of Spring which like the other three seasons, brings back memories of my childhood with my parents and two older brothers. My father, Paul, was a welder at United States Steel and my mother, Mary, was a homemaker. My brother, Paul, is nine years older than me and brother, John, was four years ahead of me. We lived in the city on about a quarter acre of land in a Cape Cod style home, built basically by dad and his friends with mom doing the interior painting and the varnishing of the maple wood floors. I remember vividly the addition to our home of a formal dining room, the building of a two-car garage with an attached patio and an annual huge garden in the backyard with all kinds of plants, herbs, and fruits. Mom and dad would plant seeds in our “hot box” that included several different types of tomatoes and peppers. In the mornings, they would uncover the hot box that had glass toppings to nurture growth by the sun and the glass doors lifted up to provide natural air to come in and not overheat the small plants. At nightfall, they would cover the hotbox with old used blankets and canvas tarps to retain the heat of the day and the blankets dry while keeping the cold nights, sometimes with frost, at a distance, so to say.

Towards the end of April and the beginning of May, my dad would dig up the garden by hand and slice the earth as fine as he was able and after several days of drying out, it was mom’s duty to further make the soil finer by raking it. Then came the several early evenings after supper when the sowing of other seeds, the transferal of the various tomato and pepper plants and other plants brought up by seed in the box were placed in their summer home in the garden. In addition, there were rows upon rows of carrots, onions, garlic, kohlrabi, radishes (both red and black), lettuces, various herbs, etc. all placed in their various designated spaces. The tomato and pepper plants all received a nightly cup of water if it did not rain that night or day. Stakes were gradually placed next to each tomato plant. Pumpkin and various gourd seeds were intermingled among the corn seeds. What an ordeal but what treasures we possessed as the garden was taken

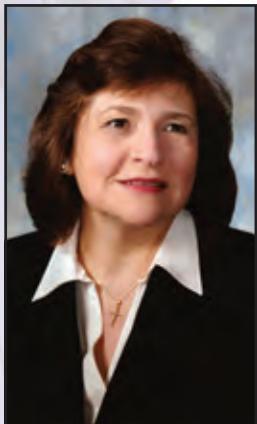
over by the seeds and their plants! What a wonderfully, delicious end of summer and the beginning of autumn!

As you are well aware, the celebrations of Lent and Easter were celebrated earlier this year. *Easter occurs on the first Sunday after the full moon that occurs on or after the spring equinox. If the full moon falls on a Sunday, then Easter is the next Sunday.* Accordingly, the Season of Lent 2024 began on Ash Wednesday, 14 February (which is usually the feast of the Patron Saints of the Slavs, Saints Cyril and Methodius, and formerly the celebration of *Saint Valentine*). The Season of Lent ended at beginning of the Sacred Triduum (28-31 March 2024) commencing on Holy Thursday with the celebration of the Lord’s Supper; Good Friday, continuing with the celebration of the Lord’s Passion and Death; and Holy Saturday, the Vigil of Easter; and, Easter Sunday. The Easter celebration continues for the next fifty days to the celebration of Pentecost on 19 May 2024.

Each and every year, you and I grow up more spiritually during these holy seasons: Lent, the Triduum- especially Easter Sunday; and, the Easter Season. The three months of Lent and Easter are both “hot boxes” for our understanding of sin, saving grace, the strength of Jesus in our lives, culminated by the gifts of the Holy Spirit. What a wonderful way to continue the liturgical year than placing ourselves before the Lord, in a spirit of repentance during the Lenten Season. We acknowledged that we have sinned and we are deeply in need to seek the reconciliation through the seed of the forgiveness of our sins especially noted by our extra acts of charity, almsgiving to the less fortunate, and obtaining a better relationship with our God, our family and those with whom we have committed the sinfulness of hatred and distaste. The seeds of forgiveness hopefully are continuing to grow now in this Easter Season of the Resurrection of Jesus. It was through His Passion and Death that we empower ourselves to be people of His Resurrection and continue to be His Light in our words, actions, and thoughts. But the Seasons of Lent and Easter lead us to the rest of the year that we call “Ordinary Time.” This article will continue with “Ordinary Time” in a Part 2 in the upcoming July 2024 issue.

Background

Photographing a person in a public place, including children, DOES NOT require a model release or expressed consent. When it comes to PUBLIC places or being in PUBLIC VIEW (even if you are standing on private property), consent or a model release is NOT required unless the photograph will be used in advertising (think billboard for Verizon or some other company) AND the person is recognizable.



When a photographer takes a photo, no matter who their subject is, copyright belongs to THE PHOTOGRAPHER. It's called "intellectual copyright" and believe it or not, it is perfectly within their legal rights to not only take the photos, but they have the right to display them, and even sell them as long as they aren't doing so commercially (as indicated above).

Considering that background information please be sure that you inform members attending your events that photographs will be taken and may be published in *Fraternally Yours*. Share that if someone does not want to be photographed or included in a write-up, to please make that known to the organizer and/or designated photographer.

Current Practice

When someone, be it a member, branch officer, district officer or home office staff submits information to be included in a future issue of the magazine, the editor sets it for publication. It is done with the understanding that the information contained has been cleared to be published with those involved. It would be impossible to verify every submission with every person pictured or included in each submission.



Memorials are only published when submitted by a family member or branch officer with the understanding that a family member asked for it to be published. Memorials may contain a head shot and approximately 250 words of text. Family members are encouraged to edit the original memorial or it will be done at the discretion of the editor. They are published when space allows.

Please use common sense and be sure to inform members that they may appear in a future issue of the magazine and respect the wishes of anyone who declines to be included in any photographs or other content submitted for publication.

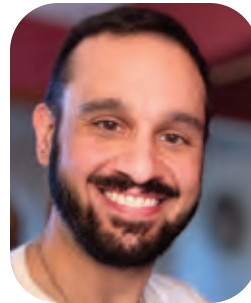
Mary Ann Castick, S156

Marie Louise Baloga Peters, S172

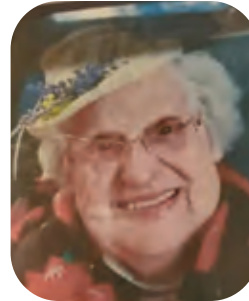

46TH ANNUAL SAINTS CYRIL AND METHODIUS APPEAL UPDATE

The Saints Cyril and Methodius Appeal is in its 46th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. The Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. Weekend Recipes

CREAMY CHICKEN ALFREDO LASAGNA

12 uncooked lasagna noodles (from 1 [16-oz.] pkg.)
5 tablespoons unsalted butter
5 tablespoons all-purpose flour
4 medium-size garlic cloves, finely chopped (about 4 teaspoon)
4 cups (1 quart) half-and-half
1/8 cup ground nutmeg
1 3/4 teaspoons kosher salt, divided
1 cup pre-grated Parmigiano-Reggiano cheese (from 1 [4-oz.] container)
3 cups shredded rotisserie chicken
1 (10-oz.) pkg. frozen chopped spinach, thawed and squeezed dry
1 1/2 cups whole-milk ricotta cheese (from 1 [15-oz.] container)
1 large egg, lightly beaten
1/4 teaspoon black pepper
12 oz. low-moisture, part-skim mozzarella cheese, shredded (about 3 cups), divided
Chopped fresh flat-leaf parsley

Cook lasagna noodles in generously salted water according to package directions for 1 minute less than al dente, about 10 minutes. Coat 2 large baking sheets with cooking spray. Drain noodles, and place in an even layer on greased baking sheets. If overlapping noodles, coat noodles lightly with cooking spray before overlapping. Set aside.

Melt butter in a medium saucepan over medium. Add flour, and whisk constantly for 1 minute.

Add garlic, and whisk constantly until garlic is fragrant and flour has started to toast slightly, about 1 minute.

Gradually whisk in half-and-half. Add nutmeg and 1 teaspoon of the salt. Bring to a simmer, whisking occasionally, over medium heat, whisking occasionally, until thickened for about 2 minutes.

Remove from heat, and gradually whisk in Parmigiano-Reggiano until smooth. Add chicken and spinach, and stir to combine; set aside.

Stir together ricotta, egg, pepper, and remaining 3/4 teaspoon salt in a medium bowl; set aside.

Preheat oven to 350 degrees with rack in center position (about 8 inches from

heat source). Coat a 2 1/4-inch deep, 9 x 13-inch (4-quart) baking dish with cooking spray. Spread 1 cup chicken mixture evenly in prepared baking dish. Lay 3 cooked lasagna noodles over chicken mixture to cover in an even layer.

Spread 1 cup chicken mixture evenly over noodles.

Dollop with 1/2 cup ricotta mixture, and spread evenly over chicken mixture.

Sprinkle 3/4 cup of the mozzarella evenly over ricotta mixture.

Repeat layers 2 more times, beginning with 3 cooked lasagna noodles. Top with remaining 3 noodles, remaining 2 cups chicken mixture, and remaining 3/4 cup mozzarella. Cover dish with aluminum foil.

Bake in preheated oven until hot and cheese has melted, about 30 minutes.

Remove foil, and bake until edges are golden brown, about 15 minutes. Without removing dish from oven, increase oven temperature to broil. Broil until cheese begins to turn golden brown, about 5 minutes. Remove from oven, and let cool 15-20 minutes before serving.

FLATBREAD WITH GOAT CHEESE, FIGS AND PROSCIUTTO

3 medium white onions
1 tbsp unsalted butter
1/4 cup brown sugar
3 tbsp balsamic vinegar
1 8oz tube thin crust pizza dough
olive oil
1 tsp garlic powder
2 cups mozzarella cheese shredded
2-3 small fresh figs sliced
8 oz goat cheese crumbled
4 oz prosciutto
6 basil leaves torn
1 cup arugula
2 tbsp balsamic glaze

Slice the onions and put them in a large sauté pan over medium low heat with the butter. Cook for 35-40 minutes until caramel brown.

Add in sugar and vinegar and cook an additional 3-5 minutes until thick and sticky. Remove from the pan.

Preheat the oven to 425 degrees
Drizzle a sheet pan with olive oil.
Open the can of dough and roll out onto the sheet pan. Drizzle with more olive oil and press the dough out to the edges of the pan. Sprinkle with garlic powder.

Top with 1 1/2 cups of mozzarella and then spread the caramelized onions all over.

Place your sliced figs all over and top with the remaining shredded cheese, and 6 oz of the goat cheese.

Tear the prosciutto and basil and scatter them both on top. Drizzle with olive oil.

Bake for 15-17 minutes until golden brown.

Top with arugula, remaining goat cheese, and drizzle with olive oil and balsamic glaze. Serve immediately.

MOUNDS POKE CAKE

1 box of chocolate cake mix (and the ingredients called for on the box)
1 (14 oz) can of sweetened condensed milk
1 (15 oz) can of coconut cream
1 (7 oz) package of shredded sweetened coconut
1 (12 oz) container of chocolate frosting
Preheat oven and prepare the chocolate cake mix according to package directions.

Pour the batter into a greased 9x13 inch casserole dish.

Bake the cake for the time specified on the box, usually between 25-35 minutes, or until a toothpick inserted into the center comes out clean.

While the cake is still warm, poke holes throughout the cake using the handle of a wooden spoon or a similar instrument.

In a medium bowl, mix together the sweetened condensed milk and coconut cream. Pour this mixture over the cake, aiming to fill the holes.

Allow the cake to cool completely, which will enable it to absorb the milk mixture thoroughly.

Once cooled, spread the shredded sweetened coconut evenly over the top of the cake.

Heat the chocolate frosting in the microwave for about 20-30 seconds, or until it reaches a pourable consistency. Pour the frosting evenly over the coconut layer.

If desired, garnish with additional shredded coconut or almond slivers for added texture and flavor.

Chill the cake in the refrigerator for at least 1 hour to set before serving. This will make cutting the cake into pieces easier and allow the flavors to meld.
