“Ordinary Time”

My dear Sisters and Brothers in Christ,

In the May edition of *Fraternally Yours*, I illustrated the different “seasons” of the Roman Catholic calendar of the Church year beginning with Advent (the four prior weeks to Christmas); the Christmas Season; the Season of Lent beginning on Ash Wednesday; the Paschal Triduum of Holy Thursday, Good Friday, and Easter; and, the Season of Easter including the Solemnity of the Ascension of our Lord, ending with the Solemnity of Pentecost. After the hustle and bustle of Advent and Christmas, and, after the many weeks of Lent and the Season of Easter ending with the Solemnity of Pentecost, there are thirty-four weeks that are entitled “Ordinary Time”. Interspersed between the Christmas and Lenten Seasons, and, the Easter and Advent Seasons, there are weeks, thirty-four in total, in which we walk the ordinary time of the path of life. It is up to us, collectively and personally, to make the practice of our Faith in Jesus, through the ordinary way we live and pray in our daily lives. Each week, each day, we have to nourish the seed of our Faith in the “hot box” of salvation nourished freely in the Person of Jesus. How do we do it? It is simple but may be so difficult. We hear it planted from the lips of Jesus in the Gospel of Mark: *One of the scribes, when he came forward and heard them disputing and saw how well he had answered them, asked him, “Which is the first of all the commandments?” Jesus replied, “The first is this: ‘Hear, O Israel! The Lord our God is Lord alone! You shall love the Lord your God with all your heart, with all your soul, with all your mind, and with all your strength.’ The second is this: ‘You shall love your neighbor as yourself.’ There is no other commandment greater than these” (12:28-31).*

Is the seed of Love still growing in your personal “hot box”? Has it been planted, nourished, and watered through your Baptism; in your receptions of the Holy Eucharist; through the daily gifts provided for you in the Holy Spirit; by the forgiveness of sins in the Sacrament of Reconciliation; or in your forgiveness to those who have sinned against you or you who have sinned against

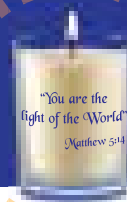
others? In other words, have you nourished your Love for others, especially God?

Ah, those thirty-four weeks of “Ordinary Time” have spiritual aids to assist us in the nourishing of the virtue of Love. Please look at your religious calendar in your home! Notice the other Solemnities, Feasts, and Memorials of the Saints who have gone before us, marked with the sign of Love! Generally speaking, the saints that have gone before us lived their lives to the honor and glory of Almighty God through their Love. They lived in a different time, some doing great fetes; others, personal, holy lives; and still others, ordinary people like you and me - attempting to Love for the sake of being a sister or brother in the Person of Jesus Christ, our Loving Brother!

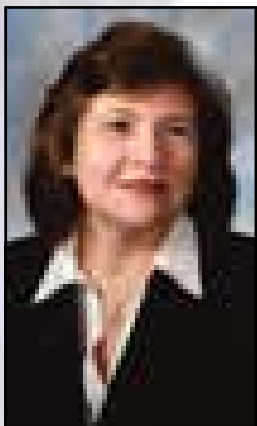
The thirty-four weeks of Ordinary Time in the Catholic calendar in which we now participate until the Season of Advent in November challenges all of us to grow like the plants from the “hot box” and presently flourish in the sunshine and rains of summer! Some of us are in the Springs, others, in the Summers, and still others, like me, in the Autumns of the calendar. No matter what season we are in, “time’s a wastin” as one of the comic strip characters stated years ago and carved in my memory. During these days of summer and in the several months that we will be living in the Ordinary Time of the Catholic Church calendar, I suggest that we do more daily reading of the Sacred Scriptures or pick up a book about a saint, reading how to become more holy and humble in our lives. I know how to turn on a computer but do not know how to use it! But I do know that there are Catholic sites out there in order for us to read more about God, the saints, and good authors who may assist us in our spiritual growths through Love. The summer of Life is upon us! Are we continually ready for the harvest in the Autumn of our lives? Or a warm rather than cold, eternal Winter? The “hot box” of Life has provided nourishment through Love! Reap the Harvest among us so that we may enter the Garden of Paradise where the Seed of Love lives forever! Do not forget: “time’s a wastin”.

Dear fellow members,

On July 4, 2024, Independence Day, we commemorate the 248th anniversary of the Declaration of Independence, which was ratified by the Second Continental Congress on July 4, 1776, establishing the United States.

The motto and common aim of First Catholic Slovak Ladies Association of the United States of America has been “FOR GOD AND COUNTRY” for many years, longer than many of us can remember. This declaration has been embodied in our official documents, specifically in Article I, E 1. It has been in previous sets of bylaws for decades.

Religious identity and practices were infused into each step along the way. Faith mattered to military morale.¹ During the war, as many as 18,000 uniformed chaplains served the troops. Soldiers wore identity tags indicating their religious affiliation. General Dwight D. Eisenhower named the invasion “The Great Crusade” and asked for the blessing of “Almighty God”, with urgency.

Since our beginnings in 1892, leaders of our Association have asked for the blessings and help of our God and Father. When encountered with opposition to be permitted to become members of other fraternal benefit societies and gain access to death benefits, our Foundress Anna Hurban took heed of the guidance of Most Rev.

Stephen Furdek, a prominent Slovak priest, who encouraged her to organize a society for like minded women so we could all have access to our fine products for over 132 years and continuing today.

Throughout the decades of our existence and growth, we continue to interweave prayer, religious services and rituals into our work and activities. Common prayers for meetings and funeral and wake services are included as part of our bylaw books for use in a variety of settings. Calls for Prayer and Recitation of our Pledge of Allegiance are embodied as essential agenda items at convention sessions and board, district and branch meetings. Our National Chaplain leads us in Prayer at our board meetings and celebrates Mass for all at the home office. Since our beginnings, we have designated St. Ann as the Society’s Patron Saint. Each branch is encouraged to observe the Feast Day of its Patron Saint. Since the COVID pandemic, we have commemorated Saint Ann’s Day on July 26 with a wreath laying ceremony and Prayer Service on our home office grounds in honor of and in memory of our living and deceased members. We pray for the unborn and the frail elderly at special times throughout the year and affirm and respect the dignity of every person from the beginning of life to the end of life and beyond.

As we move forward in 2024, it is fitting and incumbent on us to continue to invoke God’s blessings on our meaningful work in our country, even more relevant today than ever, for the benefit of our members, their families, and the communities where we live, work and worship. In serving our members and the common good in our communities and in promoting peace, ours is a noble cause.

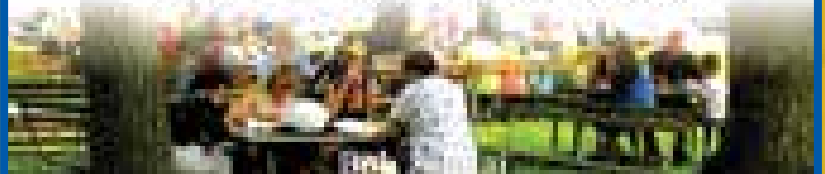

PRIVACY NOTICE

AN IMPORTANT NOTICE CONCERNING MEMBER PRIVACY

In compliance with federal law and regulation, we are required to provide each member with information regarding the practices we have in place to protect the privacy of our members. This notice explains the types of data about you that we collect and disclose, with whom that data may be shared, and how we protect your data. We recognize that the protection of our members' privacy is of the utmost importance.

INFORMATION WE COLLECT

In the process of becoming our member you (or someone representing you) provided FCSLA with certain nonpublic personal information, such as your name, date of birth, address, marital status and Social Security number. If you have applied for life insurance, you may also have provided us with employment and medical information and may have authorized us to obtain further information concerning your health history. With your authorization, we have collected only the minimum amount of information necessary to underwrite your application.

INFORMATION SECURITY

We maintain the highest levels of confidentiality concerning your nonpublic personal information. Our employees have been trained in the careful handling and protection of such information. Only individuals who are trained to safeguard your data may use data about you. Those who use your data must follow established standards, procedures and laws. They understand that improper disclosure of nonpublic personal information is a

serious matter with severe consequences. If we should find it necessary to retain another organization to assist us with our operations, we will require that it maintain the same strict standards of confidentiality as we do. In addition, we maintain physical, electronic, and procedural safeguards to protect the nonpublic financial information of our members.

INFORMATION WE DISCLOSE

We are a fraternal benefit society that has always been committed to protecting the privacy of its members. There are no affiliated financial institutions or third party affiliates which have access to your nonpublic personal information, except pursuant to your authorization. We do not share data about you with other organizations, except as permitted by law. For example, we are permitted to share data about you to (i) help us underwrite your insurance, (ii) open your account, (iii) process transactions and administer your claims, (iv) share with organizations that act for us or on our behalf, (v) comply with an inquiry by a government agency or regulator or in connection with civil or criminal litigation, or (vi) assist us in providing benefits to you as part of your membership. We will not sell any list of our members' names or addresses.

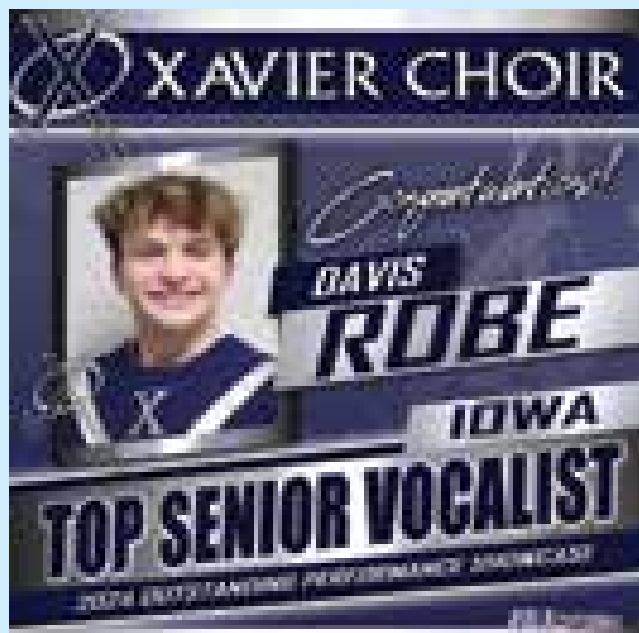

National Fraternalist of the Year

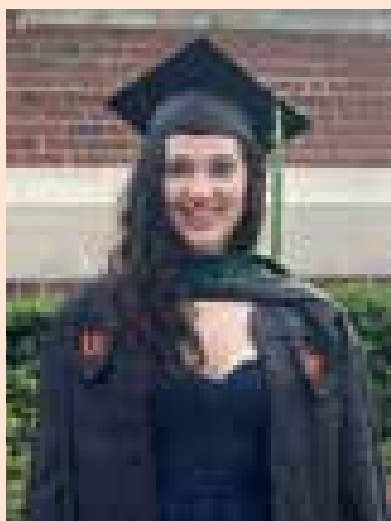
The National Fraternalist of the Year award is an honor presented to an individual in our association who, through example and accomplishment, has provided outstanding volunteer service to their branch, church, and community.

CONGRATULATIONS NEW GRADUATES!



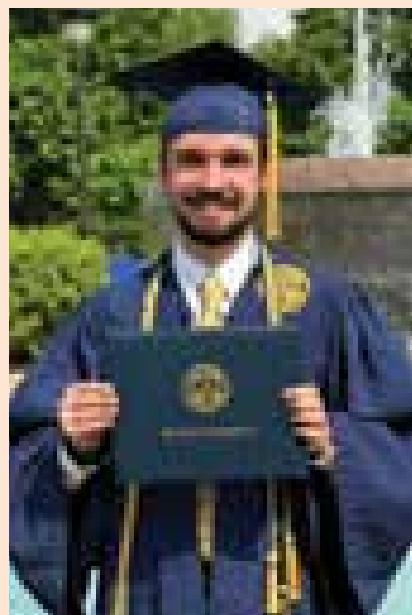

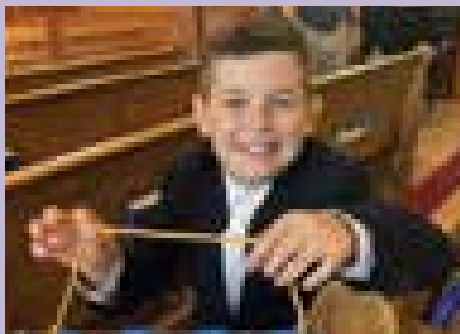

FCSLA Bylaw Changes

At the 43rd Quadrennial Convention, the Convention delegates voted to amend the corporate Bylaws subject to a regulatory process and certain provisos regarding the following changes.

II. Membership

Article II(A)(2)(d) and (e) were amended by striking out (d) and (e) and replacing it with a new (d) and (e). The adopted change now reads: A Fraternal Member is: (d) Able to have voting privileges at the branch and the district level. (e) Able to hold office at the branch and district level.

Article II(A)(3)(b) and (c) were amended by striking out (b) Sound in body and mind and (c) Recommended by a member in good standing. The adopted change now reads: All members are: a) Citizens of the United States of America b) Notwithstanding Section 3 (a) above, all members of the Association prior to October 8, 2014, shall be deemed to be Principal Members.

Article II(B)(1) was amended by striking out "to a branch". The adopted change now reads: 1. Anyone wishing to become a member or certificate owner must apply on such forms as are furnished by the Association.

Article II(C)(3) was amended by striking existing subsection 3 and inserting a new subsection 3. The adopted change now reads: A member may transfer from one Branch to another by notifying the home office of their request.

III. Leadership and Governance Structure

Article III(E) was amended to strike all Section E and re-letter the remaining sections and move Section E to new section H "Hired National Executives" as new section 1. The title has changed from National President to Chief Executive Officer (CEO) throughout the bylaws. Article III(H)(1) Chief Executive Officer (CEO) (b) amended by striking the first sentence. The adopted change now reads: (b) The Chief Executive Officer (CEO) may at times answer questions involving interpretation of the Bylaws. The Board of Directors shall have final determination of any interpretation of the Bylaws. An appeal must be made within 30 days after the decision is made by submitting two written copies of the appeal to the Chair of the Board.

Article III(H)(1) was amended to add a new subsection (f). The adopted change now reads: The board will conduct a transparent national search utilizing a national search firm to assist with the process. All members will receive notification of the hiring process.

The following provisos apply to this amendment:

1. Prior to the employment of a hired Chief Executive Officer (CEO), the Board of Directors

will develop procedures for communicating bylaws interpretations from the Board Chair to the Chief Executive Officer.

2. The transition from an elected to a hired Chief Executive Officer (CEO) will be effective upon hiring of the Chief Executive Officer, not to exceed 24 months after adoption.

Article III(B)(1) and (2) were amended by striking out subsection (1) and (2) and inserting a new subsection (1) and (2) and adding a new subsection (3). The adopted change now reads:

1. The Board of Directors shall consist of 11 voting members, and 10 members elected for a four (4) year term as provided in these Bylaws; the 11th voting member shall be the Chief Executive Officer (CEO) for any matter coming in front of the board, excluding budget and compensation matters.
2. The Composition of the Board of Directors is as follows:
National Chaplain;
Chief Executive Officer (CEO);
Four (4) National Directors;
Two (2) National Trustees; and
Three (3) National Auditors.
3. The Board of Directors shall select its own Chairperson from the 4 National Directors and 2 National Trustees with a 2/3 majority vote of all board members at the first regular board meeting of the newly elected board or when a vacancy exists.

Article III(I)(1)(b), (d), and (e) were amended by striking out (b) who shall serve as chairperson, (d) and, (e) The National Secretary and National Treasurer who shall serve as staff to the Executive Committee but shall not be considered voting committee members. Then inserting a new (a) Chair of the Board and renumbering the list of committee members. The adopted change now reads:

Section I. Executive Committee

1. The Executive Committee shall consist of the following:
 - a) Chair of the Board
 - b) National Chaplain
 - c) Chief Executive Officer (CEO)
 - d) Two (2) National Trustees
 - e) Two (2) National Directors selected by the Board of Directors

The following proviso applies to this amendment:

Any sections inconsistent with the adoption of hiring the Chief Executive Officer must all be modified accordingly.

Article III(H)(2) National Secretary amend by striking out (c), (e) and (g) and renumber the other items. The adopted change now reads:

H. Hired National Executives

2. National Secretary

- a) Shall direct operating activities of the Association subject to review by the Chief Executive Officer (CEO) and in accordance with the purpose and objectives of the Association;
- b) Shall provide full time services to the Association;
- c) Shall be hired by the Chief Executive Officer (CEO) subject to approval of the Board of Directors through the verification process;
- d) Reports directly to the Chief Executive Officer (CEO) and is subject to review by the Chief Executive Officer (CEO).

Article III(C)(1) (a) was amended by striking out subsection (a) "Be at least 35 (thirty-five) years of age"; and the section renumbered.

Article III(C)(3) was amended by striking out "excluding the Court of Appeals". The adopted change now reads:

3. Verification Process

All candidates for National Office shall be verified in accordance with Section V(A)(4)(b) of these Bylaws.

Article III(G)(1) was amended by striking out "with the approval of the National President". The adopted change now reads:

G. National Auditors

1. The three National Auditors shall make a thorough semi-annual audit of all books of the Association and shall compile a report of their findings and cause them to be published forthwith in the Association's Official publication.

IV. Organization Structure

Article IV(A)(2)(e) was amended by striking out the words "Only Principal". The adopted change now reads: Members may be eligible to serve as a Branch Officer, who shall be elected at the Branch's annual meeting.

Article IV(A)(3)(a) was amended by inserting a new (vi). The adopted change now reads: (vi) If a Branch is dissolved, members can select from a list of area active branches to transfer. If no Branch is selected, they will be assigned a branch by the home office.

V. Convention, Court of Appeals and Parliamentary Authority

Article V(A)(4)(f)(i) and (ii) Strike out the word President as this is no longer an elected position.

The following proviso applies to this amendment:

This will take effect immediately following the 43rd Quadrennial Convention or when approved by the various state governing authorities.

Article V(A)(2)(b) was amended by striking the word "Principal" throughout subsection (b).

Article V(D)(3) was amended by inserting a new 3 to read as follows:

Except as set forth in Article III(A)(6), the Board of Directors may amend or repeal in whole or in part these Bylaws in the best interest of the organization by a 2/3 vote of all members of the Board. No amendment or repeal will become effective until the board approved bylaw change has been sent to the credentialed delegates for a 2/3 approval by those voting on the board approved bylaw change, by mail or other approved means.

NATIONAL SEARCH FOR A CHIEF EXECUTIVE OFFICER FOR FCSLA LIFE

Per the Bylaw changes approved at the last Quadrennial convention in October 2023, the National Board has initiated a national search for a Chief Executive Officer for FCSLA Life. A special Board Committee was appointed at the January 2024 Board meeting consisting of 5 Board members. The Committee has worked to define the job and job requirements and has selected Jacobson Executive Search, a national executive search firm, to identify qualified candidates. 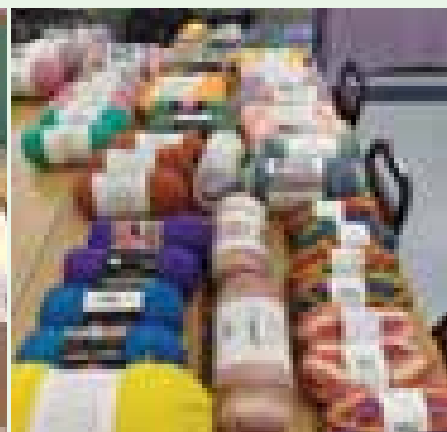

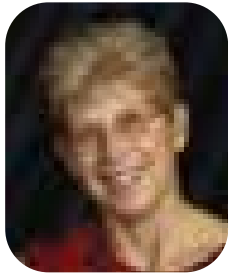

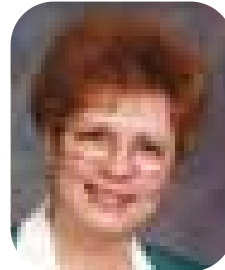
Bernard Markey, S140

46TH ANNUAL SAINTS CYRIL AND METHODIUS APPEAL UPDATE

The Saints Cyril and Methodius Appeal is in its 46th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. The Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. A direct mailing asking for donations was sent in February to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, clergy with Slovak ancestry, and previous donors.

Light up the Grill

GRILLED FLANK STEAK

1 1/2 cups packed fresh cilantro leaves and stems
1 cup packed fresh flat-leaf parsley leaves and stems
3 tablespoon red wine vinegar
2 tablespoon chopped fresh oregano
6 medium garlic cloves, chopped (2 tablespoons)
5 drained anchovy fillets, chopped (about 2 teaspoon, optional)
1 medium-size red Fresno chile, stemmed, seeded, and chopped
1 3/4 teaspoon kosher salt, divided
1/2 cup extra-virgin olive oil, divided
1 (1 1/2-lb.) flank steak (3/4 to 1 inch thick)
Make chimichurri sauce:

Place cilantro, parsley, vinegar, oregano, garlic, anchovies (if using), chile, and 1 teaspoon of the salt in a food processor; pulse until very finely chopped, 10 to 15 pulses, stopping to scrape down sides. With processor running, gradually pour 6 tablespoons of the oil through food chute; process until smooth, about 10 seconds. Spoon 1/4 cup of the chimichurri into a large ziplock plastic bag. Refrigerate remaining chimichurri in an airtight container for up to 1 day.

Add steak and remaining 2 tablespoons oil to bag with chimichurri. Seal bag, and massage to distribute marinade. Refrigerate 4 to 12 hours.

Let steak stand at room temperature 30 minutes. Preheat grill to high (450 to 500 degrees). Remove steak from bag, and discard marinade. Sprinkle evenly with remaining 3/4 teaspoon salt.

Place steak on oiled grates, and grill, uncovered, turning occasionally, until an instant-read thermometer inserted into thickest portion of steak registers 125 degrees, 10 to 12 minutes.

Transfer to a cutting board; let rest 15 minutes. Slice steak against the grain, and serve with reserved chimichurri.

GRILLED CORN SALAD

4 ears fresh corn
4 tablespoon olive oil, divided
1 small (5 oz.) red bell pepper, finely chopped (about 3/4 cup)

1 small (5 oz.) zucchini, quartered and sliced 1/4-in. thick
1 large (1 1/2 oz.) shallot, finely chopped (about 1/4 cup)
1 large garlic clove, grated (about 1 teaspoon)
1/2 cup thinly sliced fresh basil
3 tablespoon balsamic vinegar
3/4 teaspoon kosher salt
1/2 tsp black pepper
1/2 teaspoon black pepper

Preheat grill or grill pan to medium-high (400 to 450 degrees). Coat corn with 1 tablespoon of the olive oil.

Place corn on oiled grates; grill uncovered, turning occasionally, until grill marks form all over and corn is just tender, about 10 minutes.

Transfer to a cutting board, and let cool 5 minutes. Cut kernels from corn, and place in a large bowl.

Add bell pepper, zucchini, shallot, garlic, basil, vinegar, salt, pepper, and remaining 3 tablespoons olive oil to corn in bowl. Toss until evenly combined.

LEMONY WHITE BEAN SALAD WITH BROCCOLI

1 (16-oz.) pkg. fresh broccoli florets (7 cups florets)
1/2 cup plus 1 1/2 tablespoons olive oil, divided
1 teaspoon kosher salt, divided
1/2 teaspoon black pepper, divided
1/2 teaspoon lemon zest plus 1/4 cup fresh juice (from 2 lemons)
2 tablespoons chopped fresh flat-leaf parsley
1 garlic clove, minced
1 tablespoon whole-grain mustard
1 tablespoon apple cider vinegar
1/2 teaspoon honey
1 (15 1/2-oz.) can no-salt-added cannellini beans, drained and rinsed
4 cups baby arugula
1 cup thinly sliced red onion
1 ounce Parmesan cheese, shaved (about 1/2 cup)

Preheat oven to 400 degrees with oven rack 6 inches from heat. Toss together broccoli, 1 1/2 tablespoons of the oil, 1/2 teaspoon of the salt, and 1/4

teaspoon of the pepper in a large bowl. Spread broccoli in a single layer on a rimmed baking sheet. Roast in oven until just tender, 20 to 25 minutes.

Meanwhile, whisk together lemon zest and juice; parsley; garlic; mustard; vinegar; honey; and remaining 1/2 cup oil, 1/2 teaspoon salt, and 1/4 teaspoon pepper in a medium bowl. Set aside.

Increase oven temperature to broil; cook broccoli until slightly charred, 1 to 2 minutes. Cool about 5 minutes.

Combine broccoli, beans, baby arugula, and red onion in a large bowl. Toss with dressing; sprinkle with Parmesan.

GRILLED PEACHES WITH SPICED WHIPPED CREAM

1 cup heavy whipping cream
2 tablespoons confectioner's sugar
1/4 teaspoon cinnamon
1/8 teaspoon ground clove
1/8 teaspoon nutmeg
1/2 teaspoon vanilla extract
4 ripe peaches, halved and pitted
2 teaspoons olive oil
Pinch of salt
Sorghum syrup or honey (*optional*)
Garnish: Mint leaves (*optional*)

In small bowl, combine cream, cinnamon, nutmeg, clove, vanilla, and powdered sugar. Whisk with a hand mixer until medium peaks form. Chill while peaches grill.

Preheat grill to medium high. Brush peaches with olive oil on the flesh side, and sprinkle with salt. Place peaches flesh-side down on the preheated grill, close the lid, and cook for 5 to 6 minutes.

Top with whipped cream, and garnish with fresh mint, drizzled syrup or honey.

LEMON ICEBOX PIE

1 (8 oz.) package cream cheese, room temperature
1 (14 oz.) can sweetened condensed milk
2 tablespoon lemon zest (from 2 lemons), plus more for garnish
3/4 cup fresh lemon juice (from 6 lemons)
1 homemade or store-bought graham cracker crust
Whipped cream or frozen whipped topping, thawed, to serve

In a large bowl, combine cream cheese, sweetened condensed milk, lemon zest, and lemon juice.

Using an electric mixer on medium, mix until smooth.

Spread into pie crust and smooth top. Refrigerate for 7 hours (or until set).

Once the pie is set, top it with a layer of homemade whipped cream, and sprinkle with additional lemon zest, if desired.
