

The Voice of Christmas

He had been a long-time member of the church but refused to show up for services, let alone join. He was an integral part of the Christmas Choir, but would not attend rehearsals. Still, everyone looked forward to seeing him once a year. So much, in fact, they would hold a seat for him at the candlelight service every Christmas Eve. Many of the congregation would arrive early to get a good seat near the gentleman. Was it his personality? No, he really kept to himself, rarely sharing a word with anyone. It was his voice. "Oh Holy Night" was his song.

Throughout his life, he often wished for the chance to perform it at a local church. The choir would stand, the church organ would begin to play. "O holy night, the stars are brightly shining" was the intro sung by the 12-member choir. Then, as if Heaven had opened its doors, the choir softly faded, and the man began to sing ...

You could feel the excitement as music began to build to the refrain...

By this time, there was never a dry eye. After the service, the man would blend into the crowd and exit the rear door. The tradition lived on until a month before Christmas that year. He had joined his love, his reason to sing.

"What will they do?" one of the elders asked. "Who could take his place?" No one. No one would dare attempt to fill his spot. It would be difficult indeed to come close to that long-treasured moment. "We will do the song in his memory," the choir director declared.

"But, who among us will sing his part?" "God had blessed us with his voice, and His earthly choir is not made of only one single voice," he assured them. "He will bless us again."

That Christmas Eve, as everyone filled the church, you could hear the choir, warming up in the basement. A small piano began playing, followed by, "O holy night, the stars are brightly shining" then silence.

Although our country is not engaged in massive troop interventions throughout the world, there are very many women and men who will not be home with their families because of protecting our freedoms in this country, especially our religious freedom. It is always an uplifting experience to see our children make gifts in their art classes, assisted by parents and alumni who chip into send care packages to our armed service personnel. Maybe you and I can inquire at our local parish or public grade schools whether or not teachers and children will be involved in such a task. If they are, maybe we could be a part of their project.

Some of you may want to pray the Novena to the Infant Jesus of Prague, a very familiar novena of the Slavic peoples. You can acquire the booklet from a nearby religious bookstore and begin it nine days prior to Christmas. There is a very interesting website about the Infant Jesus at www.pragjesue.info from the church where the statue is housed in Prague. If you are unable to purchase the novena booklet, there is a chaplet that can be prayed and is easy to follow. Tradition has it that the Lord appeared to Venerable Margaret of the Sacred Heart, a Discalced Carmelite man, who died in 1648 in the Carmel of Beaune, France and asked her to reveal the chaplet to the Church. Here is how it is prayed: A. Three times pray, "And the Word was made flesh" followed by the Our Father; B. Once pray, "and the Word was made flesh and dwelt among us." C. Pray twelve Hail Mary's; and, D. End the chaplet with one Glory be to the Father. The three Our Fathers represent the members of the Holy Family and the twelve Hail Mary's are in memory of the childhood of Jesus.

There is also a prayer to the Infant Jesus that by tradition was revealed to Venerable Father Cyrill, OCD, by the Blessed Mother. "Infant Jesus, I have recourse to You and ask You through the intercession of Your Holy Mother to help me in my need (here mention your need) for I firmly believe that Your Divinity can help me. I hope, in complete trust, to obtain Your holy grace. I love You with all my heart and with all the strength of my soul. I am truly sorry for all my sins, and beg You, O good Jesus, to give me the strength to conquer them. I shall never offend You and am ready to suffer rather than to cause You pain. From now on I want to serve You with complete faithfulness and for love of You. O Divine Infant, I will love my neighbor as well as myself. Omnipotent Infant Lod Jesus, again I implore You, help me in this need of mine (mention need again). Grant me the grace of possessing You eternally, with Mary and Joseph and of adoring You with the holy angels in Your heavenly court. Amen."

These are just a few ways of keeping the traditions of Christmas sacred! Slow down, enjoy family and friends, assist those so less fortunate than ourselves, and give thanks to Almighty God for the gift of the Infant Jesus!



The Value of Policy Conversions

If you are reading this article in *Fraternally Yours*, you are most likely a member of FCSLA Life. That means that either you or someone close to you believes that there is value in owning life insurance. As I have mentioned in previous articles, I think life insurance is one of the most important financial instruments available and is the basis for personal financial stability.

In this article I will discuss a valuable additional feature that some of our life insurance policies have that you may not be aware of. There are generally two types of insurance policies, term and permanent. Term policies provide coverage only for a specified period, usually 10, 15, 20 or 30 years. Permanent policies provide coverage for an entire lifetime. FCSLA Life term policies offer a feature that allows for converting a term policy to a permanent policy, with no medical exam or underwriting requirements.

When you purchase an FCSLA term policy you automatically get the option to convert the policy to a permanent policy. So, why is the ability to convert from a term policy to a permanent policy such an important feature?

Not everyone can get life insurance. Life insurance companies underwrite the mortality risk of insuring someone before offering coverage. There are a lot of reasons why a company would decline coverage or at least request additional premium to accept a risk:

- Age
- Medical history
- · Current medical conditions
- Lifestyle choices
- Dangerous avocations (hobbies)
- Dangerous vocations (jobs)

It is always a good idea to purchase life insurance early in life before health issues or choices made preclude the ability to get life insurance.

Let's look at a hypothetical example:

Twenty-three years ago, a kind and wise grandmother purchased a life insurance policy for her new-born grandchild from FCSLA Life. The grandmother didn't have much money, so she purchased the youth term product that was available at that time.

When the grandmother purchased not only did the grandchild become insured but also:

• Became a member of FCSLA Life

- Participated in the FCSLA Life scholarship program
- · Was active in local FCSLA Life branch activities

Now at age 23 our now adult grandchild is getting married and starting a family. She understands the value of life insurance and would like to make sure she has a lifetime of coverage. The friendly and knowledgeable policy services representative mentions that she could convert her term policy to a permanent policy with no underwriting. She's very happy with that and proceeds with the conversion.

If someone was an adult when they purchased a term policy from FCSLA Life, possibly a 20 Year Level Term or and Annual Renewable Term those **may** also be eligible for conversion.

If you are a member with a term policy or purchased a term policy for a child or grandchild, you should investigate converting the policy to a permanent plan. The permanent plan will last a lifetime and build valuable cash value over time. There are some age and other restrictions regarding the conversion of term policies so if you think you might be interested in this don't put it off! NUT ROLL (KOLACHE)

Dough

- ³/₄ cup whole milk
 ¹/₄ cup warm water
 ¹/₄ cup unsalted butter melted (or vegetable oil)
 1 egg, room temperature
 1 package instant yeast
 ¹/₄ cup sugar (2 oz.)
- 3-3¼ cups flour bread, all-purpose or a combo of both
- 1 teaspoon salt

Walnut Filling

10 oz. ground walnuts 3/4 cup sugar 1 teaspoon cinnamon 6 tablespoons melted butter

Place the milk in a small saucepan and scald over medium heat. Do not let the milk simmer or boil. Once scalded, remove from heat to cool to 115 degrees before continuing.

In the bowl of a stand mixer with a dough hook, combine the milk, water, butter, egg, yeast, and sugar. Add most of the flour, then add the salt. Beat on a low speed for 2-3 minutes to combine, then knead on medium-high for 5-7 minutes.

Turn the dough out onto a lightly floured surface and cover with cling wrap. Let it rest for 10 minutes. Finish kneading the dough by hand until smooth and elastic.

Place dough in a greased bowl, turning to coat, and allow to rise in a warm, draft free location for about 1-2 hours, or until doubled in size.

After the first rise, punch the dough down and allow it to rise for another 30-45 minutes.

Combine the walnuts, sugar, and cinnamon to make the filling and set aside. If the walnuts are in large chunks, pulse in a food processor until fine/medium-fine.

Punch the dough down to expel any gas, then divide into 2 equal portions. Roll into rectangles, ¹/₈-inch thick. Keep the portions you are not working with covered so they don't dry out. Brush the dough with melted butter and cover with the filling. Be sure to leave space along the far, long edge of the dough for when you roll it up.

Roll the dough lengthwise, like a jelly roll, keeping it tight. Pinch the seam and ends closed and move to a cookie sheet, seam side down. Repeat with remaining portion.

Allow the loaves to rise for one hour. Make sure they are covered with cling wrap to prevent the dough from drying out. Preheat the oven to 350 degrees for at least 30 minutes before baking.

Bake the loaves at 350 degrees for 30-40 minutes. If they are browning too quickly you can tent a piece of foil over them. Allow to cool completely before slicing and serving.

If using active dry yeast: Sprinkle yeast over the warm water and dissolve. Stir after 5 minutes, then let it completely dissolve for another 5 minutes. Then add to wet ingredients. Makes 2 loaves.

POPPY SEED SWEET ROLL

Filling

1 cup poppy seeds, ground

1¹/₂ cups milk

- 1 teaspoon pure vanilla extract
- 3 tablespoons white corn syrup
- $\frac{1}{2}$ cup sugar
- 3 tablespoons unsalted butter
- 2 tablespoons all-purpose flour
- 1 pinch salt

In a medium saucepan, combine all ingredients. Bring to a boil over low heat. Reduce heat and simmer for 30 minutes, stirring frequently. Cool completely before using. Can be made ahead and stored in the refrigerator for up to one week.

GINGERBREAD COOKIES

3 cups all-purpose flour 2 teaspoons baking powder 1 tablespoon ground ginger ½ teaspoon ground allspice

1/2 teaspoon ground cloves

- 1/2 teaspoon ground cinnamon
- 1/2 teaspoon salt
- 1/2 cup shortening, melted
- and slightly cooled
- 1/2 cup molasses
- 1/2 cup brown sugar packed
- 1 large egg
- 2 teaspoons vanilla extract
- 3 tablespoons water

Sift the flour, baking powder, ginger, allspice, cloves, cinnamon and salt in a large bowl. Set aside.

In the bowl of your mixer, add the melted shortening, molasses, brown sugar, egg, vanilla and water. Using the paddle attachment mix on medium until smooth. Add the dry ingredients to the mixer bowl. Start on low, mix everything together until all the dry ingredients are completely incorporated.

Divide the dough into two equal portions. Use your hands to form into a ball then flatten into discs. Wrap each disc with plastic wrap and refrigerate for at least one hour or until the dough is chilled, but still pliable. Take the dough discs out of the refrigerator 20 minutes before rolling. Preheat the oven to 350°F. Line a baking sheet with parchment paper; set aside.

Unwrap the dough and place it on a floured work surface. Using a floured rolling pin, roll the dough until it's about ½-¼-inch in thickness. Use cookie cutters to cut the dough into cookies.

Transfer cut cookies onto the prepared baking sheet. Repeat with remaining cookie dough and re-roll leftover dough until finished.

Transfer the baking sheet to the preheated oven and bake for 8 to 10 minutes. The cookies are done when they no longer look dry, but still soft to the touch.

Let the cookies cool on the baking sheet for 5 minutes then transfer to a wire rack to finish cooling. When cool, frost or ice your cookies.

SUGAR PECANS

2 tablespoon butter melted

2 egg whites

1/2 cup brown sugar packed

- 1/2 cup sugar
- 1 teaspoon cinnamon ground

4 cups pecan halves

Preheat the oven to 350 degrees. Pour the butter and spread it over a baking sheet.

In a large bowl, mix the egg whites, sugar and cinnamon. Add the pecan halves and toss until they are fully coated.

Spread the pecans onto the baking sheet evenly. Bake for 30 minutes, stirring the pecans every 10 minutes. Check after 20 minutes of baking to make sure they don't burn.

Cool on the baking sheet for 10-15 minutes before serving.
