All the memories of the past that steal your peace today should not be allowed in the present. If you've been dragging around something that is dead, now it's time to choose life.

The Fifth Sorrowful Mystery:

THE CRUCIFIXION

My dear Sisters and Brothers,

This month we conclude our reflection on the Sorrowful Mysteries of the Rosary with the last mystery in this set of five – the Crucifixion. The Fruit of the Mystery is Forgiveness. The Crucifixion of Jesus is one of the most commented and discussed historical events in books, lectures and films. It is established and confirmed as a historical event even by non-Christian sources. The Crucifixion is considered to be one of two historically certain facts about Jesus, the other being Jesus' baptism in the River Jordan.

The earliest detailed accounts of the Crucifixion of Jesus are described in the "canonical" gospels; namely, those of Matthew, Mark, Luke and John. All four Gospels provide an almost hour-by-hour account of what took place from the point of Jesus' arrest through his trial, condemnation to death, carrying of the cross, crucifixion and including Christ's burial in the tomb.

Jesus had already been scourged and mocked with a crown of thorns and then was made to carry the cross to his own crucifixion. According to all four gospels, Jesus was brought to Golgotha or the "place of the skull" to be crucified between two criminals. The location was immediately outside Jerusalem's walls; the face of the hill resembled a skull. The word "Golgotha" is taken from the Greek translation of the Aramaic word for skull. "Calvary" is the English name we more commonly use for this place and is derived from calvaria, the Latin word for skull.

Crucifixion was mainly used for the worst criminals and was one of the slowest and most painful methods of causing death. In fact, the word "excruciating" is derived from "crucifixion." Still, even as the moment of Jesus' death was imminent, his forgiveness was exemplary. "Father, forgive them, for they know not what they do" (Luke 23:34). The Bible describes seven supernatural events that occurred while Jesus was on the cross, two of the most familiar being the sky turning dark in the middle of day and an earthquake. Those who

witnessed these events and had seen other miracles Jesus performed may have wondered why Jesus did not perform one more miracle where he saved himself. They did not know that Jesus' greatest miracle of conquering death was yet to come.

The Crucifixion was the most perfect example of God's love for us. Jesus died on the cross so that we might be set free from sin in order to spend eternity in the Kingdom of Heaven. It is up to each of us to return the love that we receive from God and to follow God's plan for us even in the face of great difficulty.

The reflections of the Sorrowful Mysteries over the past several months may have made you stop and contemplate or perhaps even made you uncomfortable at times. My goal was to give you all a clearer picture of what Jesus did for us in the name of love and forgiveness. Next month we go on to "lighter" reflections as we begin the five Glorious Mysteries of the Rosary. Until then, I hope you are all enjoying the hazy, lazy, crazy days of summer!

Call to Order/Prayer/Pledge of Allegiance

National President Cynthia M. Maleski called the meeting to order at 9:31 a.m. at the home office, Beachwood, Ohio. National Chaplain Monsignor Peter M. Polando was asked to open the meeting with prayer.

Opening Business

Roll Call

National Secretary Kimberly A. Graham was asked to call the roll. Members present were:

Approval of Agenda

President Maleski noted there was one amendment to add to the agenda under Unfinished/New Business which is the business travel policy. President Maleski called for approval of the agenda Chaplain Monsignor Polando moved National Director Patrick F. Braun seconded the motion.

APPROVED

Approval of the Minutes

President Maleski noted the minutes were distributed in advance and noted a few editorial changes. President Maleski called for a motion to approve the minutes and National Director Suzanne V. Strohl moved and National Director Sue Ann Seich seconded the motion.

APPROVED

National President's Comments

President Maleski welcomed our new rotating National Directors Larry Golofski and Patrick Braun. President Maleski reminded everyone of the process according to our bylaws III,J,1,d on Page 14 the board voted to rotate two National Directors each year. President Maleski thanked National Directors Jeanette Palanca and Joann Skvarek Banvich who are rotating off the Executive Committee this year. At the recent on-boarding session, it was agreed that Directors Palanca and Skvarek Banvich would continue as part of the carryover work to complete the review of the Board Policy and Procedures manual. President Maleski noted the role of the Executive Committee as a bridge to the Board of Directors as they provide their recommendations. President Maleski also welcomed Stu Collins as our new National Treasurer.

Strategic Planning

President Maleski noted Balanced Growth, our outside strategic planner, has completed the discovery phase and conducted

31 interviews with board members, management team, additional FCSLA Leaders and key stakeholders. In addition, Balanced Growth completed an environmental scan. The next step is to review these results with the management team and board of directors; then, the project is ready to move into the Design Phase.

2021 Board Education

President Maleski stated there is a 3-prong approach for board training and communications. First, is the virtual training tool we are using with Microsoft Teams. Second, AFA has provided us the opportunity for board members to attend any of the 3 virtual board training programs. Third, regarding the financial and investment side, President Maleski and Treasurer Collins worked together to provide a training presentation by an outside person regarding bond education at an upcoming board meeting possibly in March. President Maleski vetted this idea with the Chair of the Board Performance and Review committee, and she was supportive of this idea.

Product Development

President Maleski noted we had several meetings with the product development committee to evaluate the nonforfeiture valuation requirements made by the NAIC in July 2020. Originally, there was a requirement for the reduction of valuation interest rates for reserves from 3.5% to 3.0% for new life insurance policies issued on or after January 1, 2021. In the fall, our National Treasurer Steven Hudak at the time and our outside actuary did complete that review and exercise. This required new reserve tables and new codes and that was completed. President Maleski noted that she reported at the September board meeting that we had begun our assumption analysis that changed our interest rate for cash values/nonforfeiture values from 4.5% to 4.0%. Originally, we assumed this would have an impact on product profitability and some policy filings would be necessary. The Product Development committee headed by co-chairs National Sales Manager Paul Smithers and Insurance Manager and IT Coordinator Paula Dalpiaz was moving along that path. Then at the end of the year, Congress passed a new valuation standard, and all life insurance products will need to adhere to the maximum nonforfeiture interest rate of 3.75% so this requires a pivot from the 4%. This is a dramatic change. We again met with our actuary to review our assumptions to take this lower amount into consideration. Our goal in this analysis is to be as competitive as we can while remaining profitable and sustainable. We are currently working on the SPWL which is our major product, and these assumptions will most probably flow down into the other whole life products. We are reviewing all current life products except the youth term and we are also developing new products such as the 20-year life plan and a more standardized term product. The phases of this project are as follows: Phase 1 is development, Phase 2 is Installation and Marketing, Phase 3 is testing, and Phase 4 is deployment. The committee is also considering adding riders. The plan is to have a timeline for the phases, so it is completed by the end of the year.

Rebranding

President Maleski stated Secretary Graham is the lead on

this project and I have a detailed timeline from her, and we are currently in Phase 3 which is the implementation phase and launch. President Maleski stated we just hired a Marketing Coordinator Renée DeLuca who reports to Secretary Graham. President Maleski held a meeting with Secretary Graham, Marketing Coordinator DeLuca, and Sales Manager Smithers and told them we need to work as a team to build this rebranding correctly and asked them to develop an updated sales and marketing plan.

Human Resources Projects

President Maleski noted we are delighted to have Treasurer Stu Collins join our organization and the management team. We have appointed Katherine Bowes as the National Fraternal and Youth Director. Renée DeLuca was hired as our new Marketing Coordinator. President Maleski we are currently recruiting an enhanced IT Manager who would work full time with us. We had consulted with a firm we had used in the past to work with us to develop the necessary IT role and job description now that Consultant Jean Bush is retiring. In addition, ODI noted a new cybersecurity law that was recently instituted in Ohio and there are similar laws in other states requiring the IT Manager to stay abreast of these regulations and work with the management team.

FCSLA Cybersecurity Program

As a follow-up to our November meeting, President Maleski noted we passed a motion to recommend the Cybersecurity Response Plan be developed, implemented, and it has now been completed. A comprehensive checklist is completed every year by IT. It was reviewed at the IT Steering Committee on February 2, 2021 and Compliance will file this certificate in a timely fashion.

Heart of A Shepherd

President Maleski remarked that she had been contacted by the Bishop of Cleveland, Most Reverend Edward C. Malesic, JCL regarding a Diocese of Cleveland seminary campaign supporting Borromeo and Saint Mary Seminaries. President Maleski explained our normal process of donations to Bishop Malesic.

Approval of President's Report

Trustee Seich moved to accept the President's report and seconded by Trustee Strohl.

MOTION ADOPTED

National Treasurer's Report

Treasurer Collins presented the Treasurer's Report as of December 31, 2020. Treasurer Collins reviewed the financial review and graphs of Asset Growth, Surplus, and Income by Type, Net Income before Dividends, Bond Rating, and a snapshot of our portfolio, as well as a graphical review of our revenue for the last five years. At the end of December, our admitted assets were at \$1.063 billion and our surplus is \$107.4 million.

Treasurer Collins reviewed the preliminary Balance Sheet, and Income Statement as of December 31, 2020. Questions were asked and answered.

Annuity Reserves by Product


The community provides showers, toilet facilities and food for the homeless, as well as bagged food at the door for the needy.

GRILLED BLUE CHEESE BURGERS WITH FRIED ONIONS

2 tablespoons butter

1 teaspoon salt, or to taste

1 teaspoon pepper, or to taste

2 onions, sliced

4 burger buns

4 burger patties

4 blue cheese slices

2 large tomatoes, sliced

Baby arugula or baby kale

4 tablespoons sweet and spicy mustard

Prepare your grill for cooking over high direct heat.

In a large skillet melt the butter over medium-high heat. Add onions, season with $\frac{1}{2}$ teaspoon each salt and pepper, then cook until crispy.

Oil the grill first before laying down the patties.

Season the burger patties with remaining salt and pepper. Add the patties to the grill and cook for about 5 minutes per side.

Lay a slice of blue cheese over each patty for the last 2 minutes of cooking. If you want to grill your burger buns, add them to the grill now and don't leave them more than 30 seconds.

Remove everything from grill and assemble the burgers. Spread 1 tablespoon of mustard on the bun. Top with some baby arugula or kale, lay the burger patty, tomato slices, crispy onions and top bun.

CHICKEN RANCH PASTA SALAD

For Dressing

3/4 cup mayonnaise

½ cup sour cream

1 cup ranch dressing

1/4 cup chives, chopped

1/4 teaspoon salt, or to taste

1/4 teaspoon pepper, or to taste

For Pasta Salad

10 oz. Penne pasta

6 slices bacon, chopped and fried

2 chicken breasts, cooked and diced, about 2 cups), using a Rotisserie chicken makes it convenient 1 stalk celery, chopped

1/4 cup black olives, sliced

1 cup cherry tomatoes, halved

In a medium size bowl whisk together the dressing ingredients. Cover with plastic wrap and refrigerate until ready to use.

Cook the pasta according to package instructions. Drain in a colander and rinse it under cold water.

Transfer the pasta to a large bowl. Add the bacon, chicken breast, celery, black olives and cherry tomatoes, then add the prepared dressing. Toss well.

STRAWBERRY SHORTCAKES

For Strawberry Topping
1 pound strawberries, stemmed
and chopped
2 tablespoons sugar
Zest from 1 lemon
Juice from 1 lemon

For biscuits

3 cups all-purpose flour

4 teaspoons baking powder

1/4 teaspoon salt

1/4 cup sugar

12 tablespoons butter (11/2 sticks)

½ cup half and half or heavy cream

2 eggs

For Whipped Topping

1½ cups whipping cream

2 tablespoons powdered sugar

1 teaspoon vanilla extract

In a medium sized bowl, mix strawberries with 2 tablespoons sugar, lemon zest and lemon juice. Toss well and refrigerate for 30 minutes.

Preheat the oven to 375 degrees. Line a baking sheet with parchment paper.

In a large bowl, add the flour, baking powder, salt, sugar and mix together. Add butter and cut it in using a pastry cutter or 2 knives or forks until it resembles peas. In a small bowl whisk together the half and half and the 2 eggs and add to the bowl with flour mixture. Stir with a fork and then eventually use your hands to mix the dough a bit until it comes together. Turn the dough onto your work surface and knead until it no

longer crumbles and it all comes together. Roll out so that it's about 1 inch in thickness then using a 2½ inch cutter cut into circles. You should get about 12 biscuits.

Place biscuit on prepared baking sheet and bake for about 18 minutes or until golden.

Add whipped topping ingredients to a mixing bowl and mix on high until stiff peaks form.

To assemble shortcakes cut each biscuit in half. Spoon some of the whipped topping then strawberries with their juice onto each shortcake bottom. Place the shortcake on top. Spoon more strawberries over the top if preferred and serve.

CHERRY COBBLER

Cherry filling

2 lbs. cherries fresh, pitted and cut in half

½ cup sugar, granulated

2 tablespoons cornstarch

2 tablespoons lemon juice

1/4 teaspoon salt

Batter

1 cup all purpose flour

1 cup sugar

1 tablespoon baking powder

1/4 teaspoon salt

1 egg

3/4 cup milk

½ cup butter unsalted, melted, for the skillet Preheat oven to 375 degrees.

Wash and pit your cherries. Slice them in half and add them to a saucepan with the rest of the filling ingredients. Cook them over medium heat for about 5 minutes, stirring occasionally.

Mix the flour, sugar, baking powder, salt, egg, and milk in a bowl until smooth. Melt the butter in the skillet, remove from heat, then pour the batter in.

Spoon the cherry mixture in an even layer over the batter and turn the oven down to 350F. Bake for 40 to 45 minutes, or until golden brown.

STRAWBERRY MARGARITAS

3 cups strawberries fresh, washed and stems removed

3/4 cup tequila

½ cup sugar

½ cup water cold

1/4 cup lime juice, freshly squeezed

1/4 cup triple sec

1/8 teaspoon salt

3 cups ice

Place all ingredients except the ice in a blender and blend on high until smooth. Add the ice and continue blending on high until smooth.

Serve immediately.
