- June 1 Memorial of Saint Justin martyr in the early Church (+165) who wrote one of the earliest descriptions of Holy Mass celebrations in the early history of the Church. I celebrated Mass in the undercroft of the main altar at St Peter Basilica, Rome with my canon lawyer classmates on June 1, 1994.
- **June 4** Mass of the Most Holy Trinity celebrated annually the Sunday after Pentecost. It celebrates the



fullness of our Godhead: the Father, the Son, and the Holy Spirit.

- **June 11** Mass of the Most Holy Body and Blood of Christ (Corpus Christi) celebrated annually the Sunday after Holy Trinity. At the end of the weekend liturgies, churches may have a procession with the Eucharist around the church, inside or outside.
- June 13 Memorial Saint Anthony of Padua priest and Doctor of the Church (+1231) who was born in Lisbon and patron saint of Portugal and also to the poor, of harvests and of lost articles. This day ends his novena of thirteen Tuesdays prior to his feast day. He is one of my favorite saints because I am always losing something!
- June 14 Flag Day celebrates the anniversary of the adoption of the flag of the United States of America.
 We should show respect to our flag! Let us fly it with pride!
- June 15 Solemnity of the Most Sacred Heart of Jesus celebrated annually on the second Friday after Pentecost. Jesus loves us so much as he stretches out His hands and arms revealing the everlasting love that is burning in His Sacred Heart.
- June 16 Memorial of the Immaculate Heart of Mary

 celebrated annually on the second Saturday after
 Pentecost. Through the Heart of her Son, Mary shares in her heart the immense love she has for all of us, the sisters and brothers of her Son.
- June 18 Father's Day All of us should give thanks to Almighty God for the gifts of our fathers for they are a part of our births. Pray for our Fathers, both living and deceased!
- June 21 The Summer Solstice takes place at 10:58 AM, EDT. Happy Summer! (Also, it is the anniversary of my priestly ordination in 1980!)
- June 24 Solemnity of the Nativity of Saint John the Baptist Saint Augustine writes about the Saint as the light that lessens after the Summer Solstice but the light of Jesus' birth increases after the Winter Solstice which commences this year on 21 December at 5:02 AM, EST)
- June 29 Solemnity of Saints Peter and Paul Peter was the first bishop of Rome and known as the proclaimer of the Gospel to the Jewish people. Paul received the Risen Christ into his life on the road to Damascus, and known to be the proclaimer of the Gospel to the Gentile people.

To all of our members and you families: Enjoy the month of June and all the months of summer with your family and friends. Take note of the feast/holidays as listed above plus your own. They will enlighten you in faith and history!



BOARD OF DIRECTORS VERIFICATION PROCESS

Individuals must submit resumes containing a list of qualifications for the national office being sought, along with a completed Letter of Intent and the required fee. The Letter of Intent may be obtained from our National Secretary, Kimberly Graham and must be returned by August 2nd, 2023 to the attention of National President Cynthia Maleski.

The verification process was approved by the Board of Directors at their quarterly March 23rd, 2023 meeting. An outside contracted company with an office located in Cleveland, Ohio will verify education, employment data, and work experience.

The Credential Committee made up of appointed convention delegates not seeking national office, will review the resumes, fraternal qualifications, and verification reports for the individuals who have submitted Letters of Intent to determine if those individuals meet the qualifications as set forth in the bylaws.

To obtain a Letter of Intent or if you have questions, contact the National Secretary prior to the August 2nd, 2023 deadline.


donated 65 to the Rescue Mission and 65 to the Beatitude House equally 130 in honor of the 130th anniversary year.



GARLIC BUTTER STEAK BITES

1 tablespoon olive oil

1½ pound sirloin steak, cut into bite size pieces, or strip loin, tenderloin, strip steak or rib eye

1/2 teaspoon salt or to taste

½ teaspoon pepper or to taste

2 tablespoons butter unsalted

4 cloves garlic minced

1/4 teaspoon red pepper flakes

1 tablespoon parsley fresh, chopped

Add the olive oil to a large skillet and heat it over high heat. Make sure the olive oil is hot, then add the steak pieces to it. Season them generously with salt and pepper.

Cook for at least 2 minutes before stirring the steak pieces. You want to make sure you get a good sear on them. Continue cooking for another 2 minutes until they're golden brown. If your skillet isn't big enough, you may need to do this in batches.

Transfer the steak bites to a plate and in the same skillet add the butter. Turn the heat down to a medium and after the butter has melted, add the garlic and red pepper flakes. Cook for about 30 seconds while stirring, just until the garlic becomes aromatic and starts to brown.

Pour the garlic butter over the steak bites and toss well. Garnish with parsley and serve

Notes: Make sure to pat the steak dry with paper towels before cutting into bitesized pieces. This helps the steak to brown nicely and develop a delicious crust.

Preheat the pan before adding the steak bites to ensure a good sear and even cooking.

Cook the steak bites in batches to avoid overcrowding the pan, which can lead to steaming instead of browning.

Allow the steak bites to rest for a few minutes after cooking to retain their juices and ensure a tender, flavorful result.

APPLE AND ORANGE SALAD

2 tablespoon olive oil2 tablespoon red wine vinegar½ tablespoon orange juice freshly squeezed 1/2 cup raisins

1 orange

4 apples

3/3 cup pecans or walnuts, roughly chopped

1/4 teaspoon salt or to taste

1/4 teaspoon pepper or to taste

In a large bowl, whisk the olive oil, red wine vinegar, and orange juice. Add the raisins and set it aside.

Peel the orange and cut it into small pieces. Core the apples and cut them in small pieces.

Add the oranges, apples, pecans to the bowl with raisins. Add salt and pepper to taste. Toss everything together very well and serve.

ONE PAN ROASTED HONEY ORANGE CHICKEN AND POTATOES

For Potatoes

 $1\frac{1}{2}$ pounds baby potatoes cleaned

1 tablespoon olive oil

1 teaspoon Italian seasoning

1/4 teaspoon salt

1/4 teaspoon black pepper ground

For Chicken Thighs

1/4 cup honey

1 tablespoon chili garlic sauce

6 chicken thighs with skin and bones

1 medium orange cut into 1/4" slices

1/2 teaspoon salt

1/2 teaspoon black pepper ground

Optional

1/4 cup pomegranate seeds

1/4 cup fresh parsley chopped

Preheat the oven to 425 degrees. Line a baking sheet with parchment paper.

In a large bowl toss together the baby potatoes with the olive oil, Italian seasoning, salt and pepper. Set aside.

Microwave the honey for about 20 seconds just so that it warms up a bit, then whisk it together with the garlic chili sauce in a small bowl. Place the chicken thighs skin side down on the prepared baking sheet. Brush each thigh generously with the honey mixture, then season with a bit of salt and pepper. Flip the thighs over so that the skin side is up and repeat brushing with the honey mixture and seasoning with salt and pepper.

Scatter the potatoes around the chicken thighs then place the orange slices over top.

Bake for about an hour until the skin is golden brown and the meat easily detaches from the bone. The potatoes should also be nicely baked and golden brown.

Garnish with pomegranate seeds and parsley if preferred. Serve while warm.

Notes: Usually baby potatoes only require about 20 to 30 minutes in the oven, but because they roasted together with the honey mixture from the chicken, the potatoes almost get caramelized on the bottom. If you prefer your potatoes less cooked, simply add them 30 minutes into roasting the chicken.

Drumsticks can also be used in this recipe with no change to cooking time, temperature or ingredients.

If you're using skinless boneless thighs, the roasting time will only be around 30 minutes.

OLD FASHIONED LEMON BREAD

Bread

11/2 cups all-purpose flour

1 teaspoon baking powder

½ teaspoon salt

2 large eggs

3/3 cup evaporated milk

1 cup granulated sugar

1/₃ cup vegetable oil

11/2 teaspoon lemon zest

from about 1 lemon

Lemon Syrup

1/4 cup lemon juice freshly squeezed

⅓ cup sugar

Preheat oven and prepare pan: Preheat oven to 350 degrees. Grease and flour 8 x 4-inch baking pan.

Combine flour, baking powder and salt in large bowl. Beat eggs, evaporated milk, sugar, oil and lemon zest together in medium bowl. Add the flour mixture into the egg mixture. Stir until just combined. Pour into prepared pan.

Bake for 55 to 60 minutes or until wooden skewer inserted in center comes out clean. Let it cool for 5 minutes in the loaf pan, then remove the loaf from the pan and transfer it to a cooling rack.

While the bread is baking, combine ½ cup granulated sugar and ½ cup lemon juice (1 lemon) in small, heavy-duty saucepan. Cook over medium-low heat, stirring constantly, for about 5 minutes or until sugar is dissolved and a light syrup is formed.

While the bread is still warm, poke numerous holes using a wooden skewer, piercing all the way to the bottom. Slowly drizzle the hot lemon syrup over the bread (syrup will soak into the bread). Finish cooling the bread on wire rack.
