Do You Believe in You?

Did you know that Albert Einstein could not speak until he was four years old and did not read until he was seven? His parents and teachers worried about his mental ability.



Or that Beethoven's music teacher said about him, "As a composer he is hopeless"? What if young Ludwig believed it?

When Thomas Edison was a young boy, his teachers said he was so stupid he could never learn anything. He once said, "I remember I used to never be able to get along at school. I was always at the foot of my class...my father thought

I was stupid, and I almost decided that I was a dunce." What if young Thomas believed what they said about him?

When F. W. Woolworth was 21, he got a job in a store, but was not allowed to wait on customers because, according to his boss, he "didn't have enough sense." I wonder if the boss was around when Woolworth became one of the most successful retailers of his day.

When the sculptor Auguste Rodin was young he had difficulty learning to read and write. Today, we may say he had a learning disability, but his father said of him, "I have an idiot for a son." His uncle agreed. "He's uneducable," he said. What if the boy had doubted his ability to excel?

A newspaper editor once fired Walt Disney because he was thought to have no "good ideas." The great Italian tenor Enrico Caruso was told by one music teacher, "You can't sing. You have no voice at all." And an editor told Louisa May Alcott, just a few years before she wrote the classic novel Little Women, that she was incapable of writing anything that would have popular appeal.

History will long praise each of these famous people, but what became of their critics? Nobody even remembers some of their names, which is all that need be said.

But what if these young people had listened to those critical voices and became discouraged? Where would our world be without the music of Beethoven and Caruso, the art of Rodin, the ideas of Albert Einstein and Thomas Edison, the imagination of Walt Disney or the literary contributions of Louisa May Alcott? As it was so accurately put, "It's not what you are, it's what you don't become that hurts." (That from Oscar Levant.) What if these people had not become what they were capable becoming, had not done what they actually could have accomplished, just because they were discouraged by people who couldn't see them for what they were?

We all have potential and, whether you realize it or not, your desire to do or be more than you are is your best indicator of future success. Others may discourage you, but the most important voice to listen to is your own. Do you believe in you?

Our Annual Lenten Journey

My dear Sisters and Brothers,

On Wednesday, 2 March 2022, we enter into the annual Paschal preparation period that we call Lent. Lent is that very profound time of the year for each Christian to look into her/his heart to review how our life is or is not in conformity to the teachings and preachings of Jesus Christ. It is a time of forty days to seek God's forgiveness, forgiveness from neighbor, and to bestow forgiveness with those who may have offended us in

one way or another or we have sinned against them. These days remind us of our human frailty and sinfulness so that we may make a change of heart and enter into stronger and better grace-filled relationships with our God and with each other.

The ministry of Jesus was one of forgiveness. Two passages that immediately come to mind for me are in the Gospel of Luke. The first is that one in the early part of Jesus' public ministry where He encounters the paralytic. Recall that there was a vast crowd in the presence of Jesus. The friends of the paralytic, seeking a cure from Jesus, lowered the stretcher upon which the paralytic was on, through the tiles of the roof, and placed him in front of the Lord. Jesus "When he saw their faith said, 'As for you, your sins are forgiven.' Then the scribes and Pharisees began to ask themselves, 'Who is this who speaks Who but God blasphemies?

alone can forgive sins?' Jesus knew their thoughts and said to them in reply, 'What are you thinking in your hearts? Which is easier, to say, "your sins are forgiven," or to say, "Rise and walk"? But that you may know that the son of Man has authority on earth to forgive sins' – he said to the man who was paralyzed, 'I say to you, rise, pick up your stretcher, and go home.' He stood up immediately before them, picked up what he had been lying on and went home, glorifying God" [5:17-26].

Later, in the same Gospel, we read the words of the author who gives us the backdrop of all of our lives to which we are called in the person of Jesus. Drawn into the mystery of our salvation, the Crucifixion scene, Luke relates to the reader

Christ's major focus of His earthly ministry for all people of every age. "When they came to the place called the Skull, they crucified him and the criminals there, one on his right, the other on his left. [Then Jesus said, 'Father, forgive them, they know not what they do'] [23:33-34].

Forgiveness. Is this not the essence of our Catholic Faith? Especially in this Lenten Season, it is so very important to look deeply into our souls and hearts to forgive. And I do

not think that we have to ponder too long, either! Let us start by cleaning out our own homes. There are many of us who have held grudges and fail to talk to members of our own family or people who we once held as dear friends in our lives but because of what was said or an incident that occurred in the past, we have separated ourselves from them and had these occurrences fester in our lives to the point of obsession at times. Where is the forgiveness? Which is easier to say, "I forgive you of your sin" or to say "Rise and walk with me again"? Or, "Father, forgive me and forgive them for I and they know not what I and they do". Dare I say that forgiveness should be daily spiritual fixtures in the expression of faith in the name of Jesus.

Lent also is that period of time where forgiveness are exhibited through our extra prayer, fasting, and almsgiving.

Joyfully yet humbly take on the traditional practices of fasting and abstaining. Canon Law of the Church requires all Catholics over the age of eighteen to fast (one major meal with two minor meals combined not to exceed the major meal and no eating in between meals) on Ash Wednesday and Good Friday. Those Catholics over the age of fourteen are required to abstain from the eating of meat on the aforementioned days as well as on all Fridays of Lent. These days should be ones of meager meals and the monies that would have been utilized for fuller meals should be donated to the poor. Almsgiving is an important component of the Lenten observance. We must align ourselves with the poor. The mercy of the Lord then will endure forever!







HOT ARTICHOKE & SPINACH DIP

- 1 box (9 oz.) frozen spinach, thawed, squeezed to drain
- 1 can (14 oz.) quartered artichoke hearts, drained, chopped
- ½ cup refrigerated Alfredo pasta sauce (from 10-oz. container)
- ½ cup mayonnaise
- 3/4 teaspoon garlic salt
- 1/4 teaspoon pepper
- 1 cup shredded Swiss cheese (4 oz.)
- 1 loaf (20-inch length) baguette French bread, cut into 40 slices

In 1- to $1\frac{1}{2}$ -quart slow cooker, mix all ingredients except bread.

Cover; cook on Low heat setting 2 to 4 hours. Serve dip with sliced bread.

SALSA CHICKEN

- 2 pounds chicken breasts boneless, skinless (about 4) Fresh, not frozen
- 2 cups salsa mild
- 1 cup Mexican Blend cheese shredded

Place whole chicken breasts in your crockpot then pour the salsa over each breast.

Cook anywhere from 1 $\frac{1}{2}$ to 2 hours on high or 4 hours on low. It will start falling apart if cooked longer.

Preheat oven to 425 degrees.

Transfer the chicken to a 9x13 inch baking dish. Spoon some of the leftover salsa over the chicken. Sprinkle each breast with cheese, about ½ cup of cheese for each breast.

Place the baking dish in the oven and bake for 15 minutes or until the cheese is golden brown and is bubbling.

BROWN SUGAR PULLED CHICKEN

Perfect for tacos, burritos, quesadillas or sandwiches

2 pounds chicken thighs boneless, skinless 1 cup water

1/2 teaspoon salt

1/2 teaspoon pepper freshly ground

1 teaspoon oregano dried

½ cup brown sugar packed

2 tablespoons soy sauce low sodium

2 tablespoons balsamic vinegar1 tablespoon cornstarch

Add the chicken to the slow cooker. In a small bowl mix together oregano, salt, pepper and ½ cup of the water. Pour over the chicken. Cook on high for 2½ hours.

After 2 ½ hours, mix the remaining ingredients with the ½ cup water left, in a small saucepan. Heat over medium heat until the mixture starts to thicken. It should start to thicken as soon as it comes to a boil.

Add sauce over chicken: Pour the mixture over the chicken in the slow cooker and toss, so that the chicken is covered in the sauce thoroughly.

Continue cooking: Cook for an additional hour in the slow cooker on low.

Remove the chicken from slow cooker into a big bowl and carefully pull it apart using two forks.

Serve warm with remaining glaze on the side, if preferred.

SHORT RIBS

- 1 tablespoon vegetable oil
- 3 pounds beef chuck short ribs bone-in
- 1/2 teaspoon salt or to taste
- 1 teaspoon pepper or to taste
- 1 medium onion peeled and quartered
- 2 large carrots cut into large chunks
- 2 medium parsnips cut into large chunks
- 2 sprigs rosemary fresh
- 1 teaspoon thyme dried
- 4 sprigs fresh parsley stems and leaves separated
- 1 tablespoon Worcestershire sauce
- 2 bottles dark stout beer 2 (12-ounce) bottles, such as Guinness

In a large skillet over medium-high heat, add the oil. Season the short ribs with salt and pepper. When the oil is hot, brown the short ribs, in batches, until they are browned on all sides, about 1 to 2 minutes per side.

While the short ribs are browning, place a layer of onion and carrot pieces into the bottom of a slow cooker and season them with salt and pepper. Place the browned meat on top. Add the remaining onions and carrots along with the parsnips and herbs. Add Worcestershire and pour over the stout and add enough water to almost cover the contents. Cover and cook on low

for 8 hours, or high for 4 hours or until the meat is very tender.

To serve, carefully remove the meat and vegetables from the slow cooker. Strain the juices. Serve the ribs with the juice and garnish with chopped parsley leaves.

BLACK FOREST CAKE

box Super Moist chocolate fudge cake mix
 Water, vegetable oil and eggs called for
 on cake mix box

1/2 cup butter, melted

- 1 can (21 oz.) cherry pie filling
- 1 container (8 oz.) frozen whipped topping, thawed

Make cake batter as directed on box. In 3½- to 4-quart slow cooker, pour melted butter. Pour in cake batter (do not stir). Add cherry pie filling, pouring into center.

Cover; cook on low heat setting 2 to 4 hours or until toothpick inserted in center comes out clean. Serve warm in bowls topped with whipped topping.

PINEAPPLE UPSIDE DOWN CAKE

1 cup packed brown sugar ½ cup butter, melted

- 1 can (20 oz.) pineapple slices in juice, drained, juice reserved
- 10 maraschino cherries without stems, drained
- box Super Moist yellow cake mix
 Vegetable oil and eggs called for
 on cake mix box

Spray 6-quart slow cooker with cooking spray. In small bowl, mix brown sugar and melted butter; spread evenly in bottom of slow cooker. Arrange pineapple slices on brown sugar mixture, cutting as needed to fit in one layer. Place cherry in center of each slice and around slices, as needed.

Add enough water to reserved pineapple juice to measure 1 cup. Make cake batter as directed on box, substituting pineapple juice mixture for the water. Pour batter over pineapple and cherries.

Cook on High heat setting 2 ½ to 3 hours or until toothpick inserted in center comes out clean. Turn off slow cooker; uncover. Remove ceramic base from cooker to cooling rack. Cool 15 minutes.

Place heatproof serving plate upside down onto ceramic base; carefully turn plate and ceramic base over. Remove ceramic base.
