Fourth Glorious Mystery: THE ASSUMPTION OF THE BLESSED VIRGIN MARY

Dear Sisters and Brothers,

The Fourth Glorious Mystery is Mary's Assumption into Heaven. The fruit most commonly associated with the mystery of the Assumption is the grace of a happy death.

After the descent of the Holy Spirit on Pentecost, the apostles began their mission to convert and baptize. We know the beloved disciple, Saint John, took care of Mary after Christ's death and resurrection. There she lived for many years and was a source of comfort and strength to the apostles. Just as Mary nourished her infant Jesus, she nourished the infant Church spiritually.

One might ask how could God honor her more than he already had by choosing her to be the Mother of God? God had one final gift for Mary, his most humble of servants. Mary's body would not suffer the corruption of death but would become the first fruit of Christ's Resurrection. Her body, as well as her soul, would be assumed into heaven and be a symbol for us of the resurrection of the body. Jesus did not permit the sinless body of his mother to decay in the grave. Corruption of the body is an effect of original sin from which Mary was totally exempted. Because Mary did not succumb to death by sinning, her flesh never lost its eternal life, and thus she was "assumed" or transferred bodily to heaven.

Although our Holy Church tradition teaches that Mary was assumed into heaven at the end of her earthly life, there is no narrative of this event in Scripture. Still early Christians knew that Mary was taken up into Heaven. The early Church would have known Mary as a saint and wanted to collect relics. We have relics of the apostles and so many of the greatest saints and martyrs in history but not a single relic of Mary's body. As revered as Mary was, this would be very strange, except for the fact of the assumption of her body. The absence of such relics speaks to the reality of this mystery.

Many times throughout Church history, the Church clearly and specifically has made official and infallible what it has already taught for centuries. This is done by virtue of a dogma. On November 1, 1950, Pope Pius XII declared in an Apostolic constitution known as the *Munificentissimus Deus*, that it is a dogma of the Church "that the Immaculate Mother of God, the ever Virgin Mary, having completed the course of her earthly life, was assumed body and soul into heavenly glory."

Only Mary, who was born without stain of original sin – the Immaculate Conception – could give birth to Christ, who is fully God and fully human. Because of Mary's role in God's plan of salvation, she did not suffer from the effects of sin, which are death and decay. Mary is the first to receive the fullness of the redemption that Jesus won for all of humanity. The Church teaches us that the Assumption is "an anticipation of the resurrection of other Christians." We can look to the life of Mary as an example of faith and holiness, and we can look at her death and assumption as an example of what we can expect. Every time we recite the Nicene Creed, we say: "I look forward to the resurrection of the Assumption of the Blessed Virgin Mary, we can envision what those words actually mean for us.



Heritage – Our Ancestors' Greatest Gift

One of my favorite movies of the past year is "The Last Blockbuster" a documentary about the lone remaining Blockbuster video store in Bend, Oregon.

The movie focuses on this video rental store as the last remnant of an era when people were renting physical videotapes and DVDs of films that they can now download or stream through their home computers. It focused on the death of a major company done in by shifts in technology and how this lone store has won the hearts of video fans simply because it wouldn't quit.



an ethnic radio program in Cleveland, Ohio, and there are times when I wonder whether broadcasters like me will someday be the lone holdouts as people forget the heritage left by their parents or grandparents or other ancestors.

Let's take a moment to imagine the city of Cleveland in 1890 or 1895, at the height of European immigration – around the time that the First Catholic Slovak Ladies Association was founded.

At that time, fifty percent of Cleveland's population was foreign born. If you were walking down Cleveland's main commercial street, every other person you would see would be from another country.

More than anything, these people needed something to hang onto, not only for their own security but for their own thought processes.

And before these immigrants had radio, they had newspapers, and cultural, religious, and fraternal organizations, many of which, like FCSLA Life, are still with us today. And these elements are all tied to their family, language, and religion.

By the 1920s and 30s many of these immigrants of the 1890s had assimilated into American ways, but their thoughts and dreams would always be in another language. And that's where ethnic radio came in – to reach out to these people, who still longed to hear the language and music of their native land.

This tradition continues to the present day – perhaps for different reasons. Today, many who are foreign born still listen to programs that broadcast in their language, but others listen to these shows because that's what their parents or grandparents or previous generations did, and they want to reach back to reclaim the culture of their ancestors.

Some listen for nostalgic reasons, and that's not a bad thing. But many tune in to a particular ethnic program because they feel drawn to their ancestors' memory. It's a simple fact that decisions your ancestors made perhaps more than a century ago directly affect who and where you are today. You are their heritage.

And that's why I continue the tradition of Czech – and perhaps a little Slovak – radio, not for the sake of nostalgia but to help listeners learn about their culture and remind them that there was a time when their grandparents and beyond lived in a heavily Slovak, Czech, Polish, Italian, Irish or any other ethnic neighborhood, where they could deal with merchants who understood their language or culture and the truths that language and culture imparted. And where they could worship or gather with folks who spoke those eternal truths.

The same can be said for today's immigrants, who want so much to be part of the American fabric but also want to add their own pattern to our patchwork society.

But none of us can ever lose track of who and where we are. To do so would allow us to become a homogenized society with less and less ethnic diversity.

I will always be grateful for the continued support the New Czech Voice has received from FCSLA Life and National President Cynthia Maleski. Because of this support we all benefit.

Through their carefully thought-out mission statements and support of radio programs like the New Czech Voice of Cleveland, organizations such as FCSLALife help all of us to retain our ethnic identity and assert our role as proud Americans. And they help preserve the three greatest gifts we received from our ancestors – family, language, and religion.

NEW HOLIDAY TRADITIONS

TRIPLE CRANBERRY SAUCE

- 1 package (12 oz.) fresh or frozen cranberries
- 1 cup thawed cranberry juice concentrate $\frac{1}{2}$ cup dried cranberries
- ⅓ cup sugar
- 3 tablespoons orange juice
- 3 tablespoons orange marmalade
- 2 teaspoons grated orange zest
- 1/4 teaspoon ground allspice

In a small saucepan, combine the cranberries, cranberry juice concentrate, dried cranberries and sugar. Cook over medium heat until the berries pop, about 15 minutes.

Remove from the heat; stir in the orange juice, marmalade, orange zest and allspice. Transfer to a small bowl; refrigerate until chilled.

SAUERKRAUT SOUP

- 1 tablespoon olive oil
- 8 oz. bacon, chopped
- 1 stick celery, diced
- 1 medium onion, diced
- 2 medium carrots, sliced thin
- 1 lb. potatoes, peeled and sliced into ¹/₃" thick pieces
- 1/4 cup quinoa, rinsed, optional
- 3 cups sauerkraut, triple rinsed & drained
- 8 cups chicken broth
- 2 cups water, or to taste
- 1 (15 oz.) can Great Northern beans
- 1 bay leaf

Salt and pepper to taste

Heat olive oil in a large soup pot or Dutch oven. Add chopped bacon and sautee until browned. Remove with a slotted spoon and set aside.

Add chopped celery and onion. Saute until softened and golden for around 5 minutes. Add sliced carrots, potatoes, ¼ cup quinoa (optional), 8 cups broth and 2 cups water. Bring to a boil then reduce heat and simmer 15 minutes.

Add 2-3 cups of well rinsed and drained sauerkraut and half of cooked bacon, reserving some for garnish, beans including their juice, and 1 bay leaf. Continue to cook until potatoes are tender, around 10 minutes longer. Season soup to taste. Serve with fresh crusty bread.

SIMPLE SLOW-COOKED STUFFING

- 1 cup chopped onion
- 1 cup chopped celery
- ¹/₄ cup butter
- 6 cups cubed day-old white bread
- 6 cups cubed day-old whole wheat bread
- 1 teaspoon salt
- 1 teaspoon poultry seasoning
- 1 teaspoon rubbed sage
- 1/2 teaspoon pepper
- 1 can (14¹/₂ ounces) reduced-sodium chicken broth or vegetable broth
- 2 large eggs, beaten

In a small nonstick skillet over medium heat, cook onion and celery in butter until tender.

In a large bowl, combine the bread cubes, salt, poultry seasoning, sage and pepper. Stir in onion mixture. Combine broth and eggs; add to bread mixture and toss to coat.

Transfer to a 3-qt. slow cooker coated with cooking spray. Cover and cook on low for 3-4 hours or until a thermometer reads 160 degrees.

CRANBERRY MACADAMIA STREUSEL COFFEECAKE

Cake:

- 1 (17-oz.) pouch Cranberry Macadamia Cereal
- 1 (16-oz.) box angel food cake mix
- 1 (15-oz.) can pumpkin
- 1 cup cranberry juice or water
- 1 tablespoon ground cinnamon
- 2 teaspoons ground cloves
- 2 teaspoons ground ginger

Streusel:

- 2 cups crushed cereal
- 1 cup granulated sugar
- 1 cup brown sugar
- 1 cup whole wheat flour

2 teaspoons ground cinnamon

- 2 teaspoons ground cloves
- 2 teaspoons ground ginger
- 6 tablespoons vegetable oil

Preheat oven to 325 degrees. Grease a 13-by-9-inch cake pan.

Poke the seam side of the cereal pouch 10 times with a fork and then crush with a rolling pin using medium pressure. Set aside 2 cups of the crushed cereal for the streusel. Pour remaining cereal into a large bowl.

Add all remaining cake ingredients to the bowl and mix until blended.

Pour the batter into the prepared pan.

To prepare the streusel, combine reserved 2 cups crushed cereal and all remaining ingredients. Mix well and sprinkle over the cake batter.

Bake for 20-25 minutes, or until the cake bounces back to the touch.

PUMPKIN CHEESECAKE Crust:

1¹/₂ cups graham crumbs

- 5 tablespoons butter, melted
- 1 tablespoon sugar

Filling:

- 3 (8 oz.) pkgs. cream cheese, softened
- 1 cup sugar
- 1 teaspoon vanilla
- 1 cup canned pumpkin
- 3 eggs
- 1/2 teaspoon cinnamon
- 1/4 teaspoon nutmeg
- 1/4 teaspoon allspice
- Whipped Cream

Mix crust ingredients together, just till coated and crumbly. Press onto the bottom and ²/₃ up the sides of an 8" springform pan. Bake for 5 mins. at 350. Set aside. Combine cheese, sugar and vanilla in large bowl, mix until smooth with an electric mixer. Add pumpkin eggs,and spices, beat till smooth and creamy. Pour into the crust. Bake for 60–70 mins. or till the top turns a bit darker. Remove from oven and allow to come to room temperature, then refrigerate. After it has thoroughly chilled, remove the pan sides and cut. Serve with whipped cream.

COCONUT MACAROONS


 $1\frac{1}{3}$ cups sweetened shredded coconut $\frac{1}{3}$ cup sugar

- 2 tablespoons all-purpose flour
- ¹/₈ teaspoon salt
- 2 large egg whites, room temperature ½ teaspoon vanilla extract

In a small bowl, combine the coconut, sugar, flour and salt. Add egg whites and vanilla; mix well.

Drop by rounded teaspoonfuls onto greased baking sheets. Bake at 325 degrees for 18-20 minutes or until golden brown. Cool on a wire rack.
