# Third Glorious Mystery: THE DESCENT OF THE HOLY SPIRIT

My dear Sisters and Brothers,

The Third Glorious Mystery of the Rosary is the Descent of the Holy Spirit on Pentecost Sunday, ten days after the Ascension. The spiritual fruit most commonly associated with this third Glorious Mystery is "The Gifts of the Holy Spirit."

As we have meditated these past months on the many mysteries of the Rosary, the Trinity is certainly a mysterious part of our religion as is the Holy Ghost a mysterious Person. The Holy

Spirit is God, the third person of the Trinity and coequal with the Father and the Son. He has always existed and has appeared throughout Scripture. We first see the power of the Holy Spirit in the act of creation: "In the beginning God created the heavens and the earth; the earth was waste and void; darkness covered the abyss, and **the spirit of God** was stirring above the waters" (Genesis 1:1-2). It was by the power of the Holy Spirit that the world came into being.

Before Christ ascended into heavean he had promised his disciples that he would not leave them alone, that he would send the Holy Spirit. After Christ's Ascension the disciples along with Mary, the Mother of Jesus, gathered in the same upper room where the Last Supper took place. There they prayed for nine days, the most solemn novena ever made. As they prayed on the tenth day, a sound came from heaven very much like a mighty wind, and the whole house was filled. It is here that the Church was born as the Holy Spirit descended on each of them in the form of tongues. This miraculous event coincided with the Feast of Weeks, a holy day that was celebrated by the Jews to remember the day the law was given to Moses on Mount Sinai. In the Old Testament the festival was known as Shavuot, which celebrated the end of the grain harvest. "Pentecost" is actually the Greek name for the Feast of Weeks. The Greek word means "fifty" and refers to the fifty days that elapsed since the completion of the seven-week counting period between Passover and Shavuot. As it was, on this day many foreigners had come to Jerusalem to celebrate the Feast of Weeks. Upon hearing the commotion taking place in the upper room they naturally came to investigate. By virtue of "the gift of tongues" granted by the Holy Spirit, despite the fact that many had no common language, they were perfectly able to understand one another. What the disciples preached was understood in the native language of all who witnessed this descent of the Holy Spirit. Filled with the gifts of the Holy Spirit, the disciples were enlightened and strengthened to spread the Gospel and to boldly preach about Our Lord. They were transformed from frightened and confused people to men who would face martyrdom for what they believed. That first day Peter went forth to preach and baptized three thousand!

Pentecost marks the time when the Holy Spirit permanently dwells within us. Throughout the Old Testament, the Holy Spirit would empower people but never permanently dwell within them. Prior to Pentecost, Jesus' disciples followed him, learning what he had to teach them and preparing for the coming kingdom. In a sense, they were a church but they were not yet the Church that Jesus was going to establish. The feast of Pentecost is the birthday of the Church. It was on Pentecost that the Holy Spirit descended upon the disciples and turned them into a unified body which is the Church as we now know it, where the Holy Spirit continues to draw us into the body of Christ.


# FCSLA Life Branch Z211 Hosts Meeting & Social




## **Cleveland District Celebrates Saints Anne and Joachim**




# Fr. Frank Basa Recognized by the Great Trail Council

#### AM Best

President Maleski noted the AM Best interview is scheduled for June 16, 2021, and we have been advised the rating committee will meet to discuss our rating in late August. In preparation, we have formed an AM Best Interview Team and this year we added a key preparation team, and we have established a 2021 work plan, tracking system and shared a calendar with the team indicating deadline dates for submission of materials. This year AM Best sent out a voluntary Environmental, Social and Governance (ESG) survey form. The key point is the ESG framework is becoming more commonplace, and President Maleski stated we will introduce it into our discussions. The questions on the survey focus on the awareness of these ESG factors in the insurance industry and for us to consider the ESG risks and opportunities. The survey also focuses on investing, culture, and underwriting. Questions were asked and answered.

#### **Strategic Planning**

President Maleski mentioned that we completed Phase 1 and had the presentation from Balanced Growth, our outside strategic planner. We are now in Phase II, and a survey form has been sent to each board member and it should be completed and returned by May 23, 2021. Treasurer Collins reviewed the annuity reserves by product. He explained in detail significant statistics on the report. Questions were asked by members of the Executive Committee and answered.

#### First Quarter 2021 Budget vs Actual

Controller Rando reviewed the first quarter 2021 Budget vs Actual report by discussing the life business, annuity business, general expenses, and highlighted variances. Questions and comments were asked and answered.

Controller Rando was excused from the meeting at 10:26 a.m.

#### **Acquired Securities Report**

Treasurer Collins reviewed the \$33.3 million of acquired securities since our last Executive Committee meeting. Treasurer Collins also reviewed the quarterly credit watch list, and the credit events report as of March 31, 2021. Questions were asked and answered.

#### **Annuity Interest Yield**

Elite Silver (5 Year) from 2.75% to 2.65% APY Elite Gold (7 Year) from 3.00% to 2.90% APY

Elite Platinum (10 Year) from 3.25% to 3.15% APY

It was recommended by Treasurer Collins that there be no change to the immediate annuities and no change to the guaranteed minimum rates.

Trustee Strohl moved to accept the Treasurer's recommendation and seconded by Director Golofski.

#### **Business Travel**

# Flavons of Fall!

#### CURRIED BUTTERNUT SQUASH SOUP

- 6 strips bacon chopped
- 1 large onion chopped
- 2 cloves garlic minced
- 1/4 teaspoon curry powder
- 1/4 teaspoon turmeric
- 1/2 teaspoon cardamom
- 1/4 teaspoon cumin
- 1/2 teaspoon coriander
- <sup>1</sup>/<sub>2</sub> teaspoon salt or to taste
- 1/4 teaspoon pepper or to taste
- 4 cups chicken broth low sodium
- 1 lb. large butternut squash about 1 cubed
- 1 large apple pealed, cored and cut into cubes
- 1 cup heavy cream

1 tablespoon fresh oregano chopped Optional

1/2 cup goat cheese crumbled

In a large soup pot add the bacon and fry it until crispy over medium-high. Remove the bacon from the pot and set aside. Leave the bacon fat in the pot.

Add the chopped onion and cook for about 3 minutes until it softens and becomes translucent. Add the garlic and cook for another 30 seconds. Add all the spices: curry, turmeric, cardamom, cumin, coriander, salt, pepper and stir.

Stir in all the chicken broth then add the cubed butternut squash and apple. Turn the heat down to a medium and cook for about 15 to 20 minutes or until the butternut squash is fork tender.

Use an immersion blender to puree the soup on high until creamy and smooth. Alternatively you can transfer the soup to a blender and puree it that way.

Stir in the heavy cream and bring to a boil. Taste for salt and pepper and adjust as necessary.

Garnish with fresh oregano and serve as is or top with goat cheese and bacon.

#### **APPLE SQUARES**

- 3 medium apples peeled, cored and sliced into small chucks
- 1 teaspoon cinnamon
- 4 tablespoon brown sugar, packed
- 1 teaspoon baking powder

- 1¼ cup all-purpose flour
- 1/4 teaspoon salt
- 3/4 cup white sugar
- $\frac{1}{3}$  cup vegetable oil
- ⅓ cup sour cream
- 1 teaspoon vanilla extract
- 2 eggs
- 1/2 cup almonds slivered
- Preheat oven to 350 degrees and line a 9x13 inch pan with parchment paper.
- Toss the chopped apples with the brown sugar and cinnamon in a medium bowl.

In a medium bowl add the flour, salt, and baking powder and combine.

In the bowl of your mixer add the eggs and add the vanilla, sour cream, sugar, vegetable oil and mix everything together until smooth about 2 minutes.

Add the dry ingredients to the mixer bowl and using a paddle attachment, mix until everything is well incorporated. Add the apple mixture to the bowl, and using a spatula, mix everything together.

Pour the batter into the prepared pan, then top with the slivered almonds.

Bake for about 1 hour or until done, when a toothpick is inserted into the center, it should come out clean.

#### MACAROON-TOPPED RHUBARB COBBLER

4 cups sliced fresh or frozen rhubarb (1-inch pieces)

- 1 large apple, peeled and sliced
- 1/2 cup packed brown sugar
- 1/2 teaspoon ground cinnamon, divided
- 1 tablespoon cornstarch
- 2 tablespoons cold water
- 8 macaroons, crumbled
- 1 tablespoon butter, melted
- 2 tablespoons sugar
- Vanilla ice cream, optional

In a large cast-iron or other ovenproof skillet, combine the rhubarb, apple, brown sugar and ¼ teaspoon cinnamon; bring to a boil. Reduce heat; cover and simmer until rhubarb is very tender, 10-13 minutes. Combine cornstarch and water until smooth; gradually add to the fruit mixture. Bring to a boil; cook and stir until thickened, about 2 minutes. In a small bowl, combine the crumbled cookies, butter, sugar and remaining cinnamon. Sprinkle over fruit mixture.

Broil 4 inches from the heat until lightly browned, 3-5 minutes. If desired, serve warm with ice cream.

Note: If using frozen rhubarb, measure rhubarb while still frozen, then thaw completely. Drain in a colander, but do not press liquid out.

#### CARAMEL-PECAN MONKEY BREAD

1 package (1/4 ounce) active dry yeast <sup>1</sup>/<sub>4</sub> cup warm water (110° to 115°) 5 tablespoon plus 1/2 cup butter, divided 1¼ cups warm 2% milk (110° to 115°) 2 large eggs, room temperature 1¼ cups sugar, divided 1 teaspoon salt 5 cups all-purpose flour 1 teaspoon ground cinnamon Caramel: <sup>2</sup>∕₃ cup packed brown sugar 1/4 cup butter, cubed 1/4 cup heavy whipping cream 3/4 cup chopped pecans, divided Optional Glaze: 4 ounces cream cheese, softened 1/4 cup butter, softened 1<sup>1</sup>/<sub>2</sub> cups confectioners' sugar 3 to 5 tablespoons 2% milk

Dissolve yeast in warm water. Melt 5 tablespoons butter. Add milk, eggs and melted butter; stir in ¼ cup sugar, salt and 3 cups flour. Beat on medium speed for 3 minutes. Stir in enough remaining flour to form a firm dough.

Turn onto a floured surface; knead until smooth and elastic, 6-8 minutes. Place in a greased bowl, turning once to grease the top. Refrigerate, covered, overnight.


Punch dough down; shape into 40 balls (about 1¼ in. diameter). Melt remaining butter. In a shallow bowl, combine cinnamon and remaining sugar. Dip balls in butter, then roll in sugar mixture.

For caramel, bring brown sugar, butter and cream to a boil in a small saucepan over medium heat. Cook and stir 3 minutes. Pour half of the caramel into a greased 10-in. fluted tube pan; layer with half the pecans and half the dough balls; repeat. Cover and let rise until doubled, about 45 minutes.

Preheat oven to 350°. Bake until golden brown, 30-40 minutes. (Cover loosely with foil for last 10 minutes if top browns too quickly.) Cool 10 minutes before inverting onto a serving plate.

For optional glaze, beat cream cheese and butter until blended; gradually beat in confectioners' sugar. Add enough milk to reach desired consistency. Drizzle glaze over warm bread.
